- 1995 and prior crop year commodity loans: **3.750** % per annum.
- 1996 and subsequent crop year commodity loans: **4.750** % per annum.
- Local Depositary Earnings: 3.750 % per annum.
- Farm Storage Facility Loans: 4.125 % per annum.
- Sugar Storage Facility Loans: 4.625 % per annum.

Note: The lending rate is the rate at which CCC lends money to the public.

Tobacco Transition Payment Program Discount Rate (December 2007): 10.000 %.

Prompt Pay Interest Rate (July 1, 2007 thru December 31, 2007): 5.750 %.
