- 1995 and prior crop year commodity loans: **3.125** % per annum.
- 1996 and subsequent crop year commodity loans: **4.125** % per annum.
- Local Depositary Earnings: 3.125 % per annum.
- Farm Storage Facility Loans: 3.500 % per annum.
- Sugar Storage Facility Loans: 4.375 % per annum.

Note: The lending rate is the rate at which CCC lends money to the public.

Tobacco Transition Payment Program Discount Rate (February 2008): 8.000 %.

Prompt Pay Interest Rate (January 1, 2008 thru June 30, 2008): 4.750 %.
