The purpose of this modification is to provide funding in the amount of \$12,050,193.49. Clause B.4, Obligation of Funds, paragraph (a) is revised as follows:
 "Pursuant to the clause in Section I, FAR 52.232-22 entitled "Limitation of Funds," total funds in the amount of \$201,649,555.50 are obligated herewith and made available for payment of allowable costs and maximum fee to be incurred from the effective date of this contract through the period estimated to end December 31, 2010."
 Also, by this modification, the clause number for the clause entitled Contractor Use of Government Property, which was added by Modification M010, is corrected from H.34 to H.36.
