Grain Inspection and Weighing Fees and Charges

Effective: September 1, 2008

Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current approved fee schedule.

Regular Hours: 7:00 a.m. to 3:00 p.m. Monday through Friday except holidays.

Regular Hourly Rates:	\$18.00	\$15.00
Overtime Rate (Saturday and Non/Regular)	\$27.00	\$22.50
Sunday and Holiday	\$36.00	\$30.00

All hourly rates will be assessed in quarter-hour intervals. A minimum call out charge of 4 hours will be charged at applicable hourly rate.

Holidays: New Years Eve (at 11:00 a.m.) and New Years Day, Presidents' Day, Good Friday, Memorial Day, 4th of July, Labor Day, Thanksgiving Day, Christmas Eve (at 11:00 a.m.) and Christmas Day. All overtime, Sunday, and Holiday Rates will be assessed in addition to unit fees. Overtime will be assessed for all work performed outside regular hours.

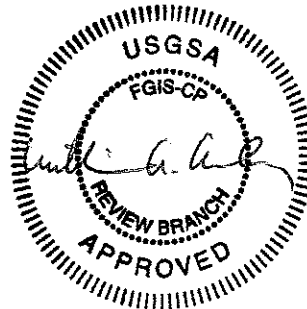
Travel Fees: Travel time outside city limits will be assessed at the applicable hourly rate and prorated where appropriate when more than 1 applicant is serviced in 1 trip.

Standby Time: Standby time will be assessed at the applicable hourly rate.

Services not covered by the above fees will be performed at the applicable hourly rate plus travel, and FGIS supervision fees.

Official Commercial Inspections are available upon request and fees will be negotiated on a case-by-case basis.

Interest applied to past due balance is 18%.
