## OFFICIAL FEE SCHEDULE

**Effective Date:** January 1, 2009. This fee schedule supersedes all other fee schedules by this office. Federal Grain Inspection Service (FGIS) must approve all fees for official services and OA's will assess only those fees appearing on their current approved fee schedule. **FGIS USER FEE INCLUDED.**

**Regular Hours:** 7:00 AM – 3:30 PM, Monday through Friday, excluding Holidays. Time can be adjusted and/or prorated, but it is not to exceed 8 hours per day. **All requests for service will be honored on a first call-first service basis.**

**Regular Hourly Rate:** (4-Hour minimum applies unless stated otherwise)

**Barge, Technician & Cancellation Rate:** \$15.32 per hour.

**Railcar Sampling Rate:** \$12.00 per hour (3-Hour minimum applies) prorated where possible.

**Inspector Rate:** (office) \$17.00 per hour.

**All services during regular hours must be cancelled a minimum of 3 hours prior to start, otherwise the minimum charge will apply. All hours are per person and assessed in ¼ hour increments.**

**Stand-by Rate:** Any stand-by time in excess of one hour will have an additional \$5.00 per hour added to the appropriate hourly rate.

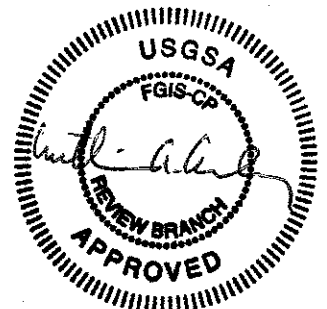
**On-Call:** There will be a 4 hour minimum charge, at the applicable hourly rate, to hold employees for service during non-regular hours.

**Overtime Hourly Rate:** (4-Hour minimum applies to **ALL** sampling) One and one half (1 ½) times applicable hourly rate applies to all hours outside regular hours and Saturday.

**Holiday & Sunday Hourly Rate:** (4-Hour minimum applies to **ALL** sampling) Two times applicable hourly rate applies to all hours worked on a holiday and Sunday.

**ANY cancellations during non-regular hours will have the applicable minimum charge applied.**

**Holidays Include:** New Years Day, Memorial Day, Independence Day, Labor Day, Good Friday, Thanksgiving Day and Christmas Day.



**Mileage Fees:** Mileage will be assessed at a rate of less than or equal to the IRS standard mileage rate and will be prorated when possible.

**Travel Time:** Will be charged at the applicable hourly rate and prorated when possible.

**Sample Pick-up/delivery:** Applicant will be charged appropriate hourly rate and mileage. (Prorated where applicable).

**Mail Charges:** Applicant requests samples to be mailed – actual charges (plus special handling fee)

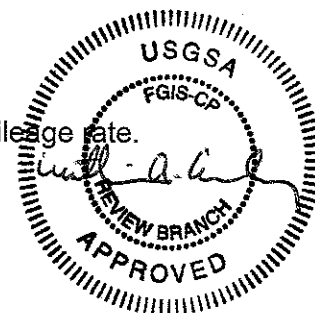
**Contract Services:**
