

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this amendment to the Request for Proposal (RFP) is to provide clarification on the usage of Change Page 86a of Amendment 000002, and to correct a clerical error in the header of the Word version of Change Page 91a.

Change Page 86a of Amendment 000002 changed the options for an Offeror submitting Attachment J-6 (Relevant Experience Form) from a choice of Prime Offeror, Team Member, or Subcontractor to a choice of Prime Offeror, Joint Venture Component, or Subcontractor. If an Offeror has completed an original version of Attachment J-6 and used either Team Member or Subcontractor as a selection and it is a subcontractor (not a prime or component of a JV), no change is necessary because the terms team member and subcontractor are synonymous in the Government's eyes.
