TO: All Interested Parties  
SUBJECT: Paper Reduction Act (Notices to the Trade)

In our further efforts to comply with the government-wide Paper Reduction Act and reduce the cost of postage, the Kansas City Commodity Office (KCCO) will no longer mail Notices to the Trade effective 30 days after release of this notice. All Notices to the Trade will be accessible on our web site at [www.fsa.usda.gov](http://www.fsa.usda.gov).

To obtain all KCCO releases as soon as they are issued, including Notices to the Trade, we recommend you subscribe to our list server. To subscribe, visit our web site at <http://www.fsa.usda.gov/daco/subscribe.asp> and follow the simple instructions. When you subscribe, select one or more of the following categories of releases you wish to receive:

- Daily Terminal Market Prices/Protein Scales - Daily Market Rates and Wheat Premiums and Discount Scales
- Daily Cash Sales - Daily Cash Sales Reports
- Bulk Commodities Information - Notices to the Trade, Invitations, Amendments to Invitations, and Contract Awards
- Export Information - Notices to the Trade, Invitations, Amendments to Invitations, Contract Awards, Port Allocation, Cargo Available for Booking
- Dairy Information - Notices to the Trade, Invitations, Amendments to Invitations, Contract Awards, Purchase and Sales Reports
- Domestic Information - Notices to the Trade, Invitations, Amendments to Invitations, and Contract Awards
- Cotton and Rice Prices - Cotton and Rice Market Prices

- Sugar Information – Notices to the Trade, Invitations, Amendments to Invitations, and Contract Awards
- Warehouse Information - Notices to the Trade, Storage Agreements for Cotton, Grain & Rice (includes Pulses), Peanuts, Sugar, and Processed Commodities, and the U.S. Warehouse Act
