FORMS BY FAX/MAIL SERVICE

The Department of Taxation's Forms By Fax/Mail service is conveniently available to you 24 hours a day, 7 days a week. This service is provided by a private company contracted by the Department of Taxation, and the operators handling the calls are NOT employees of the Department of Taxation.

A list of the forms available for faxing begins on the right. Note: Forms N-1, N-3, N-5, N-11, N-15, N-100, N-101A, N-200V, N-201V, and N-301, Schedule CR, G-45, G-49, HW-3, HW-14, RV-2 (VP-1R), TA-1 (VP-1T), and VP-1 are designed to be optically scanned and data captured. These forms cannot be faxed, but can be mailed to you.

A number of the most commonly requested Hawaii tax forms and instructions can be faxed, usually within 24 hours if not sooner. The instructions for the forms N-11, N-13, N-15, N-20, N-30, N-35, and N-40 cannot be faxed due to their length, but can be mailed to you.

Any Hawaii tax form, instruction, or publication can also be mailed to you.
