VA DATA AND INFORMATION SYSTEMS:

1. FY09 DSS Technical Conversion Guidelines: Information about LOINC Codes for LAR NDE

The Fiscal Year 2009 (FY09) Decision Support System (DSS) Technical Conversion Guidelines are now on the VA DSS VA Intranet Web site (address given in the VA Intranet version of this *Data Issues Brief*). These guidelines include more information about the new Logical Observation Identifiers Names and Codes (LOINC) which are universal identifiers for laboratory and other clinical observations that will now be used to pull DSS Lab Results (LAR) National Data Extract (NDE) records (http://LOINC.org/). These codes will address the specimen source problem documented on the VIReC Web site http://www.virec.research.va.gov/dataSourcesCategory/DataQuality/Lab.htm, as well as provide uniformity for identifying laboratory and clinical observations across different VA facilities.

2. FY09 DSS Technical Conversion Guidelines: 5 NEW Test Results in LAR NDE

The FY09 DSS guidelines document five new test results that will be included in the LAR NDE: Phosphate (Serum), Carcinoembryonic Antigen (CEA) (Serum), Pro B Natriuretic Peptide, Phosphate Pre-Dialysis (Serum), and Phosphate Post-Dialysis (Serum). 3. FY09 DSS Technical Conversion Guidelines: DSS Identifier (Clinic Stop Code) Changes

In FY09, DSS will institute several changes to its list of DSS Identifiers, also referred to as clinic stop codes. These changes include 13 new codes as well as inactivation of 7 identifiers and some credit pair changes (a credit pair is a combination of primary and secondary clinic stop codes). DSS Identifier updates also include enhanced definitions of 68 existing identifiers. Because these changes affect what outpatient workload can be captured with what codes, they are of particular importance for studies needing to identify particular services provided. Note that DSS Identifiers are also used in the National Patient Care Database (NPCD) and are included in the Medical SAS (MedSAS) Outpatient Datasets.
