## General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

### Purpose of Form

Use Form 8916 to reconcile Schedule M-3 taxable income to tax return taxable income for a mixed group, which is a consolidated tax group which includes two or more of the following tax returns: Form 1120, 1120-L, or 1120-PC. A mixed group is a consolidated tax group that (1) includes both a corporation that is an insurance company and a corporation that is not an insurance company, or (2) includes both a life insurance company and a property and casualty insurance company, or (3) includes a life insurance company, a property and casualty insurance company, and a corporation that is not an insurance company.

### Who Must File

Form 8916 must be filed by a mixed group consisting of filers of Form 1120, 1120-L, or 1120-PC that is required to file Schedule M-3.

### How To File

Attach Form 8916 to the parent's Schedule M-3 and attach the supporting workpapers which Form 8916 summarizes.

## Specific Instructions

**Line 2a. Life/non-life loss limitation amount.** Enter any life/non-life loss limitation amount from the supporting workpapers.

**Line 4a. Life/non-life carryforward amount used.** Enter any life/non-life carryforward amount used from the supporting workpapers.

**Line 4b. Net operating loss deduction.** Enter any net operating loss deduction from the supporting workpapers and shown on: Form 1120, page 1, line 29a; Form 1120-L, page 1, line xx; or Form 1120-PC, Schedule A, line xx.

**Line 4c. Dividends received deduction.** Enter any dividends received deduction from the supporting workpapers and shown on: Form 1120, page 1, line 29b; Form 1120-L, page 1, line xx; or Form 1120-PC, Schedule A, line xx.

**Line 7. Other adjustments to reconcile to taxable income on tax return.** Enter on line 7, any other adjustments necessary to reconcile to taxable income reported on the consolidated income tax return from the supporting workpapers and attach a short explanation of the adjustment.
