Office of Investigations and Training 2005 Annual Report Summary of Tables and Charts

Below is a brief description of the tables and graphs found in this report.

- Page 1: Historical summary of abuse allegations and incidents reported to the Office of Investigations and Training (OIT). Allegations of abuse and neglect are reported either to the State or the local county developmental disability and/or mental health program office. The table reflects the trend in abuse reporting over the last 10 years.
- Page 2: Summary of Developmental Disability (DD) abuse allegations and incidents reported to OIT in 2005. The table reflects DD abuse reports by the program in which the client receives DD services and the abuse type reported. County allegations of abuse are investigated by a county DD investigator, however OIT is immediately notified when an allegation is reported to the county and the county investigator submits a final report to OIT at the conclusion of the investigation.
- Page 3: Pie chart of 2005 DD abuse allegations by abuse type. The chart indicates the number of allegations reported and the percentage of all abuse reported in 2005. Neglect represents the most frequently reported abuse type (32%), followed by Physical Abuse (21%) and Financial Abuse (17%). Two common elements in many Neglect investigations are a failure of staff to supervise clients; and incomplete staff understanding of the client's Individual Support Plan.
- Page 4: Summary of DD abuse substantiation rates by abuse type and program in 2005. Of the nearly 1700 allegations of abuse reported in DD programs across the state 48.3% were substantiated.
- Page 5: Summary of DD abuse substantiation rates by abuse type in 2005. The pie chart compares substantiated allegations for all abuse reported for all clients receiving DD services. Allegations of Neglect (43.2%) and Financial Abuse (21.5%) have the highest substantiation rates.

- Page 6: Summary of DD abuse substantiation rates by abuse type in 2005. The graph compares substantiated, not substantiated, inconclusive, and allegations that "did not meet the rule" for all clients receiving DD services. Of the nearly 1700 allegations of abuse reported in DD programs across the state 195 allegations (11.4%) "did not meet the rule".
- Page 7 & 8: Summary by county of DD abuse and neglect allegations. The table reflects investigations conducted by county investigators and includes allegations that "did not meet the rule". Data does not include SOCP, Children's DD program or Eastern Oregon Training Center investigations.
- Page 9: Summary of DD Neglect investigations between 2000 and 2005. The tables reflect Neglect investigations by year and outcome, and show the service element for substantiated findings by year. The service element is the service the client was receiving at the time of the alleged abuse, but is not necessarily where the incident took place.
- Page 10: Summary of DD Physical Abuse investigations between 2000 and 2005. The tables reflect Physical Abuse by year and outcome, and show the service element for substantiated findings by year. The service element is the service the client was receiving at the time of the alleged abuse, but is not necessarily where the incident took place.
- Page 11: Summary of DD Sexual Abuse investigations between 2000 and 2005. The tables reflect Sexual Abuse by year and outcome, and show the service element for substantiated findings by year. The service element is the service the client was receiving at the time of the alleged abuse, but is not necessarily where the incident took place.
- Page 12: Summary of all DD abuse investigations between 2000 and 2005. The tables reflect all abuse by year and outcome, and show the service element for substantiated findings by year. The service element is the service the client was receiving at the time of the alleged abuse, but is not necessarily where the incident took place.
- Page 13: Summary of Mental Health (MH) abuse allegations and incidents reported to OIT in 2005. The table reflects MH reports of abuse by the program in which the client receives MH services and the abuse type reported. County allegations of abuse are investigated by county MH investigators, however OIT is immediately notified when an

allegation is reported to the county and the county investigator submits a final report to OIT at the conclusion of the investigation.

- Page 14: Pie chart of 2005 MH abuse allegations by abuse type. The chart indicates the number of allegations reported and the percentage of all abuse reported in 2005. Neglect represents the single most common form of abuse of MH clients (33%), followed by Physical Abuse (22%) and Verbal Abuse (13%).
- Page 15: Summary of MH abuse substantiation rates by abuse type and client program in 2005. Of the 607 allegations of abuse reported in MH programs across the state 15.2% were substantiated.
- Page 16: Summary of MH abuse substantiation rates by abuse type for all MH clients in 2005. The pie chart compares substantiated allegations for all abuse reported for all clients receiving MH services. Allegations of Sexual Abuse (29.3%) and Financial Abuse (22.8%) have the highest substantiation rates.
- Page 17: Summary of MH abuse substantiation rates by abuse type for all MH clients in 2005. The graph compares substantiated, not substantiated, inconclusive, and allegations that "did not meet the rule" for all clients receiving MH services. Of the 607 allegations of abuse reported in MH programs across the state 175 allegations (28.8%) "did not meet the rule".
- Page 18-19: Summary by county of MH abuse and neglect allegations. These investigations were conducted by county investigators and includes allegations that did not meet the rule.
- Page 20: Oregon State Hospital: Historical summary and recent trends (2003 2005).
- Page 21: Oregon State Hospital: 2005 substantiation rates by abuse type.

The Office of Investigations and Training

The Office of Investigations and Training (OIT) is located within the Oregon Department of Human Services, Director's Office. OIT is responsible for directly investigating or overseeing county investigations of allegations of abuse and neglect of people with mental illness or developmental disabilities who receive services. State and county staff ensure the provision of necessary protective services to victims of abuse or neglect. OIT staff are also responsible for providing training on mandatory abuse reporting requirements, conduct of investigations, and provision of protective services.

OIT's Mission Statement

The Office of Investigations and Training is committed to ensuring all investigations, protective services and trainings are conducted with integrity, fairness, and quality.

Authority

OIT and its designees (community mental health and developmental disability programs) conduct investigations and provide protective services to alleged victims under the authority of Oregon Revised Statutes (ORS) 430.735 to 430.765 and the following Oregon Administrative Rules (OARs): "Abuse Reporting and Protective Services in Community Programs and Community Facilities" (OAR 410-009-0050 through 0160); "24-Hour Residential Services for Children and Adults with Developmental Disabilities" (OAR 411-325-0010 through 0480); "Community Developmental Disability Program" (OAR 411-320-0010 through 0200); "Employment and Alternatives to Employment Services for Individuals with Developmental Disabilities" (OAR 411-345-0010 through 0300); "Adult Foster Homes (OAR 309-040-0300 through 0330); "Adult Foster Homes for Individuals with Developmental Disabilities" (OAR 411-360-0010 through 0310); "Residential Treatment Facilities for Mentally or Emotionally Disturbed Persons" (OAR 309-035-0100 through 0190); "Residential Treatment Homes" (OAR 309-035-0250 through 0460); and "Support Services for Adults with Developmental Disabilities" (OAR 411-340-0010 through 0180).

Definitions and Categories of Abuse

In addition to the statute, there are different OARs that apply depending on the type of service and the person's disability. The following is an abbreviated list of the abuse definitions (full text is available on the Internet at http://www.oregon.gov/DHS/abuse/main.shtml. Click on Developmental Disability or Mental Illness links for Rules and Laws.)

- A) Death: Any death caused by other than accidental or natural means or occurring in unusual circumstances;
- B) Physical Abuse: Any physical injury caused by other than accidental means, or that appears to be at variance with the explanation given. The willful infliction of physical pain or injury, etc;
- C) Sexual Abuse/Exploitation: Any sexual harassment or exploitation including, but not limited to, any sexual contact between a provider or provider employee and a client/patient;
- D) Financial Abuse/Exploitation: Any exploitation or inappropriate expenditure of client/patient funds including, but not limited to, theft, borrowing from or loaning money to clients/patients, commingling resident's funds with caregiver or other resident's funds, etc;
- E) Neglect: Neglect that leads to physical harm or significant mental injury through withholding of services necessary to maintain health and well being;
- F) Restraint: Using physical interventions without a written physician's order, or that is not a part of an Individual Support Plan that results in injury. It is not abuse if absolutely necessary to protect the individual or others from immediate injury;
- G) Restriction: Placing restrictions on a resident's freedom of movement by seclusion in a locked room or restriction to a specific area;

- H) Verbal Abuse/Mistreatment: Subjecting a patient/client to the use of derogatory names, phrases, profanity, ridicule, harassment, coercion or intimidation and threatening injury or withholding of services or supports, including implied or direct threat of termination of services;
- I) Other: A form of abuse that does not clearly fit into one of the other categories of abuse.

Investigation Results

The following investigation outcomes are defined by OAR:

- A) "Substantiated" means that the evidence supports a conclusion that there is reasonable cause to believe that abuse occurred.
- B) "Inconclusive" means that the available evidence does not support a final decision that there was reasonable cause to believe that abuse occurred or did not occur.
- C) "Not Substantiated" means that the evidence does not support a conclusion that there is reasonable cause to believe that abuse occurred.
- D) "Did Not Meet the Abuse Definition": Means allegations that were initially reported to the state or county, but upon preliminary screening it is determined that the allegation does not meet the definition of abuse. Under these conditions, a determination of "Not Substantiated" would not be appropriate because the alleged incident is not addressed by the current abuse\neglect statute or rules. In some of these instances the screening process reveals possible licensing violations, which are reported to the licensing authority for their review.
- E) "Other Outcomes": In addition to the investigation results defined above, there can be other outcomes of an investigation. Other Outcomes fall into two types: 1) Closed without an Outcome: Incidents in which there is not enough information reported and/or preliminary screening does not yield sufficient information to conduct an investigation. 2) Open Investigations: Investigations that have not been closed, commonly due to active investigation by law enforcement, or pending prosecution.

Terminology and Abbreviations (referred to in the following graphs and spreadsheets)

C – Children's 24 Hour Residential Program: Investigations conducted when the alleged victim is under 18 and receiving services from a DD licensed children's residential program and child welfare has referred the case to OIT.

SO – State Operated Community Program (SOCP): Investigations conducted when the alleged victim is receiving services from a state operated 24-hour residential program.

EOTC – Eastern Oregon Training Center (EOTC): Investigations conducted when the alleged victim is receiving services at EOTC.

OSH – Oregon State Hospital (OSH): Investigations conducted when the alleged victim is receiving services from the Oregon State Hospital.

EOPC – Eastern Oregon Psychiatric Center (EOPC): Investigations conducted when the alleged victim is receiving services at EOPC.

FTC – Fairview Training Center: While this facility has been closed and no investigations have been conducted there since 1999, this facility (for people with developmental disabilities) had investigations that are described in the "Comparison of Allegations and Incidents Investigated by or Reported to OIT and Counties" spreadsheet.

SDI – Special Department Investigation: Investigations that are normally undertaken by county staff (MH or DD) but are instead conducted by OIT staff due to possible conflict of interest, complexity, or other identified need.

SDIA – Special Department Investigation Assist: Investigations that are undertaken by county staff (MH or DD) and closely assisted by OIT staff due to complexity, or other identified need.

Special – An investigation conducted by OIT when an individual who receives services is found to have unexplained injuries of concern, and no individual person is accused or identified at the time it is reported.

Review – A review by a forensic specialist of an unexplained injury or patterns of injuries investigated by OIT or county staff.

County DD - Abuse and neglect investigations conducted by a county developmental disability (DD) protective services investigator for individuals who receive developmental disability services.

County MH – Abuse and neglect investigations conducted by a county mental health (MH) program staff for individuals who receive mental health services.

Critical Incident / Miscellaneous Information – A serious incident involving a client or patient, the nature of which did not meet the definition of abuse or neglect (for example, accidental or natural death).

OIT Training Program

The Office of Investigations and Training (OIT) is legally responsible to provide training to protective service investigators (PSI) statewide in how to conduct unbiased, thorough and culturally competent protective service investigations. To encourage reporting and reduce the risk of abuse, OIT also trains mandatory reporters, family members, advocates, clients and community partners. In 2005 OIT staff held a total of 57 training events, encompassing more than 115 training days. More than 3000 individuals attended these trainings.

Training opportunities were provided on the following topics: Basic Investigations; Sorting and Mapping; Interviewing; Advanced Interviewing; Documents, Evidence and Exhibits; Mandatory Abuse Reporting; The Culturally Competent Investigator; Focus on Report Writing; Ethics and Values; Training the Facilitative Trainer (train the trainer); Coaching Skills; The Big Picture: Demystifying the New Rule; A Just Response: Improving Victim Safety and Offender Accountability; Conflict Management; and Disability Awareness; and Strategic Planning and Technical Assistance sessions to community partner agencies and non-profits (to build local abuse response infrastructure including multi-disciplinary teams).

Participants at OIT training programs included protective service investigators from county developmental disability and county mental health programs; staff at Oregon State Hospital, Eastern Oregon Training Center, Eastern Oregon

Psychiatric Center, State Operated Community Program; state protection and advocacy staff, members of law enforcement, judges, and district attorneys; case managers, service coordinators, self-advocates, mental health consumers, family members, agency administrators and senior protective services staff; adult care providers, employment providers, residential providers; domestic violence and sexual assault program staff, community advocates for client populations, members of the Oregon Rehabilitation Association; and the State Attorney General's Sexual Assault Task Force.






2005 DD Abuse Allegations by Abuse Type 1697 Total Allegations





% Allegations to Clients Served (Abuse Reporting Rate):

This represents the percentage of clients receiving DD services who were reported as possible victims of abuse or neglect.

For example, if 150 clients received DD services and 20 allegations of abuse/neglect were reported to the county, the reporting rate is 13.3%.

% Substantiated Allegations to Clients Served (Abuse Rate):

This represent the percentage of clients receiving DD services who were abused or neglected as determined by an abuse investigation.

For example, if 150 clients received DD services and 20 allegations of abuse are reported with 10 allegations being substantiated, the abuse rate is 6.6%.

Physical Abuse Investigations and Allegations by Result




