The Office of Investigations and Training

The Office of Investigations and Training (OIT) is located in The Oregon Department of Human Services, Director's Office. OIT is responsible for directly investigating or overseeing county investigations of allegations of abuse and neglect of people with mental illness or developmental disabilities who receive services. State and county staff ensure the provision of necessary protective services to victims of abuse or neglect. OIT is also responsible for providing training on mandatory abuse reporting requirements, conduct of investigations, and provision of protective services.

These services are significant to Oregonians because individuals with mental illness and developmental disabilities are at the highest risk for abuse and neglect. Research has shown that more than half will experience repeated physical or sexual abuse in their lifetime. Freedom from abuse is critical to benefiting from services. Victims of abuse are offered and provided protective services such as counseling or alternative living arrangements. OIT and county investigations are used to sanction or remove abusive caregivers, and require providers to conduct additional training or revise policies to prevent further abuse.

The Office of Investigations and Training is committed to ensuring all investigations of abuse and neglect, protective services and trainings are conducted with integrity, fairness, and quality thereby maximizing the safety of people with mental illness and developmental disabilities.

OIT Activities and System Improvements

OIT continues to forward investigations to The Oregon Department of Justice, Medicaid Fraud Control Unit (MFCU) for their legal review and action. Of the investigations forwarded in 2007, the MFCU took action in four cases: Two cases involved billing fraud in which the MFCU secured a restitution agreement of over \$72,000 in one case and a 12-month jail sentence in the other. A third case of sexual abuse had stalled at the local law enforcement level. OIT forwarded this information to MFCU, whose investigation led to charges being filed against the individual. The fourth case involved theft of client funds in which the MFCU

secured a conviction, a restitution agreement and jail term for the caregiver. The caregiver is also prohibited from employment with access to elderly or disabled individuals.

In 2007 OIT made 20 referrals to the Oregon State Board of Nursing (OSBN) regarding licensed caregivers who are nurses or Certified Nursing Assistants with substantiated allegations of abuse or neglect. The OSBN took action against five of these caregivers by suspending the licenses of four and reprimanding a fifth.

In 2007, the OIT screener evaluated 847 allegations of abuse and neglect, and assigned 320 of these allegations for investigation in the State Operated Community Program (SOCP), the Children's 24 Hour Residential Program, and patients in the Oregon State Hospital system. The majority of incidents that were screened out were more appropriately patient/client grievances related to staff performance, or were related to other issues that do not rise to the level of abuse. The screening function allows OIT to review all reported incidents thoroughly and in a standardized manner ensure appropriate assignment of cases for investigation.

In 2007 OIT staff began to use civil subpoenas as another investigative resource in the conduct of investigations. Although not often necessary, the ability to obtain phone, bank, employment records and other records can be important in determining whether abuse or neglect occurred.

Authority¹

OIT and its designees (community mental health and developmental disability programs) conduct investigations and provide protective services to victims under the authority of Oregon Revised Statutes (ORS) 430.735 to 430.765 and the following Oregon Administrative Rules (OARs): "Abuse Reporting and Protective Services in Community Programs and Community Facilities" (OAR 407-045-0250 through

0360); "Abuse of Individuals Living in State Hospitals and Residential Training Centers" (OAR 407-045-0400 through 0520); "Community Developmental Disability Program" (OAR 411-320-0010 through 0200); "24-Hour Residential Services for Children and Adults with Developmental Disabilities" (OAR 411-325-0010 through 0480); "Employment and Alternatives to Employment Services for Individuals with Developmental Disabilities" (OAR 411-345-0010 through 0300); "Adult Foster Homes for Individuals with Developmental Disabilities" (OAR 411-360-0010 through 0310); "Comprehensive In-Home Services for Adults with Developmental Disabilities" (OAR 411-330-0010 through 0170); "Support Services for Adults with Developmental Disabilities" (OAR 411-340-0010 through 0180); "Standards for Adult Mental Health" (OAR 309-032-525 through 0605); "Residential Treatment Homes" (OAR 309-035-0250 through 0460); "Residential Treatment Facilities for Mentally or Emotionally Disturbed Persons" (OAR 309-035-0100 through 0190); and "Adult Foster Homes" (OAR 309-040-0300 through 0445);

Definitions and Categories of Abuse

In addition to the above statutes, different OARs apply depending on the type of service and the person's disability. The following is an abbreviated list of the abuse definitions for adults with developmental disabilities or mental illness. The full text is available on the State website at:

- A) Death: Any death caused by other than accidental or natural means or occurring in unusual circumstances;
- B) Physical Abuse: Any physical injury caused by other than accidental means, or that appears to be at variance with the explanation given; the willful infliction of physical pain or injury;
- C) Sexual Abuse/Exploitation: Any sexual harassment or exploitation including, but not limited to, any sexual contact between a provider or provider employee and a client/patient;

- D) Financial Abuse/Exploitation: Any exploitation or inappropriate expenditure of client/patient funds including, but not limited to, theft, borrowing from or loaning money to clients/patients, commingling resident's funds with caregiver or other resident's funds, etc;
- E) Neglect: Neglect/failure to act that leads to physical harm or significant mental injury through withholding of services necessary to maintain health and well being;
- F) Restraint: Using physical interventions without a written physician's order, or that is not a part of an Individual Support Plan that results in injury. It is not abuse if absolutely necessary to protect the individual or others from immediate injury;
- G) Restriction: Placing restrictions on a resident's freedom of movement (for example, by seclusion in a locked room or restriction to a specific area);
- H) Verbal Abuse/Mistreatment: Subjecting a patient/client to the use of derogatory names, phrases, profanity, ridicule, harassment, coercion or intimidation and threatening injury or withholding of services or supports, including implied or direct threat of termination of services;
- I) Other: A form of abuse that does not clearly fit into one of the other categories of abuse.

Investigation Results

The following investigation outcomes are defined by OAR:

A) Substantiated: The evidence supports a conclusion that there is reasonable cause to believe that abuse occurred.

- B) Inconclusive: The available evidence does not support a final decision that there was reasonable cause to believe that abuse occurred or did not occur.
- C) Not Substantiated: The evidence does not support a conclusion that there is reasonable cause to believe that abuse occurred.
- D) Did Not Meet an Abuse Definition: The allegations were initially reported to the state or county, but during the early stages of investigation it was determined that the allegation does not meet the definition of abuse. Under these conditions, a determination of "Not Substantiated" would not be appropriate because the alleged incident is not addressed by the current abuse\neglect statute or rules. In some of these instances the investigation process reveals possible licensing violations, which are reported to the licensing authority for their review.
- E) Other Outcomes: In addition to the investigation results defined above, there can be other outcomes of an investigation. Other Outcomes fall into two types: 1) Closed without an Outcome: Incidents in which there is not enough information reported and/or preliminary screening does not yield sufficient information to conduct an investigation. 2) Open Investigations: Investigations that have not been closed, commonly due to active investigation by law enforcement, or pending prosecution.

Terminology and Abbreviations (referred to in the following graphs and tables)

BMRC – Blue Mountain Recovery Center (formerly Eastern Oregon Psychiatric Center). OIT investigators conduct abuse and neglect investigations involving BMRC patients.

Children (DD) – Children's 24-Hour Residential Program. Residents in the program are under 18 and receive services from a DD licensed children's residential program when placement is made by SPD Home & Community Supports. OIT investigators conduct abuse and neglect investigations involving residents of this program when these are violations of SPD-DD licensing rules.

CDDP – Community developmental disability services and programs. County developmental disability protective services investigators conduct abuse and neglect investigations involving clients receiving community DD services.

CMHP – County or community mental health services. County mental health protective services investigators conduct abuse and neglect investigations involving clients receiving community MH services.

Critical Incident / Miscellaneous Information – A serious incident involving a client or patient, which did not meet the definition of abuse or neglect (for example, accidental or natural death).

DD – Developmental Disability.

EOTC – Eastern Oregon Training Center (EOTC). OIT investigators conduct abuse and neglect investigations involving EOTC clients.

FTC – Fairview Training Center: While this facility has been closed and no investigations have been conducted there since 1999, this facility (for people with developmental disabilities) had investigations that are described in the "Comparison of Allegations and Incidents Investigated by or Reported to OIT and Counties" spreadsheet.

MH - Mental Health

OSH – Oregon State Hospital. OIT investigators conduct abuse and neglect investigations involving OSH patients.

Review – A review by a forensic specialist of an unexplained injury, or patterns of injuries investigated by OIT or county staff.

SDI – Special Department Investigation: Investigations that would normally be undertaken by county MH or DD staff, but are instead conducted by OIT staff due to possible conflict of interest, complexity, or other identified need.

SDIA – Special Department Investigation Assist: Investigations that are undertaken by county MH or DD staff, and closely assisted by OIT staff due to complexity, or other identified need.

SOCP – State Operated Community Program, 24-hour residential program. OIT investigators conduct abuse and neglect investigations involving SOCP residents.

Special – An investigation conducted by OIT when an individual who receives services is found to have unexplained injuries, and no individual person is accused or identified at the time it is reported. In 2006 OIT changed the way these investigations are tracked. They are now included under the service the client received at the time of the allegation.

OIT Training and Prevention Program

The Office of Investigations and Training (OIT) is legally required to provide training to protective service investigators (PSI) statewide in how to conduct unbiased, thorough and culturally competent protective service investigations. To encourage reporting and reduce the risk of abuse, OIT trains mandatory reporters, family members, advocates, clients and community partners, including first responders. In 2007, OIT also assumed training responsibilities for certain licensed professional Children's Care Provider (CCP) programs, which offer therapeutic treatment to children in out-of-home settings.

In 2007 the OIT Training and Prevention Program expanded its focus to incorporate prevention. Training and Prevention Unit staff held a total of 77 training sessions encompassing more than 824 classroom training hours, delivered to more than 2685 individuals.

The following trainings were provided: Basic Investigations; Sorting and Mapping; Interviewing; Advanced Interviewing; Documents, Evidence and Exhibits; Mandatory Abuse Reporting (for the adult mental health and developmental disabilities system as well as for the Children's Care Provider System); The Culturally Competent Investigator; Could This Happen In Your Program? Learning From Stories of Abuse and Neglect; Making Sense of the Abuse Reporting System for Consumers and Family Members; Sexual Abuse of People with Disabilities; Money: The Good, the Bad, and the Ugly (Financial Exploitation); Oregon State Hospital Abuse Reporting System; Advanced Report Writing; Ethics and Values; Conflict Management; and Disability Awareness.

Strategic Planning and Technical Assistance sessions were provided throughout the year to community partner agencies and non-profits (to build local abuse response infrastructures including multi-disciplinary teams) and to Marion and Polk counties to assist in the creation of an interagency 24-hour coordinated community response to bias crimes against people with disabilities. Partnerships with local law enforcement, including the District Attorney's Office, were forged in the implementation and training which accompanies the model.

Additionally, in 2007 OIT produced a two-part DVD mandatory abuse training and abuse prevention film package, The Choices We Make, which includes a participant workbook. This package was distributed to all licensed MH and DD foster home providers in Oregon, all licensed MH and DD Provider organizations, and each county CMHP and CDDP program. OIT also provided technical assistance to the 2007 National Adult Protective Services Association's conference committee, supporting issues relevant to the needs of adult protective services professionals serving people with developmental disabilities and mental illness.

Participants at OIT training programs have included protective service investigators from CMHP and CDDP programs; staff of licensed professional Children's Care Provider (CCP) programs; staff at Oregon State Hospital, Eastern Oregon Training Center, Blue Mountain Recovery Center, and the State Operated Community Program; state protection and advocacy agency staff, members of law enforcement, judges, and district attorneys; case managers, service coordinators, self-advocates, mental health consumers, family members, agency administrators and senior protective services staff; adult care providers,

employment providers, residential providers; domestic violence and sexual assault program staff; community organizations and advocates for client populations; members of the Oregon Rehabilitation Association; and the State Attorney General's Sexual Assault Task Force.

Comparison of Allegations and Incidents Reported to OIT and Counties

The table below reflects the number of allegations of abuse by program over the last 10 years. Allegations of abuse and neglect are reported to the State directly; or to County Developmental Disability Programs and Community Mental Health Programs. The data below reflect "allegations" of abuse rather than cases. A case may involve a single allegation, or many allegations depending on the number of clients, alleged perpetrators and abuse types noted in the report. The increase in County Mental Health for 2007 is due to two cases at one facility with over 100 allegations.

OIT is immediately notified when allegations are reported to CDDP or CMHP programs and a final written report is submitted to OIT upon the completion of the investigation.


2007 Developmental Disability Programs

Abuse Allegations by Type and Program

The table reflects the DD program in which the client received services at the time of the incident. SDI allegations involve clients receiving county DD services, however the allegations are investigated by OIT staff due to conflict of interest, complexity or other reasons. Over 16,000 Oregonians receive a developmental disability service that is covered by abuse rules. 1837 abuse allegations were reported in 2007, of which 18 allegations were related to the deaths of 9 clients. For two of these clients the allegations of neglect were substantiated.



By Abuse Type and Number Reported




The chart represents 2007 abuse allegations of clients receiving services through the CDDP system, Brokerage system, Childrens 24 Hour Residential Program, State Operated Community Program and Eastern Oregon Training Center. Neglect represents the most frequently reported abuse type (40%), followed by financial abuse (26%) and physical abuse (18.7%). Two common elements in many neglect investigations are a failure to supervise clients and incomplete understanding of Individual Support Plan requirements.

2007 Developmental Disability Abuse Allegations

By Abuse Type and Result

The table and chart reflect substantiated allegations by abuse type in 2007. Of the 790 allegations that were substantiated, 45.7% were for neglect and 28.4% were for financial abuse. Neglect and financial abuse typically account for over 70% of all substantiated abuse. Physical abuse, sexual abuse and improper use of restraints make up about 15% of all substantiated abuse. The allegations substantiated in 2007 affected 520 individuals.


2007 Developmental Disability Substantiation Rates

By Program and Abuse Type

The table and chart reflect DD substantiation rates by abuse type and client program in 2007. Neglect (53.2%) and financial abuse (50%) have the highest substantiation rates. Of the 16,031 Oregonians receiving DD services, 520 experienced some form of abuse. The two instances in this table that show a substantiation rate of 100% are situations in which one allegation was reported and substantiated.



The table reflects substantiation rates by abuse type and compares substantiated, not substantiated, inconclusive, and allegations that "did not meet the definition" for all clients receiving DD services. Of the 1837 allegations reported, 790 (43%) were substantiated as abuse or neglect. 790 substantiated allegations affected 520 individuals receiving DD services.

Substantiated Abuse in Group Homes and Adult Foster Homes 2003 - 2007

The table reflects abuse of adult developmental disability clients living in a state licensed group home (GH) or a state operated group home (SOCP), as well as clients living in a licensed Adult Foster Home (AFH). The total residential population has increased by roughly 100 clients per year, and in 2007 consisted of nearly 4400 Oregonians. Of the 4400 residents who received services, 377 experienced abuse (8.6%).

Annually OIT documents an average of 1200 reports and allegations of possible abuse of clients with developmental disabilities living in state licensed residential settings. After initial screening and investigation by either a state or county abuse investigator, about half of these allegations will be substantiated.

As documented on page 4 of this report, approximately half of all substantiated abuse is neglect; and another 25% is financial abuse. The table also includes more serious abuse such as physical abuse, improper use of restraints, and sexual abuse (together about 15% of all substantiated abuse), as well as verbal abuse and unauthorized restrictions.


2007 Mental Health Programs

Abuse Allegations by Type and Program

The table reflects the MH program in which the client received services at the time of the incident. Over 40,000 Oregonians receive a mental health service that is covered by abuse rules and 648 allegations were reported in 2007. An unusually high number of financial abuse allegations were reported, most of which resulted from two investigations at a residential treatment facility. Over 100 allegations affecting 13 residents of the facility were substantiated. The facility was closed and the residents moved to a new location.



By Abuse Type and Number Reported




The chart represents 2007 abuse allegations of clients receiving services through County and Community MH Programs, Oregon State Hospital, and Blue Mountain Recovery Center. Financial abuse (23%) and neglect (22%) are the most frequently reported types of abuse; however, in 2007 financial abuse was unusually high due to the impact of two investigations at one facility in which over 100 allegations were recorded. The number of physical abuse and sexual abuse allegations dropped in 2007 compared to 2006.


2007 Mental Health Substantiation Rates




2007 Mental Health Substantiation Rates


