Protecting Public Health Through Food Safety and Food Defense

Food Defense Webcasts from Puerto Rico

FSIS and the University of Puerto Rico, Mayaguez (UPRM) signed a cooperative agreement this year to promote food safety and public health throughout the Western hemisphere.

UPRM will host a Webcast on December 9, 2005, to address food defense topics and concerns that affect the U.S. meat, poultry, and egg products supply as well as the import industry.

Viewers from across the country can log in to www.uprm.edu and watch a live interactive classroom Web cast of UPRM officials instructing Puerto Rico's FSIS inspectors, small and very small establishment owners, and industry representatives.

The Web cast will take place December 9, from 8 a.m to noon on http://www.uprm.edu/

agricultura/iiaa/. This Web cast is a result of an April 2005 announcement by Secretary Mike Johanns for meat, poultry and egg plants to adopt model food security plans and undergo training on how to strengthen security measures and prevent potential acts of intentional contamination.

The food security plans were created to guide the development and implementation of food security plans for meat, poultry and egg processing facilities, import establishments and identification warehouses.

Tools such as the model food security plans, FSIS' Industry Self-Assessment Checklist for Food Security and FSIS Directive 5420.1 Revision 1, Food Security Verification Procedures, are addressed during the half-

Food Safety Conference Slated for Denver

FSIS, in conjunction with the non-profit public health organization, NSF International, announced a joint sponsorship of a food safety education conference on reaching at-risk audiences. The conference will be held September 27-29, 2006, at the Adam's Mark Hotel in Denver, Colo.

Titled "Reaching At-Risk Audiences and Today's Other Food Safety Challenges," the conference will provide educators, communicators, medical and public health professionals and food industry representatives with information, research and insights into reducing foodborne illness in the general and at-risk populations.

At-risk populations include older

adults, young children, pregnant woman and their unborn children, organ transplant recipients and others with immunocompromised conditions.

In addition to addressing the specific food safety needs of atrisk populations, the conference will also benefit those who work to educate other groups such as healthy adults and young children.

Information at the conference will be provided in plenary sessions, panel discussions, poster presentations and exhibits.
