NEWS RELEASE SUMMARY - September 11, 2008

United States Attorney Karen P. Hewitt announced that a federal grand jury sitting in San Diego yesterday handed up an indictment charging Jorge Alberto Camacho-Oliverria and Jose Luis Torres-Barajas with alien smuggling violations stemming from a vehicle rollover fatality that took place on August 29, 2008.

According to court documents, after failing to yield to a Border Patrol unit on westbound Interstate-8, the vehicle exited at Dunbar Lane near Pine Valley and proceeded northbound at high speeds before losing control and rolling down an embankment. The victim died at the scene from a severed spinal cord after being ejected from the trunk during the accident.

The indictment alleges that defendant Torres-Barajas guided a group of undocumented aliens through the desert from Mexico into the United States near Tecate, California. After Torres-Barajas brought the aliens to an area near Interstate-8, the indictment further alleges that defendant Camacho-Oliverria picked up and loaded the aliens into his car and ultimately crashed the vehicle minutes later.

According to Assistant U.S. Attorney Carlos Arguello, who is prosecuting the case, the defendants were previously arraigned on a criminal complaint that charged them with Bringing in Illegal Aliens Without Presentation. The complaint was superseded by the indictment.

The defendants are next scheduled to in court on September 16, 2008 at 9:30 a.m., before Magistrate Judge Louisa S. Porter.

An indictment itself is not evidence that the defendants committed the crime charged. The defendants are presumed innocent until the Government meets its burden in court of proving guilt beyond a reasonable doubt.
