Flare Launchers

- CLASSIFICATION: NOT A FIREARM
- DISTINCTIVE CHARACTERISTICS: Generally plastic
- SPECIAL NOTE: AOW when possessed with ammunition inserts
- RATE OF TRANSFER TAX: none



Flare Launcher Inserts

- CLASSIFICATION: ANY OTHER WEAPONS, only when possessed with a flare launcher
- DISTINCTIVE CHARACTERISTICS: Generally made of metal
- SPECIAL NOTE: 25 mm 12 GA adapter is lawful unless modified
- RATE OF TRANSFER TAX: \$200 if installed in a flare launcher (making of AOW)





Sionics Type Silencer Kit (complete and unassembled)

- CLASSIFICATION: SILENCER
- DISTINCTIVE CHARACTERISTICS: Two outer cylinders, threaded ported sleeve, eyelets, bushing, baffle, spirals, encapsulator, front end cap.
- SPECIAL NOTE: The internal components or the outer cylinders, are also silencers as defined.
- RATE OF TRANSFER TAX: \$200.00





High Standard H. D. Military, .22cal. Pistol with Silencer

- CLASSIFICATION: SILENCER
- DISTINCTIVE CHARACTERISTICS: Any device for silencing or diminishing the report of any portable weapon.
- RATE OF TRANSFER TAX: \$200.00





Ruger Standard Model .22cal. Pistol with Homemade Silencer

- CLASSIFICATION: SILENCER
- DISTINCTIVE CHARACTERISTICS: Any device for silencing or diminishing the report of any portable weapon.
- RATE OF TRANSFER TAX: \$200.00





All "ANY OTHER WEAPONS" have a mandatory tax of \$200.00 for making. Transfer of an "ANY OTHER WEAPON" is an additional \$5.00.

Smooth-Bore, Shot-Revolver

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: A revolver having a barrel with a smooth bore designed or redesigned to fire shot shells.
- RATE OF TRANSFER TAX: \$5.00





Smooth Bore, Shot-Pistol

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: A pistol having a barrel with a smooth bore designed or redesigned to fire shot shells.
- RATE OF TRANSFER TAX: \$5.00





Tear Gas Pen Guns

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: Capable of chambering and firing fixed ammunition; all calibers. Can be commercially or home made, smooth bore or rifled. Usually called a "Pen Gun."
- RATE OF TRANSFER TAX: \$5.00





Marble Game-Getter Gun

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: A firearm having combination rifle and shotgun barrels, more than 12 inches but less than 18 inches long, originally designed to be fired from the shoulder. Usually has a wire type folding stock attached.
 Removal of the stock from the weapon does not affect its classification as a firearm under the National Firearms Act.
- RATE OF TRANSFER TAX: \$5.00





Wallet Holsters

- CLASSIFICATION: ANY OTHER WEAPON with firearm
- DISTINCTIVE CHARACTERISTICS: Holster has hole to fire weapon
- RATE OF TRANSFER TAX: \$5.00 with firearm; no tax without firearm





H & R Handy Gun

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: Smooth bore shot pistol designed and manufactured in present condition, commonly referred to as a "Handy Gun".
- RATE OF TRANSFER TAX: \$5.00





Model No. 35 Stevens Autoshot

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: Iron frame, smooth bore, shot pistol, half octagon barrel, front shotgun bead sight and rear shotgun groove sight cast into the frame. Firearm was commercially manufactured in its present condition.
- RATE OF TRANSFER TAX: \$5.00





Ithaca Auto-Burglar


- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: A double barreled, breech loading, smooth bore shot pistol marked "auto and burglar gun." Firearm was commercially manufactured in present condition.
- RATE OF TRANSFER TAX: \$5.00





Tear Gas Gun, I2ga.

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: Any tear gas device capable of chambering and firing any self-contained cartridge. Even though the device may destroy itself in firing, it is still a firearm under the National Firearms Act.
- RATE OF TRANSFER TAX: \$5.00





Pen and Tear Gas Guns

- CLASSIFICATION: ANY OTHER WEAPON
- DISTINCTIVE CHARACTERISTICS: Capable of chambering and firing fixed ammunition; all calibers. Can be commercially or home made, smooth bore or rifled. Usually called a "Pen Gun."
- RATE OF TRANSFER TAX: \$5.00







Mortar


- CLASSIFICATION: DESTRUCTIVE DEVICE
- DISTINCTIVE CHARACTERISTICS: Mounted on a bi-pod and base plate, bore diameter larger than .50 caliber.
- RATE OF TRANSFER TAX: \$200.00





U.S. Rocket Launcher (Bazooka)

- CLASSIFICATION: DESTRUCTIVE DEVICE
- DISTINCTIVE CHARACTERISTICS: Designed to fire a selfpropelled rocket.
- RATE OF TRANSFER TAX: \$200.00





Boys .55cal. Anti Tank Rifle

- CLASSIFICATION: DESTRUCTIVE DEVICE
- SPECIAL NOTE: In .50 caliber, this is a Title I rifle, not a destructive device.
- RATE OF TRANSFER TAX: \$200.00





Belt Buckle Holster

- CLASSIFICATION: NONE
- DISTINCTIVE CHARACTERISTICS: Buckle with pistol
- RATE OF TRANSFER TAX: None

*Please note that this refers only to the **buckle** itself*





Street Sweeper

- CLASSIFICATION: DESTRUCTIVE DEVICE
- DISTINCTIVE CHARACTERISTICS: Large revolving cylinder
- SPECIAL NOTE: See ATF ruling 2001-1
- RATE OF TRANSFER TAX: \$200.00
