Active ingredient: Amoxicillin; Clavulanate Potassium

Form/Route: Chewable Tablets/Oral

Recommended studies: 2 studies

Design: Single-dose, two-treatment, two-period crossover *in-vivo*
Strength: 400 mg/57 mg
Subjects: Normal healthy males and females, general population.

Analytes to measure (in appropriate biological fluid): Amoxicillin and clavulanic acid in plasma

Bioequivalence based on (90% CI): Amoxicillin and clavulanic acid

Waiver request of in-vivo testing: 200 mg/28.5 mg, based on acceptable (i) bioequivalence studies on the 400 mg/57 mg strength, and (ii) proportional similarity of the formulations and (iii) acceptable in vitro dissolution testing of all strengths.
