Low commodity prices, rising production costs, uncertain farm policies, and exposure to global competition have sensitized producers to the risks they face in financing, producing, and marketing their products. Many now find themselves vulnerable to these risks. Those who sell to producers and buy from producers are themselves exposed to, or are affected by, those same risks.

This conference will help you understand and cope with the realities of Midsouth agriculture in the early 21st century.

About the Program

On the first day, leading economists and policy officials will examine market prospects for Midsouth commodities, the likely direction of farm policies, the implications of emerging technologies, and prospects for Federal risk management programs. The intended outcome is an expanded understanding of the near-term market, technology and policy environment within which producers will have to make decisions. That environment, and producers' response to it, will set the stage for those who do business with producers and whose risks are intertwined with those of producers.

On the second day, speakers will focus on strategies for dealing with the challenges and risks examined on the previous day. The session will feature a panel of producers, suppliers, and lenders providing their perspectives on what they have heard and on what extension should be doing to be most helpful.

Immediately following the conference, extension educators will meet to discuss strategies for developing follow-up educational programs that build on knowledge from the conference.
