#### EXECUTIVE ORDER

### **Creating the Governor's Task Force on Child Welfare**

Pursuant to the authority vested in the Office of the Governor of the State Of Colorado, I, Bill Owens, Governor of the State Of Colorado, hereby issue this Executive Order creating the Governor's Task Force on Child Welfare.

# 1. <u>Background and Purpose</u>

In early 1999, the Governor ordered the new Executive Director of the Colorado Department of Human Services to investigate problems in children's safety and services, identify critical issues, and propose remedial actions. This was in response to recent deaths of Colorado children whose families were receiving child welfare services as well as issues regarding mental health services for youth within the Division of Youth Corrections. The Governor ordered the review to determine how safety procedures and requirements could be strengthened to reduce the risk of harm to children in the future.

In the subsequent report, *Child Protection System Review and Recommendations*, the Executive Director recommended that the "Governor appoint an independent Task Force to review Colorado's child welfare system. The Task Force would be comprised of recognized outside public and private sector experts on children service issues as well as other interested members of the community. The Task Force would be charged with the responsibility for reviewing the adequacy of the State's present system of care and making recommendations for system improvements at both service delivery and State levels.

### 2. <u>Mission and Scope</u>

The Governor's Task Force on Child Welfare shall review the adequacy of the State's child welfare system, specifically programs, agencies and policies relating to child welfare, child care licensing, youth corrections, and mental health services. The Task Force shall review and make recommendations on both the service delivery and State levels. The Task Force shall submit a report of its findings and recommendations to the Governor by October 31, 1999.

#### 3. Organization

The Task Force shall have the power to accept money and in-kind contributions from private entities only to the extent such donations are necessary to cover its expenses. Any money contributed to the Task Force shall be directed to the Office of the Governor and deposited with the Treasurer of the State of Colorado in an account within the Office of Governor's budget. Members of the Task Force shall serve without compensation. A quorum shall consist of 12 Task Force members, and any final recommendation of the Task Force submitted to the Governor shall be approved by at least 10 voting members of the Task Force.

# 4. <u>Membership</u>

The Governor's Task Force on Child Welfare shall consist of no more than 19 members appointed by the Governor:
