Dear Mr. President:

We are pleased to present you with the Fourth Year Report of the National Church Arson Task Force (NCATF or Task Force).

Since June 1996, the Task Force has successfully fulfilled your mandate to coordinate the efforts of Federal, state and local law enforcement in the battle against arsons and bombings at America's houses of worship. Led by the U.S. Department of Justice and Treasury, the NCATF has organized the national effort to identify and prosecute those who burn or damage our houses of worship, to help rebuild these vital institutions, to help heal community tensions resulting from attacks on places of worship, and to help prevent additional fires and damage.

The number of arsons and attacks on places of worship continues to decrease. We believe that this downward trend is due, in part, to the successful coordination efforts of the NCATF. Between January 1, 1995 and August 15, 2000, the Task Force achieved the following results:

- 945 Investigations. The NCATF opened investigations into 945 arsons, bombings or attempted bombings that occurred at houses of worship.
- 431 Arrests. Federal, state and local law enforcement officials arrested 431 suspects in connection with 342 incidents.
- 36.2% Arrest Rate. The NCATF's 36.2% rate of arrest is over twice the 16% general arrest rate for arsons nationwide.
- 305 Convictions. Federal, state and local prosecutors successfully obtained convictions of 305 defendants in connection with 224 arsons or bombings of houses of worship.

In addition, we are pleased to report further developments in our investigation and prosecution of Jay Scott Ballinger. On July 11, 2000, Ballinger pleaded guilty to setting 26 churches on fire in eight states between 1994 and 1999. Sentencing has not yet been scheduled,

but Federal prosecutors are seeking a sentence of more than 42 years in prison. The Ballinger pleas represent the largest number of fires linked to a single defendant since the Task Force was created.

Despite these successes, of course even one fire or a tack on a house of worship is too many. We will remain vigilant, and we will investigate and, where appropriate, prosecute each and every one of these incidents to the fullest extent of the law.

The investigation and prosecution of attacks on houses of worship remain a permanent priority within the Federal government. We can assure you that the innovative and successful practices of the NCATF are now a regular part of Federal law enforcement efforts. The Task Force has integrated its work into the existing structures of the Justice Department's Civil Rights Division, U.S. Attorneys' offices, Federal Bureau of Investigation (FBI), and Community Relations Service (CRS), and the Treasury Department's Bureau of Alcohol, Tobacco and Firearms (ATF), in close partnership with the Department of Housing and Urban Development (HUD) and the Federal Emergency Management Agency's United States Fire Administration (USFA).

We wish to congratulate the NCATF co-chairs, James E. Johnson (Under Secretary for Enforcement at the Treasury Department) and Bill Lann Lee (Assistant Attorney General for Civil Rights at the Justice Department), for their ongoing leadership as the Task Force has institutionalized its practices and mission. We also wish to commend the dedication and important contributions of special agents from ATF and the FBI; CRS conciliators; HUD and USFA officials; Federal, state and local prosecutors and law enforcement; and the many others who have contributed to this coordinated effort.

The enclosed report details the progress of the NCATF's efforts to date. We would be pleased to brief you in more detail.

FOURTH YEAR REPORT FOR THE PRESIDENT

I. OVERVIEW

Since 1996, the National Church Arson Task Force (NCATF or Task Force) has carried out the President's three-part strategy to combat arson at our nation's houses of worship: (1) identifying and prosecuting the arsonists, (2) helping communities rebuild the burned houses of worship, and (3) offering assistance in preventing more fires. Working in partnership with state and local law enforcement and community and private groups, Federal officials continue to achieve considerable success in carrying out the President's mission and strategy.

The Task Force's increased vigilance, well-publicized arrests and prosecutions, and enhanced prevention strategies have helped continue to drive down the number of fires. However, new fires continue to occur, and we continue aggressively to investigate these fires and prosecute those arrested.

Highlights of this report include:

Prosecutions

- **945 Investigations** – The NCATF has opened investigations into 945 arsons, bombings or attempted bombings that have occurred at houses of worship between January 1, 1995 and August 15, 2000.
- **431 Arrests** – Federal, state and local authorities have arrested 431 suspects in connection with 342 of the 945 incidents.
- **36.2% Arrest Rate** – The 36.2% rate of arrest in NCATF arson cases is more than double the 16% rate of arson arrests nationwide.
- **305 Convictions** – Between January 1, 1995 and August 15, 2000, Federal and state prosecutors successfully obtained convictions of 305 defendants in connection with 224 incidents. Most of the incidents involved arsons at houses of worship, but some involved the use of firearms, bombs or violent threats.

- Jay Scott Ballinger, the individual who set the largest number of church fires since the NCATF was created (26 churches in eight states from 1994-1999), pleaded guilty.

Rebuilding

- The Department of Housing and Urban Development (HUD) administers the \$10 million Federal Loan Guarantee Fund, which was established by Congress as part of the 1996 Church Arson Prevention Act to assist the rebuilding effort. Approximately \$6.2 million in loan guarantee commitments was provided as of August 15, 2000.
- HUD continues to work in partnership with the National Council of Churches and the Congress of National Black Churches to provide assistance to congregations in their rebuilding efforts.

Reconciliation

- The Justice Department's Community Relations Service (CRS) plays a critical role in the work of the Task Force, providing conflict prevention and resolution assistance to local officials, law enforcement authorities, clergy and other leaders in affected communities around the country. Through these services, CRS promotes multiracial cooperation in the construction of houses of worship and provides technical assistance in ways that bring together law enforcement agencies and communities of color.

Prevention

- The National Arson Prevention Clearinghouse, housed within the Federal Emergency Management Agency's United States Fire Administration (USFA), provides public education materials and coordinates technical assistance requests from communities. Accessible by a toll-free number (1-888-603-3100), the Clearinghouse has reached over three million individuals, organizations and communities with arson awareness and prevention materials since its inception in 1996.
- The USFA's National Arson Prevention Initiative continues to create coalitions and provide communities with the tools and technical assistance necessary to battle arson. The Initiative issued \$125,000 in arson prevention grants to eight cities in Fiscal Year 1999 and \$150,000 to nine cities in Fiscal Year 2000.

II. HISTORY

In 1996, our nation witnessed a troubling trend. There was an increase in the rate of arsons reported at houses of worship, particularly African American churches in the South. This development was tragic not only because of the intrinsic heinousness of such crimes, but also because of the historical implications.

Throughout much of our nation's history, the church has been the primary communal institution within the African American community. In the nineteenth century, before the abolition of slavery, the church was the only community institution that was permitted for African Americans in many areas. In some instances, the church served not only as a place of worship but also offered educational, legal, banking, housing, and employment services. In the twentieth century, and especially during the civil rights movement, the African American church was the focal point of political oratory and activism.

As Ozell Sutton, the CRS Southeast Regional Director in Atlanta and chair of the CRS Church Burning Response Team, testified to Congress in 1996:

The attack on African American churches is more than just an act of terrorism against a place of worship. A black church to the African American community is far more than a place of worship. It is an attack on the very soul of the African American community. It is the source of their sense of humanity, their sense of self-worth, their fight for dignity and equality, their leader and trainer in the struggle for freedom and justice.

Because of its prominence in the African American community, the church has historically been a target of arson and destruction by bigots and white supremacists. The 1963 bombing of the Sixteenth Street Baptist Church in Birmingham, Alabama, in which four young African American girls lost their lives, may be the most infamous example, but there were countless other churches burned, bombed or destroyed throughout U.S. history. These atrocious crimes were often committed to send a message of intimidation and intolerance.

For years, many arsons at houses of worship were handled by local authorities and not reported to any Federal agency. As a result, local law enforcement often did not benefit from the resources of the Federal government in pursuing these incidents. As a result of the formation of the NCATF in June 1996, however, local authorities began to report such incidents on a regular basis. Federal law enforcement responded swiftly and with the full force of its authority.

The NCATF has made the investigation of arsons at our nation's houses of worship, and the swift prosecution of the arsonists, top priorities of Federal law enforcement. The NCATF's best practices and lessons learned, set forth in the Second Year Report for the President (October 1998), remain a model for similar interagency responses.

III. INSTITUTIONALIZATION

As reported previously, the NCATF has taken a number of steps to ensure that the investigation and prosecution of attacks on houses of worship remain a permanent priority within the Federal government, and that the innovative and highly successful practices of the NCATF Operations Team are a regular part of the Federal law enforcement response. The NCATF Operations Team established protocols and guidelines for the joint investigation and prosecution of suspected arsonists. These protocols and best practices remain in force as the Task Force has

integrated its work into the existing structures of the Civil Rights Division, the Justice Department component that has jurisdiction over these and other Federal criminal civil rights cases; the U.S. Attorneys' offices; the Bureau of Alcohol, Tobacco and Firearms (ATF); and the Federal Bureau of Investigation (FBI).

The NCATF's protocols and best practices include the use of an array of law enforcement tools, such as ATF and FBI databases and computer systems that are used to track and analyze evidence and to generate investigative leads. A nationwide investigative lead database maintained by ATF helps identify, sort and track information from selected church arsons.

In June 1996, after creation of the Task Force, Attorney General Reno directed all of the U.S. Attorneys to establish or expand local task forces focusing on arsons at houses of worship in their districts. These local task forces brought together state and local law enforcement, fire prevention officials, FBI and ATF special agents, CRS mediators and victim/witness coordinators.

In addition to executive branch actions, Congress took steps that have helped to ensure a strong and lasting response to church arsons. By strengthening Federal laws, Congress lent enormous support to the efforts of the NCATF. At the time of the formation of the Task Force, Federal prosecutors often relied on general anti-arson statutes to prosecute those who used fire to destroy property involved in interstate commerce. Under criminal civil rights statutes, they also had the authority to prosecute those who conspired to deprive persons of their civil rights or desecrated religious property or a house of worship. In July 1996, Congress passed and President Clinton signed the Church Arson Prevention Act of 1996, which granted Federal prosecutors greater power in pursuing those who burn and desecrate houses of worship.

IV. PROSECUTIONS

A. Investigations

By August 15, 2000, the NCATF had opened investigations into 945 arsons, bombings or attempted bombings that occurred at houses of worship after January 1, 1995. (See Appendix 1, Charts A, Q, R, and S reflecting the number of church arsons, bombings and attempted bombings nationwide; see Charts T, U, and V reflecting the number of church arsons, bombings and attempted bombings in the South.) In addition to those investigations, Federal and state law enforcement and fire officials have responded to 465 fires that were determined to be caused accidentally.

Of the 945 incidents that the NCATF investigated, 310 have involved African American churches, 213 of which are located in the southern United States. (See Appendix 1, Chart A reflecting total house of worship arsons and bombings; see Appendix 1, Charts G-P for a list of church fire investigations throughout the United States.)

B. Arrests and Convictions

Partnership among law enforcement agencies has produced a significant number of state and Federal arrests. Between January 1, 1995, and August 15, 2000, Federal, state and local authorities arrested 431 defendants in connection with 342 of the 945 incidents that the Task Force has investigated. The 36.2% arrest rate is more than double the general arrest rate for arsons, which is approximately 16%. (See Appendix 1, Chart B.)

Of the 431 persons arrested, 350 are Caucasian, 65 are African American, 13 are Hispanic, and three are Asian. Juvenile arrests numbered 169. Of the 136 suspects arrested for arsons at African American churches, 85 are Caucasian, 50 are African American, and one is Hispanic. Of the 290 suspects arrested for arsons at non-African American houses of worship, 260 are Caucasian, 15 are African American, 12 are Hispanic, and three are Asian. Five Caucasian suspects were arrested for arsons at both African American and non-African American churches. (See Appendix 1, Charts C-F and W-Y.) As of August 15, 2000, there were 584 open investigations in which arrests have not yet been made. Since January 1, 1995, there have been 19 investigations solved with no arrests. (Investigations may be considered solved without arrest when, for example, the child is too young to prosecute or the church refuses to press charges.)

Between January 1, 1995 and August 15, 2000, Federal, state and local prosecutors successfully obtained convictions of 305 defendants in connection with 224 arsons or bombings of houses of worship. (See Appendix 1, Chart Z; see also Appendix 2 for a list of incidents in which a conviction has been obtained between October 5, 1999 and August 15, 2000.) Of the 79 defendants who have been convicted of Federal charges, 46 were convicted of crimes arising from 46 arsons or bombings motivated by bias. Thirty-seven of those defendants were convicted of hate crime charges, and the remaining nine were convicted of, or were allowed to plead guilty to, other Federal charges. (See Appendix 3 for a list of Federal hate crime convictions involving houses of worship.)

In our Third Year Report, the Task Force reported on a major church arson investigation and prosecution — the case of Jay Scott Ballinger — which serves as an important example of the benefits that flow from cooperation by law enforcement at all levels. We can now report that on July 11, 2000, Ballinger pleaded guilty to setting 26 churches on fire in eight states between 1994 and 1999. Sentencing has not yet been scheduled, but the Justice Department has recommended that Ballinger be sentenced to more than 42 years in prison. The Ballinger pleas represent the largest number of fires linked to a single defendant since the Task Force was created.

The Ballinger prosecution is an excellent example of the impact of the NCATF's collaborative efforts. It resulted from a nationwide investigation conducted by the FBI, ATF, investigators from the Indiana State Fire Marshal's Office, numerous state and local fire investigators around the country, and the NCATF. In the words of Timothy M. Morrison, the U.S. Attorney in Indianapolis: "The dots were connected in this case due to timely

communication between state and Federal agencies. And the picture came into focus thanks to the cooperation of law enforcement agencies at all levels across the country.”

V. REBUILDING

A. Loan Guarantee Program

In addition to the important prosecutorial tools it provided, the Church Arson Prevention Act of 1996 authorized the establishment of a Loan Guarantee Recovery Fund for use by HUD to assist in rebuilding places of worship damaged or destroyed by arson. With this \$10 million funding mechanism, HUD can guarantee specific loans made by financial institutions to nonprofit organizations, including houses of worship, to aid in rebuilding property damaged or destroyed by an act or acts of arson or terrorism.

In addition to administering the Loan Guarantee Recovery Fund, HUD continues to work in partnership with the National Council of Churches (NCC) and the Congress of National Black Churches (CNBC), which also provide assistance to congregations in their rebuilding efforts. HUD created this public-private partnership under the National Rebuilding Initiative, which has been maintained by the partnership to aid in the rebuilding of houses of worship. While the partners provide grants for rebuilding, HUD provides loan guarantees.

To date, the partnership has provided approximately \$15.2 million in direct assistance for the rebuilding of burned houses of worship. Of this amount, approximately \$8.6 million was in the form of grants awarded by the NCC and the CNBC. Additionally, approximately \$6.2 million was provided as private loans guaranteed by HUD. This combined assistance of grants and guaranteed loans has resulted in assistance to burned places of worship in approximately 30 states. States in the South have received most of the financial support and related resources.

Grants and guaranteed loan funds have been used to finance a wide variety of rebuilding activities including acquisition of real property, construction materials, furnishings, plans and specifications, site improvements, and the installation of security systems. Also, much has been provided in the form of in-kind contributions to the rebuilding effort, such as volunteer labor and project management, architectural and legal assistance, donated lumber, construction modules, pews, altar furnishings, bibles, hymnals, and choir robes. Such contributions have been made by congregations around the country, private companies, nonprofit organizations and individuals.

In addition to financial assistance, in-kind contributions and volunteer coordination, the rebuilding effort has aided places of worship through the provision of technical assistance. The NCC conducted site assessments and visits, and provided each congregation with the information, resources and networking that addressed its individual situation. The CNBC also performed assessments, assisted with construction planning, made insurance and fire prevention information available, established a special arson prevention program and made on-site visits.

HUD provided detailed information on the loan guarantee program, and continued to identify financial institutions interested in providing rebuilding loans for guarantee by HUD.

Who May Apply: The HUD loan guarantee process accepts applications from nonprofit organizations, including houses of worship, that are described in Section 501(c)(3) of the Internal Revenue Code of 1986. Though the organization may not have sought or obtained a ruling from the IRS under this section, its purpose must be consistent with that of organizations described therein. To qualify, a Federal, state or local fire official must certify the fire at the place of worship to be arson. For purposes of the guarantee process, the financial institution that serves as a lender may be a bank, trust company, savings and loan association, credit union, mortgage company or other issuer regulated by the Federal Deposit Insurance Corporation, Office of Thrift Supervision, National Credit Union Administration or U.S. Comptroller of the Currency. The financial institution may also be a pension fund.

Application Process: A place of worship initiates the loan-making process by submitting a HUD application to a local bank or other financial institution requesting a rebuilding loan. The financial institution reviews the application, seeks additional financial data if necessary, conducts its underwriting analysis (using its own underwriting standards), and makes a submission to HUD requesting a loan guarantee. HUD is authorized to guarantee up to 100% of the loan amount.

HUD will participate in the rebuilding process through new construction, rehabilitation of real property, refinancing of existing debt, restoration or acquisition of personal property, and related costs. Assistance may be given if the insurance proceeds for the property are not sufficient to complete rebuilding or to reimburse the related loss/damage.

As of August 15, 2000, approximately \$6.2 million in loan guarantee commitments was provided to 11 different churches: Emmanuel Church (Decatur, AL), Second New Light OFW Baptist Church (Bridgeport, CT), New Birth Temple Church of God In Christ (COGIC) (Shreveport, LA), Greater Mount Zion Tabernacle (Portsmouth, VA), New Harvest Baptist (Cornwall, NY), Bethel AME Church (Monroeville, PA), Southtowns Christian Center (Lakeview, NY), Avenue M COGIC (Birmingham, AL), Springhill Missionary Baptist Church (Memphis, TN), Greater Holy Temple COGIC (Wichita, KS), and Solid Rock Missionary Baptist Church (Miami, FL). Currently, approximately \$3.8 million in guarantee authority remains to be committed.

B. Future Actions

HUD is working to expand its role of managing the loan guarantee program. One of the objectives of this expansion is the provision of technical assistance designed to assist congregations of burned churches in accessing conventional financing and/or grants to support rebuilding efforts. In many of the burned churches, congregations are small and lack the capacity and adequate resources for rebuilding. These churches often serve as the focal point in the

community for social activities and for responding to the human needs of their members. Many of these churches do not have the financial capability to access conventional financing. In many cases, the church's budget is inadequate to service debt. Technical assistance in the area of financial management and training in the HUD loan guarantee process are critical to helping congregations restore, replace or repair houses of worship burned due to arson.

HUD, in partnership with the National Rebuilding Initiative, has identified a number of grant-making foundations that have expressed interest in supporting the church rebuilding program. Seventeen senior-level officials of some of the nation's largest financial institutions (banks, mortgage banks and credit unions) have agreed to become part of a participating lenders group for those places of worship that have the resources to carry debt financing and may need assistance in the rebuilding process.

As noted above, of the initial allocation of \$10 million authorized by Congress for the Loan Guarantee Recovery Fund, there is a balance of \$3.8 million. A pending request for \$4 million will exhaust this balance. To continue the purpose of this program and to respond to the needs that exist, HUD will request authorization for additional funding. Technical assistance and training will increase requests for participation in the loan guarantee program. HUD understands the importance of a special public-private partnership in responding to the church reconstruction process and will continue active outreach to identify potential new partners that can support and enhance the delivery of the program.

VI. RECONCILIATION

This Administration has been committed to bridging the racial divide. President Clinton has spoken powerfully to this goal by creating the White House Office of One America and by continuing his strong support for civil rights. The Community Relations Service has been a key player in this broader effort and in combating church arsons in particular.

CRS continues to provide conflict prevention and resolution assistance to local officials, law enforcement authorities, clergy and other leaders in affected communities across the country. CRS regional conciliators and conflict resolution contractors have assumed responsibility for the work of the CRS Church Burning Response Team. Their close work with U.S. Attorneys, community leaders, and Federal, state and local law enforcement has facilitated the coordinated effort necessary for community healing and reconciliation to occur.

CRS remains committed to dispatching conflict resolution and reconciliation experts from its regional offices to work directly with local communities to promote multiracial cooperation in the construction of houses of worship, and to provide technical assistance in ways that bring together law enforcement agencies and minority neighborhoods.

VII. PREVENTION

A. Community-Based Arson Prevention Grants

The National Arson Prevention Initiative (NAPI or Initiative), led by the Federal Emergency Management Agency's United States Fire Administration (USFA), completed its fourth and final year of providing grants to communities to create arson prevention coalitions. The grants are used to provide cities with the tools and technical assistance to battle arson. In Fiscal Year 1997, the first year of the Initiative, four communities received grants. Fourteen communities received grants in Fiscal Year 1998, eight in Fiscal Year 1999 and nine in Fiscal Year 2000. This year's jurisdictions received a total of \$150,000. In total, 35 communities over the last four years received NAPI grants, and in 2001, a best practices study will be made of those communities.

This year's recipients of \$16,325 grants were Ann Arbor, Michigan; Harrisburg, Pennsylvania; Beatrice, Nebraska; Marshalltown, Iowa; Bridgeport, Connecticut; Worcester, Massachusetts; Cadiz, Kentucky; Taylors, South Carolina; and Page, Arizona.

B. National Arson Prevention Clearinghouse

The USFA's National Arson Prevention Clearinghouse was established to provide public education materials and coordinate technical assistance requests from communities. Accessible by a toll-free number (1-888-603-3100) and highlighted on the USFA web site (www.usfa.fema.gov/napi), the Clearinghouse has reached over a million individuals, organizations and communities with arson awareness and prevention materials for the fourth consecutive year. A new brochure entitled "Children and Fire: A Growing Concern" was developed and has been distributed since May 2000. A new Juvenile Firesetting Community Awareness Program (including a video) has been produced and will be available from the Clearinghouse in December 2000. The Clearinghouse has maintained its efforts working through the NCC, the CNBC and others in the faith community. Thousands of houses of worship have been reached with arson prevention pamphlets and brochures. Materials distributed through the Clearinghouse include church and other structure threat assessment and fire safety documents, juvenile firesetter intervention brochures, public education materials such as bumper stickers, and community organizing and coalition building guidance.

C. Juvenile Firesetter Prevention

Data indicate that juveniles are disproportionately responsible for burning or damaging houses of worship. Since 1995, children under the age of 18 were arrested in connection with nearly 40% of all church arsons and bombings nationwide. The focus of the Initiative this year was to concentrate on juvenile arson prevention at places of worship and in the public arena. This was accomplished by working with childcare providers at places of worship and daycare centers. This effort complements the USFA prevention mission. In concert with the awareness

and prevention programs, the Initiative was instrumental in the development and implementation of a new juvenile firesetting intervention curriculum. The curriculum consists of three courses: a one-day course on management needs for the implementation of the juvenile firesetter intervention specialist at the National Fire Academy; a two-day course to outline juvenile firesetter intervention specialist skills and identify outside agencies to implement an intervention program; and a five-day course that provides the skills necessary to be a juvenile firesetter intervention specialist.

D. Public Education

Each year during the first week of May, the USFA and NAPI sponsor National Arson Awareness Week. The Initiative works in cooperation with other organizations, including the International Association of Arson Investigators (IAAI). "Target Arson," the national public education campaign that is the theme of Arson Awareness Week, encourages communities to become involved in the solutions to their arson problems. Along with NAPI grant communities, chapters of the IAAI host events and activities in virtually every state. The three major goals of National Arson Awareness Week are: (1) to create a national umbrella of recognition, awareness and understanding of the arson problem in the United States (2) to highlight accomplishments and successes of the NAPI grants; and (3) to promote the dissemination of arson awareness, prevention and investigation literature and training materials via the National Arson Prevention Clearinghouse.

E. Technical Assistance and Training

In addition to the juvenile firesetter intervention curriculum and community awareness program, the Initiative partnered with the National Volunteer Fire Council and the IAAI to sponsor two "Arson Mitigation for the First Responder" seminars. The training took place at the National Emergency Training Center in April and July 2000. The course addressed the challenges facing the volunteer fire service in arson detection and prevention. The training addressed recognition of red flags of an incendiary fire, as well as the creation of prevention programs in rural communities.

F. Threat Assessment Guide

The Task Force has produced a comprehensive guide for arson prevention, entitled "Threat Assessment Guide for Houses of Worship." (See Appendix 4.) This guide is designed to share helpful practices for members of the faith community in determining their vulnerability to fire and bombing incidents. The guide provides useful checklists and contact information.


VIII. CONCLUSION



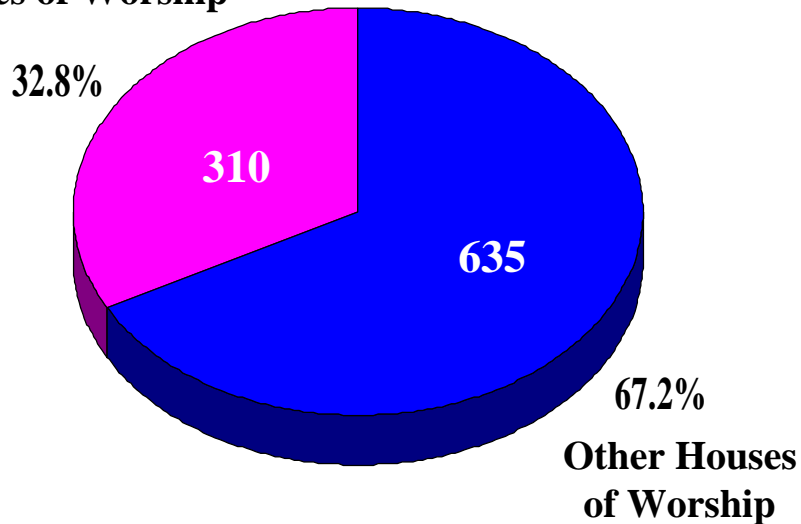

January 1, 1995 - August 15, 2000**

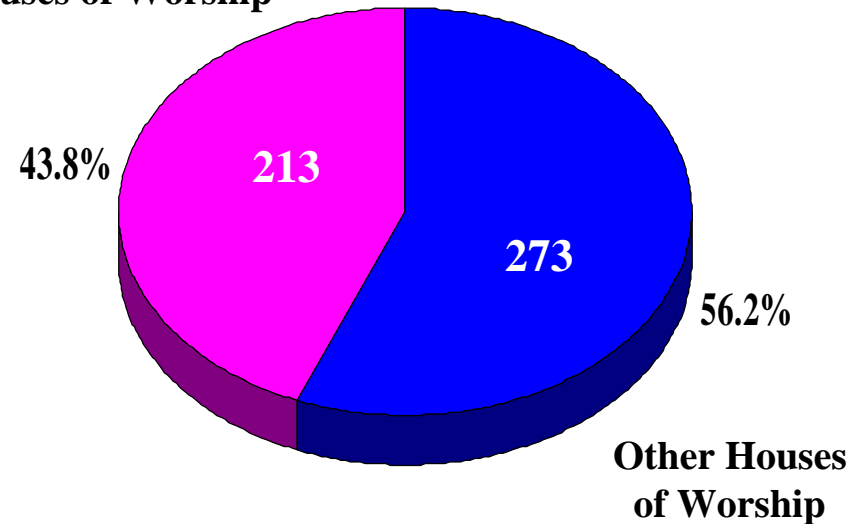

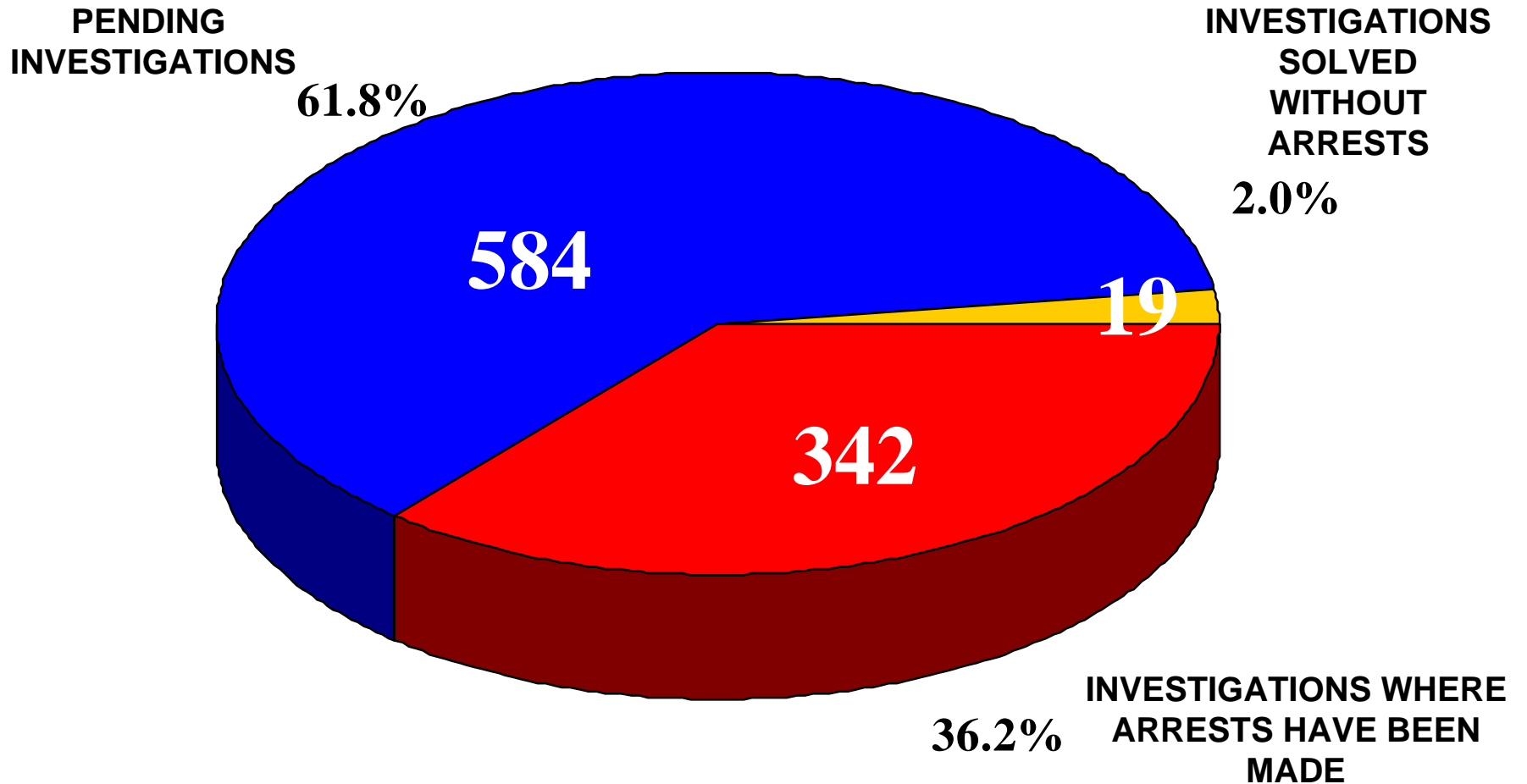

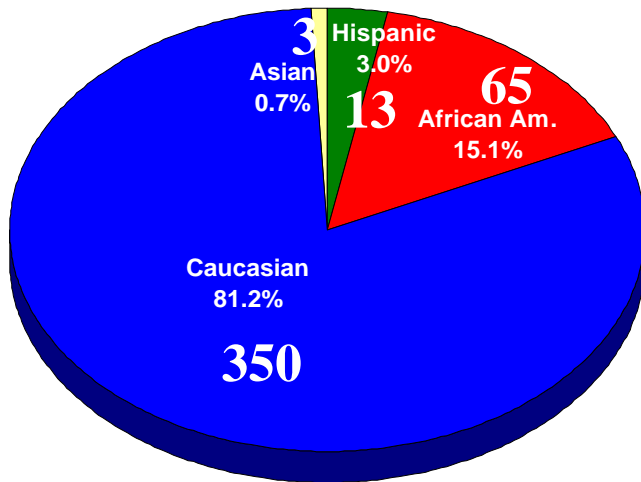
Racial Makeup of Subjects Arrested for Church Arsons/Bombings

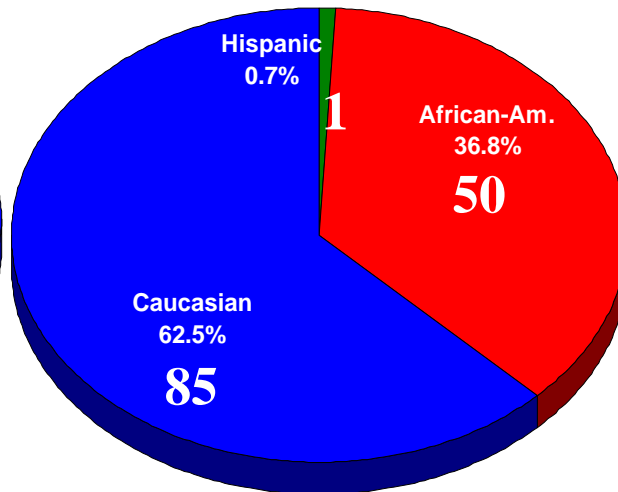

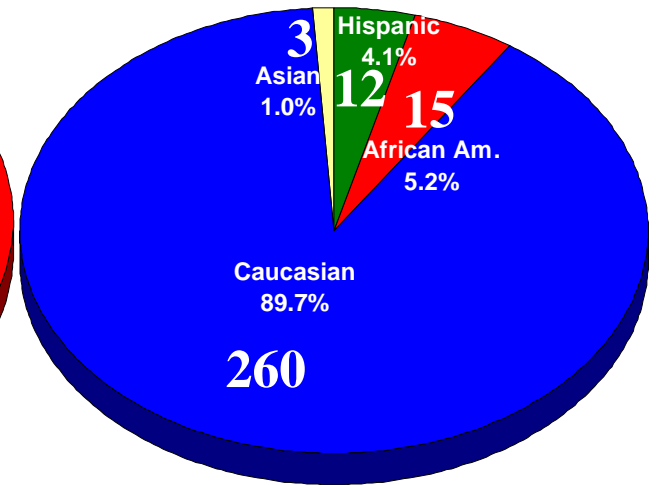

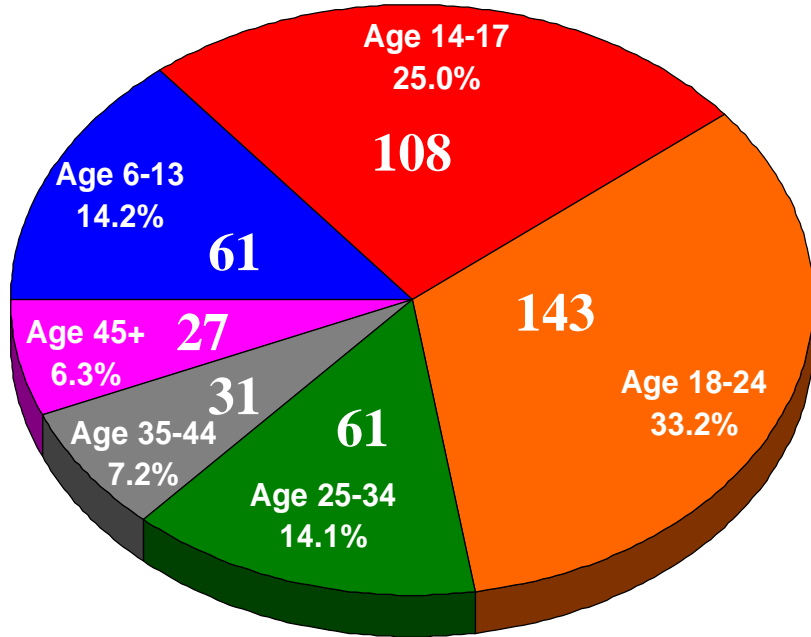

NATIONAL CHURCH ARSON TASK FORCE

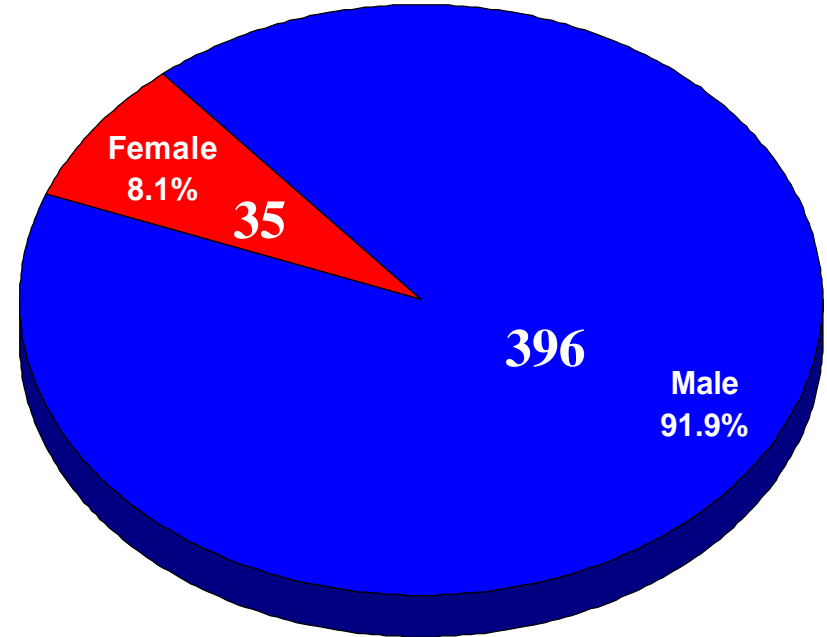
Demographic Information on Subjects Arrested for Church Arsons/Bombings Nationwide

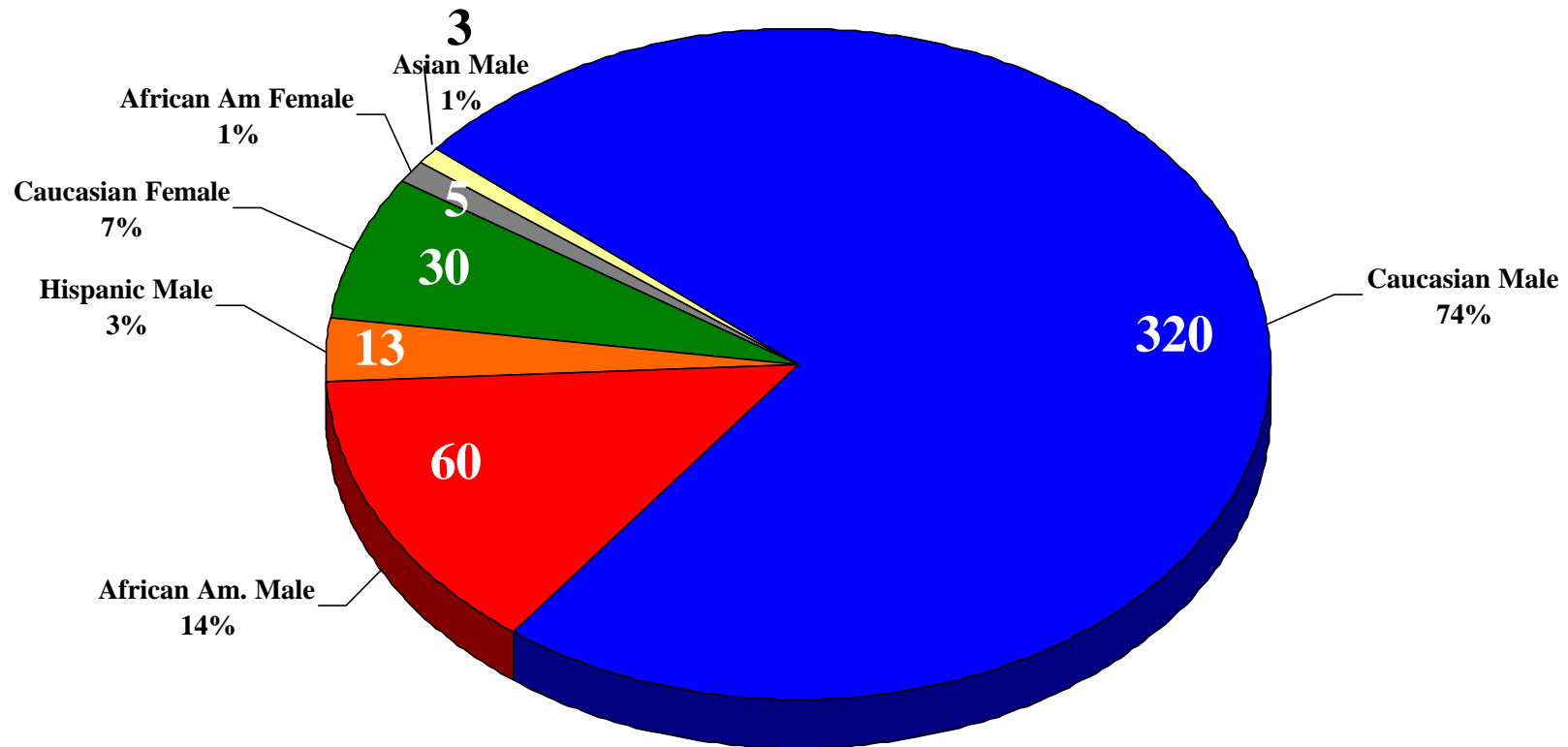

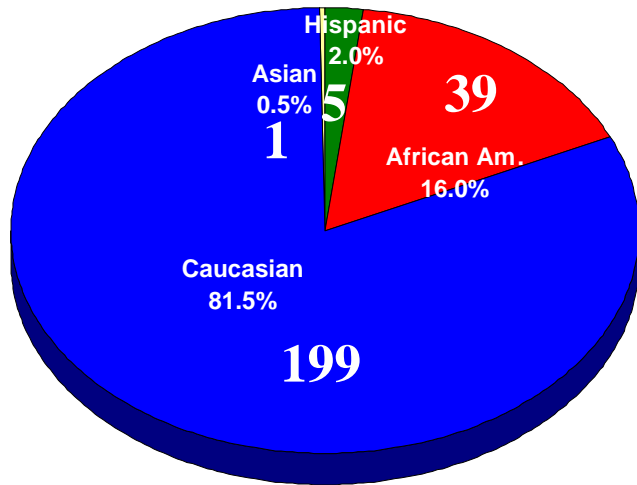
Racial Makeup of Subjects Arrested for Church Arsons/Bombings

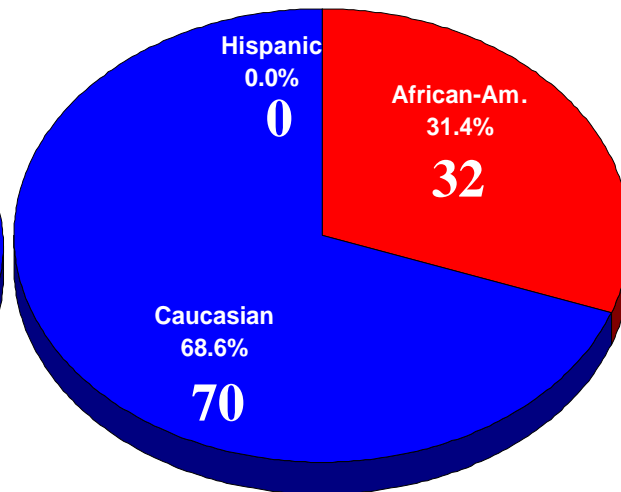

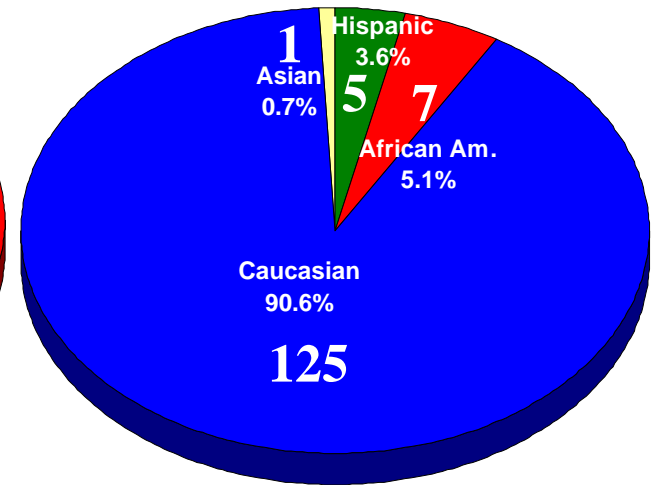

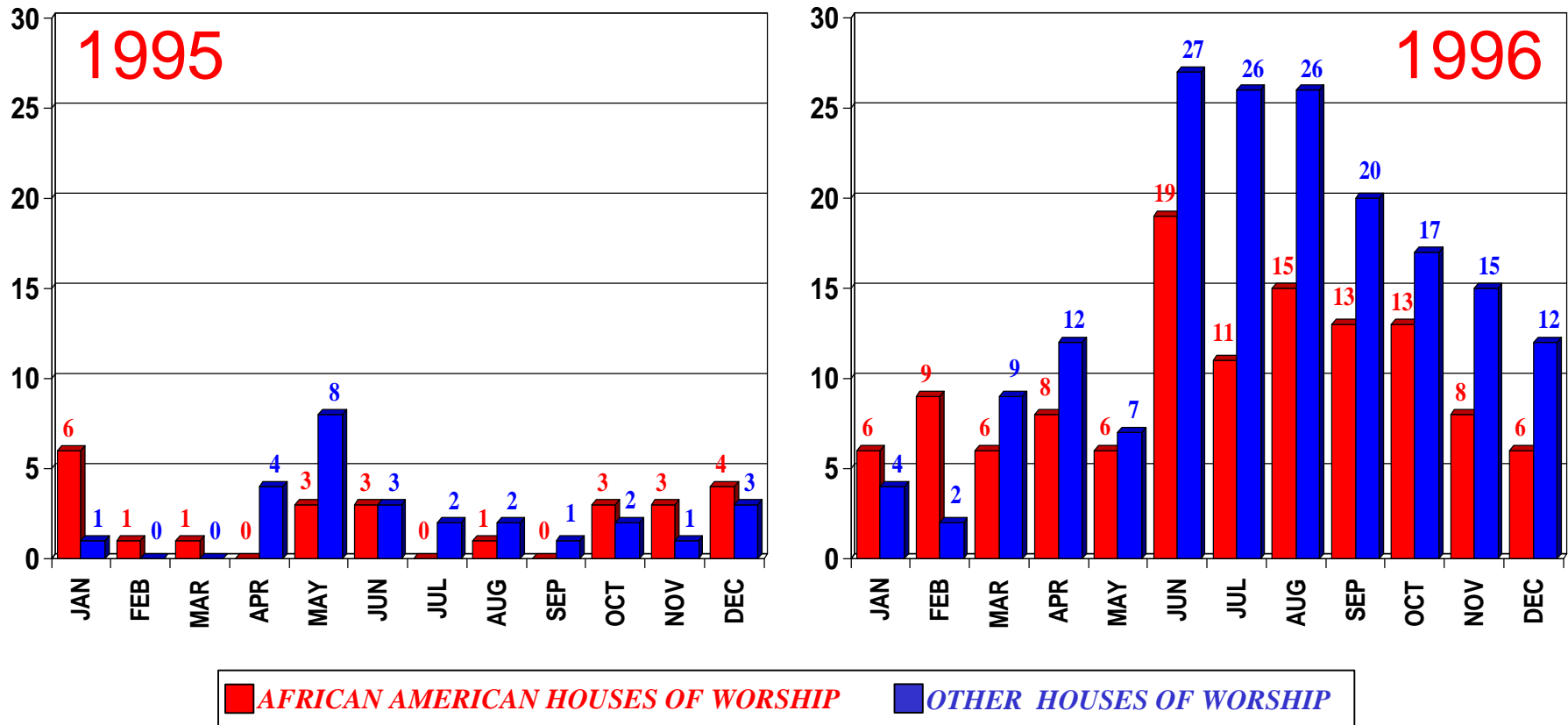

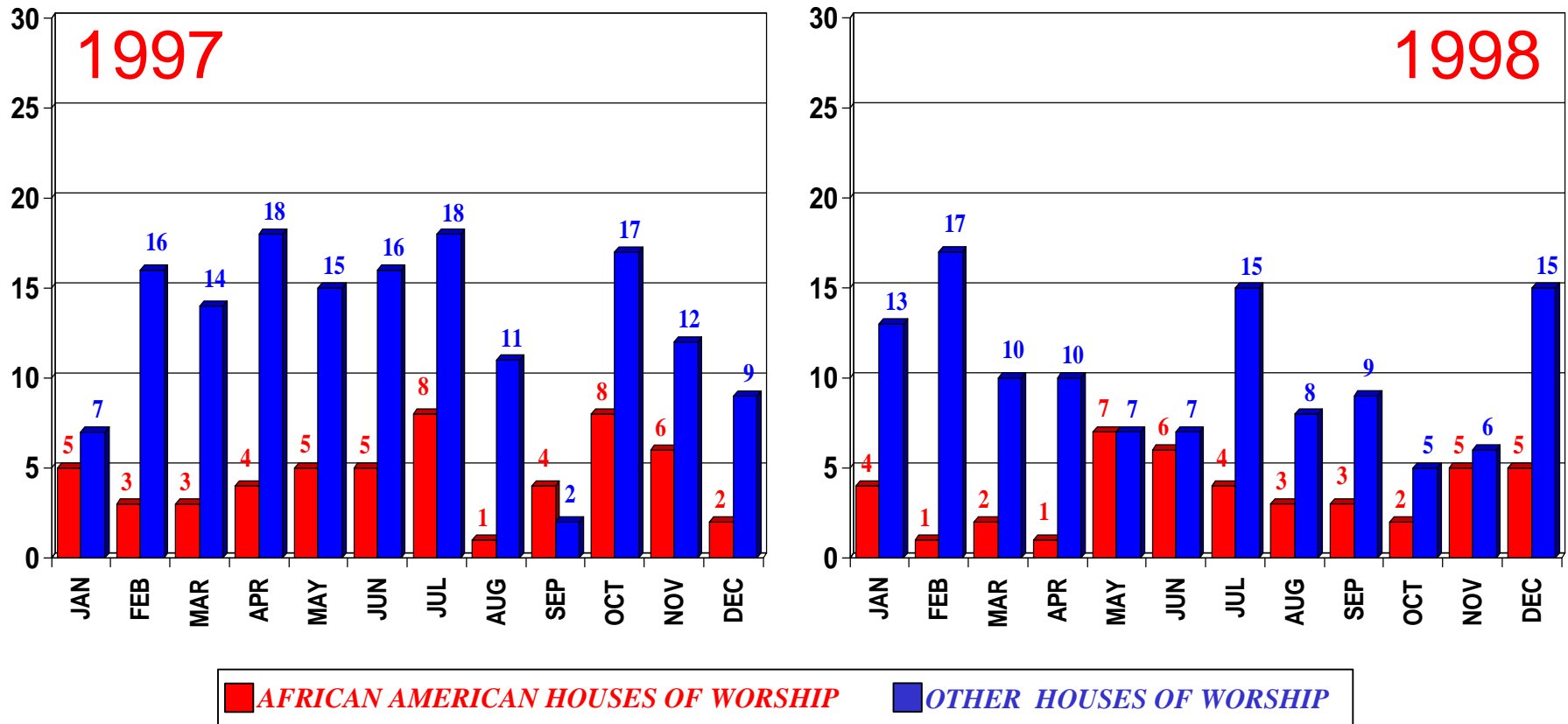

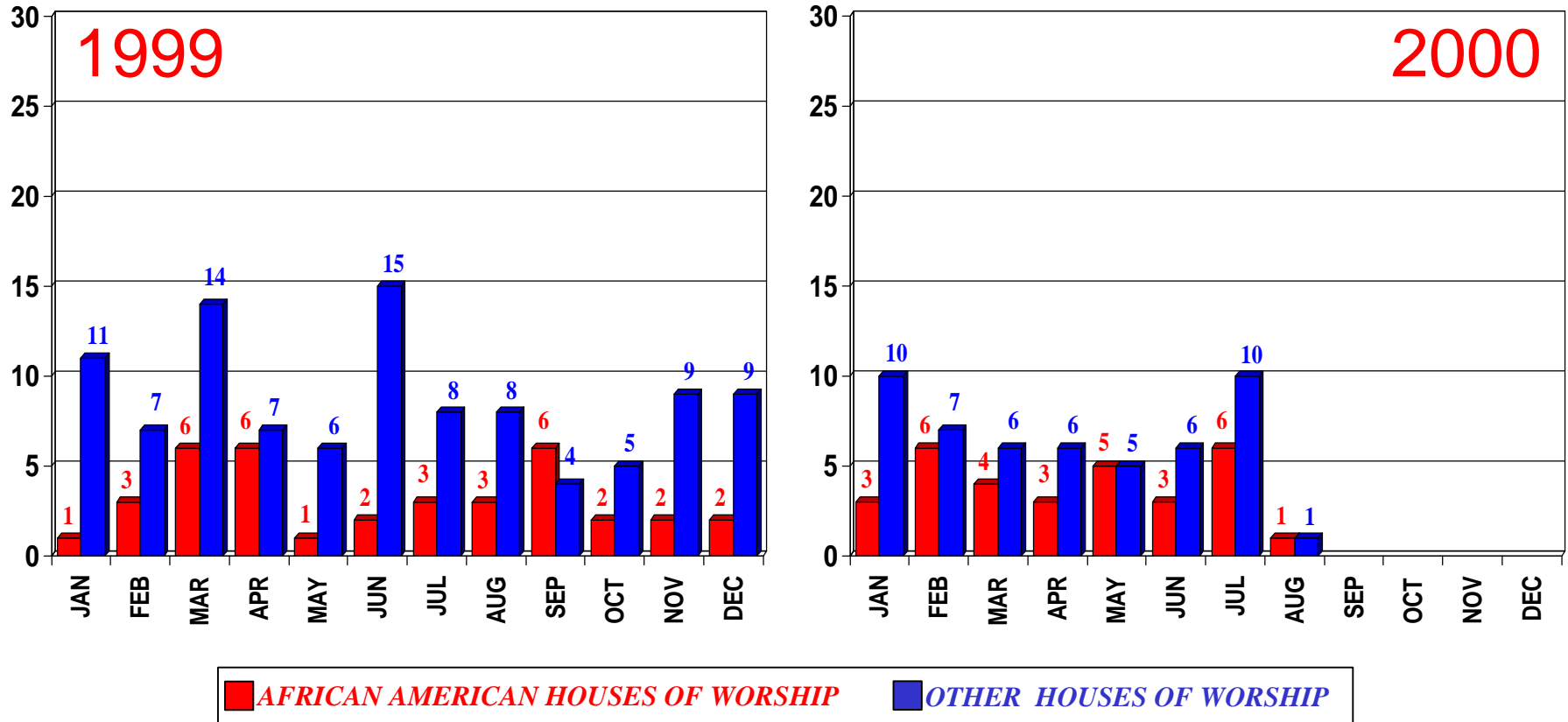

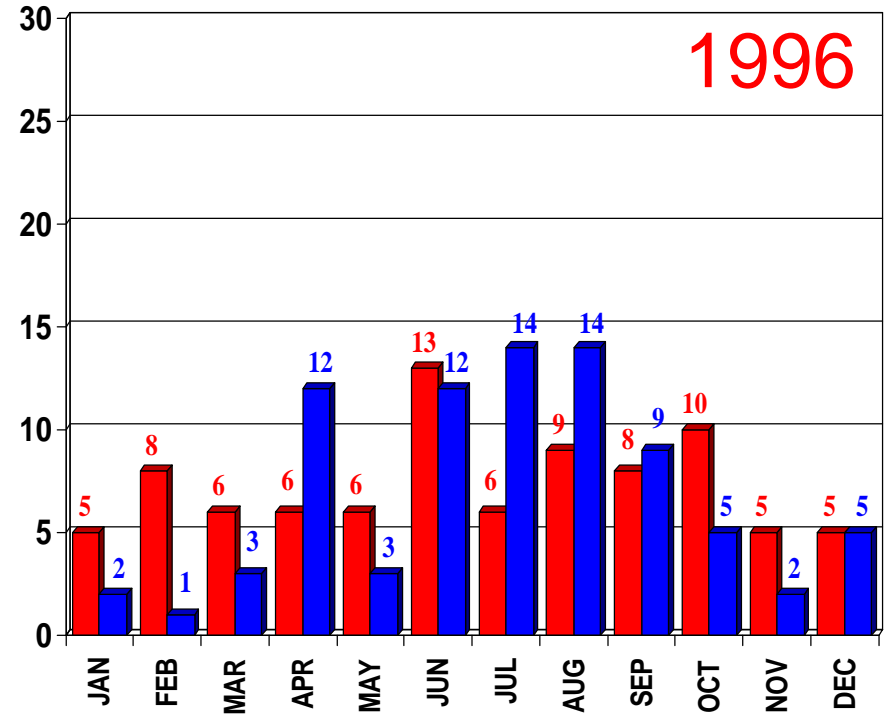
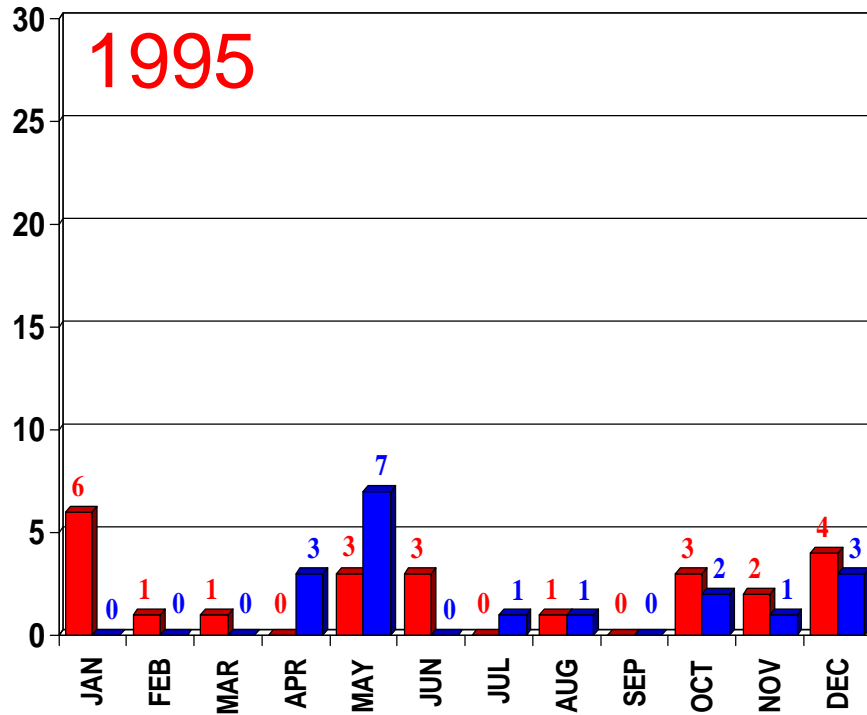

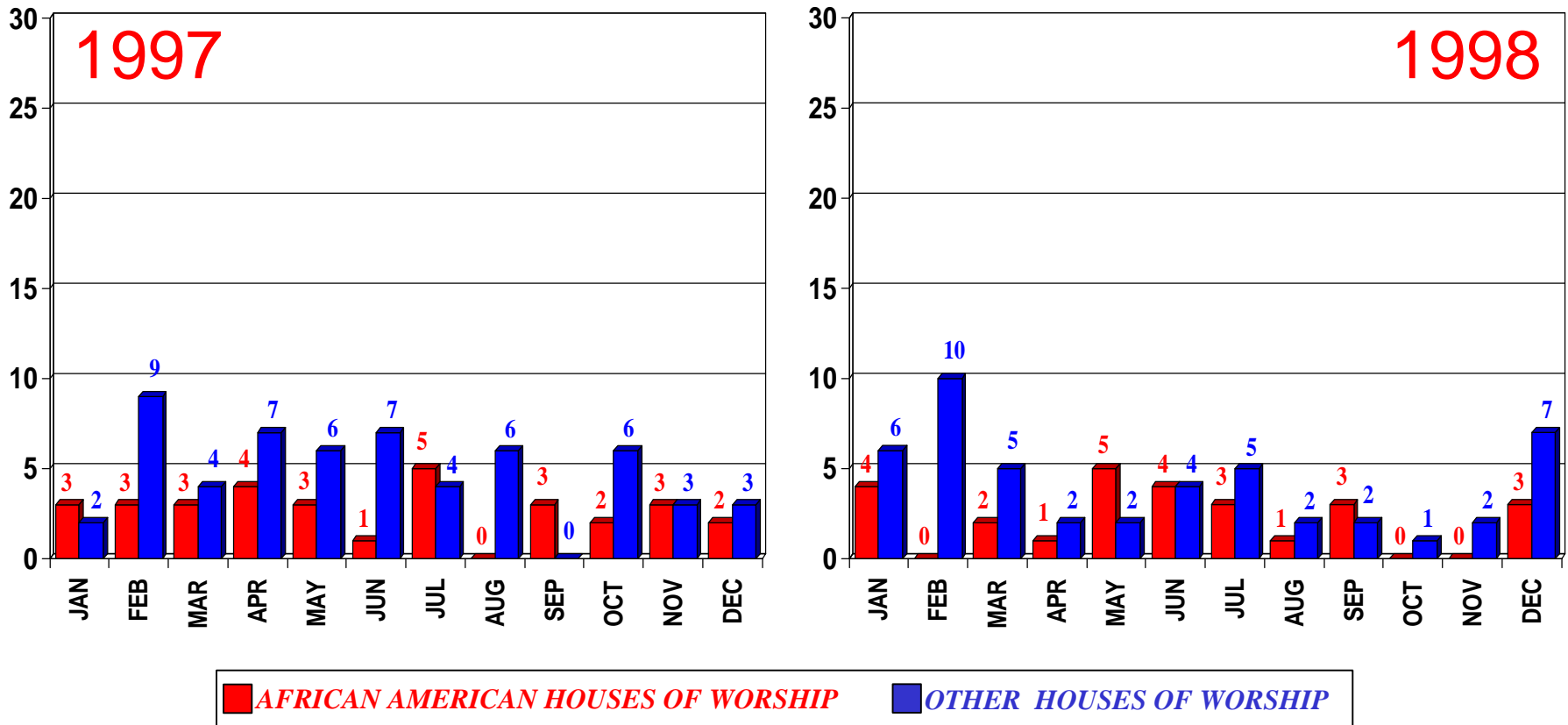

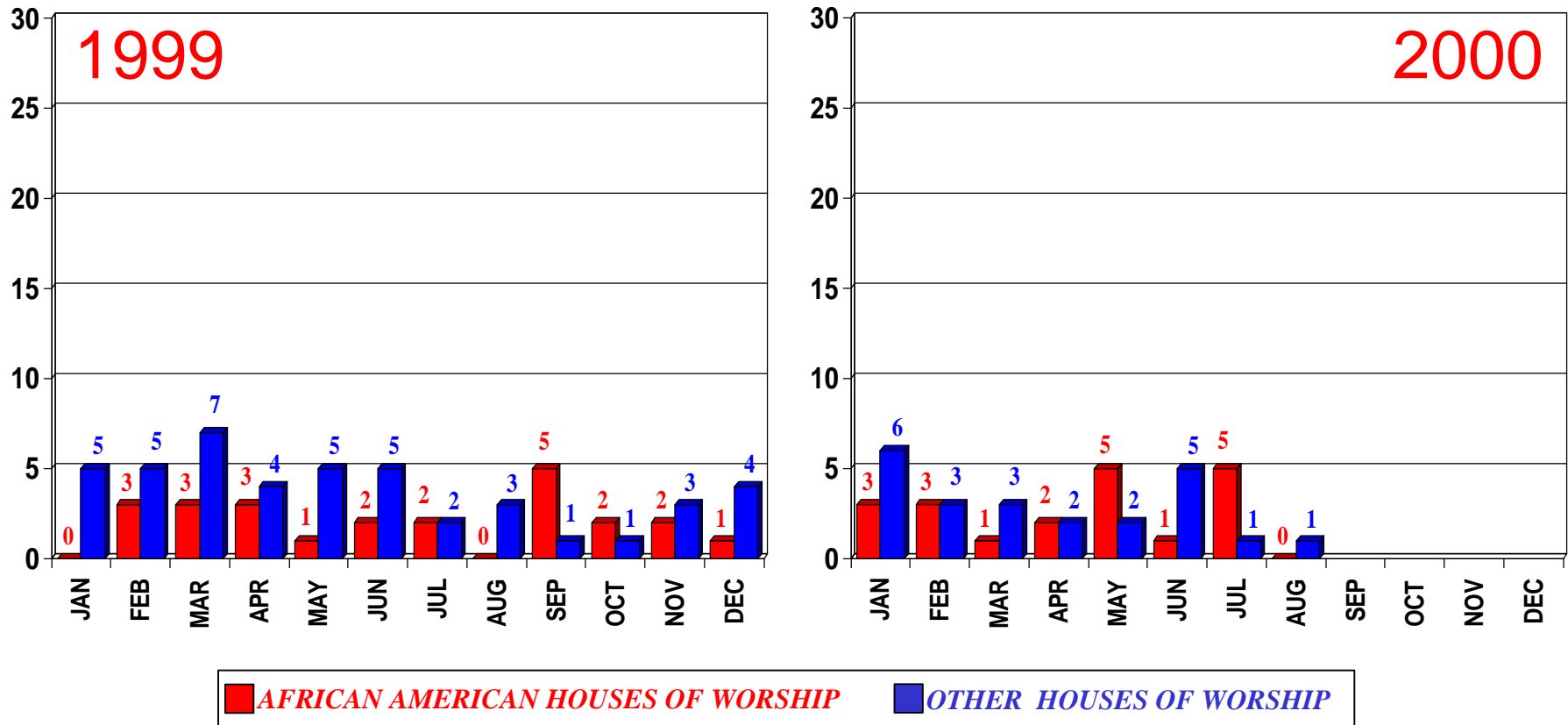

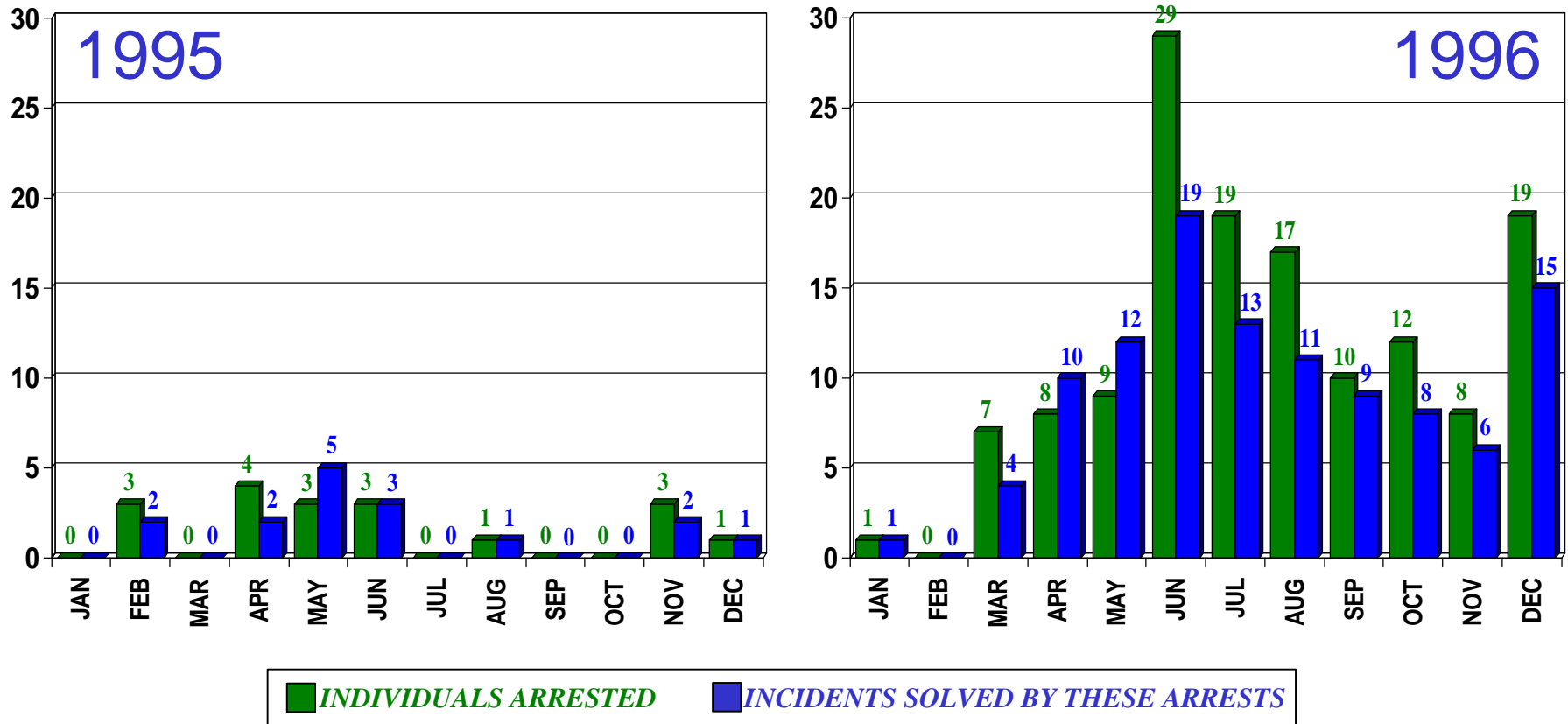

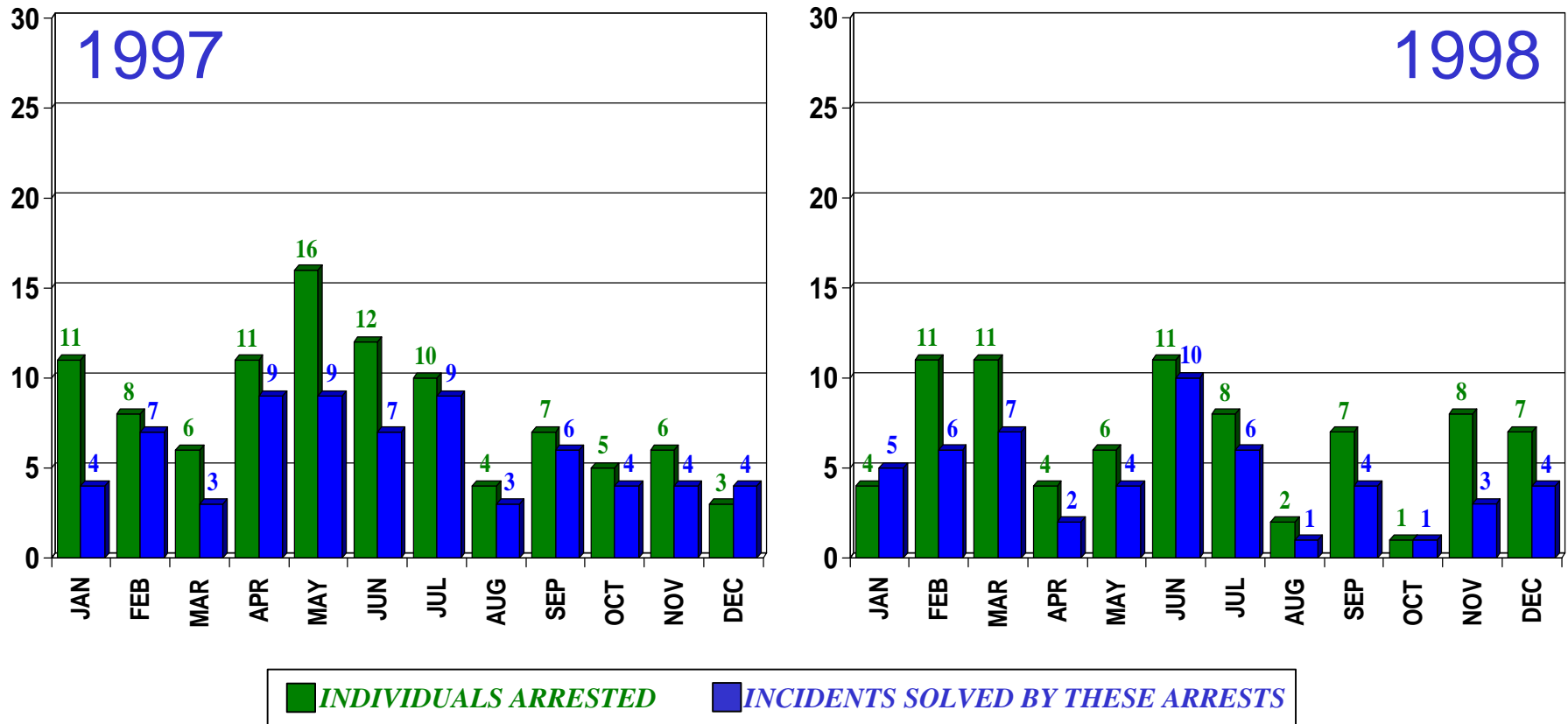

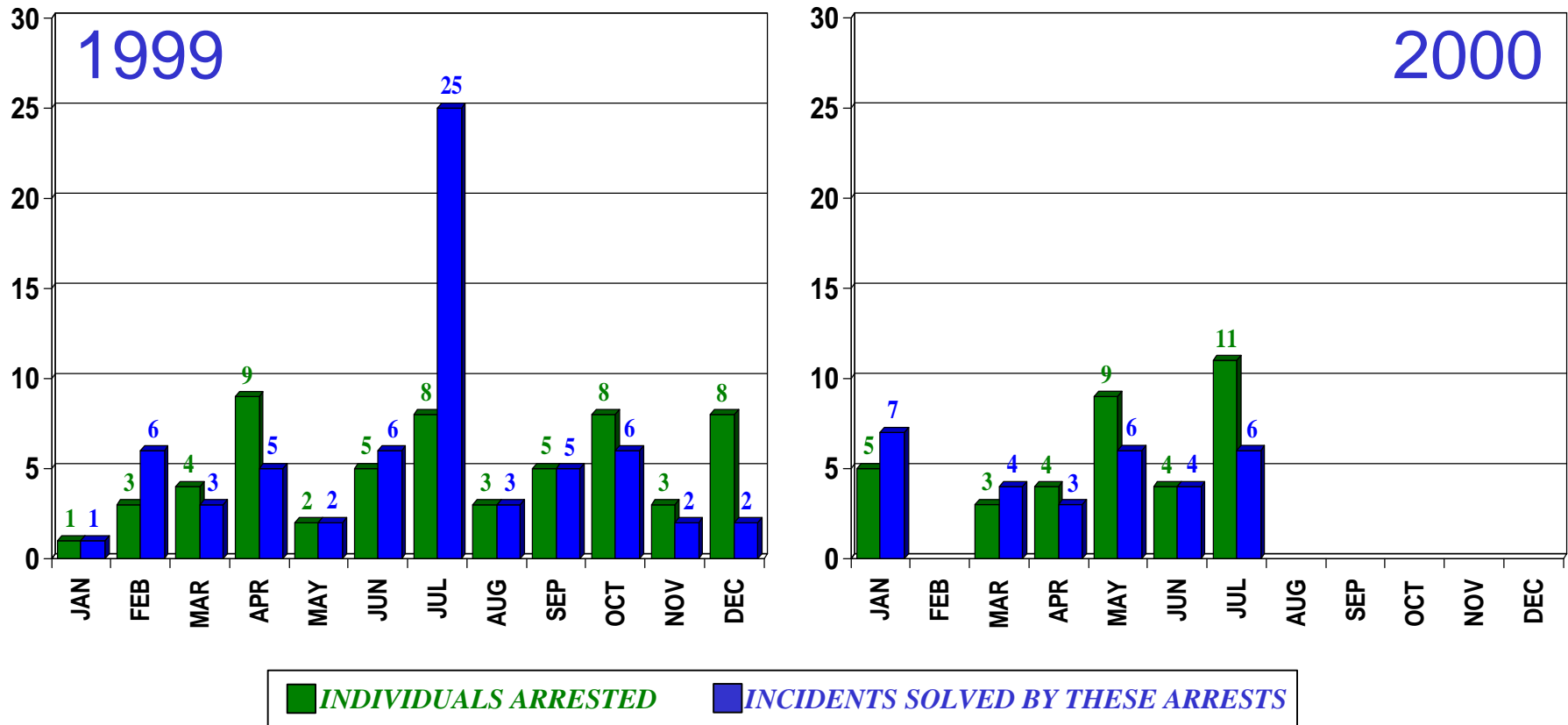

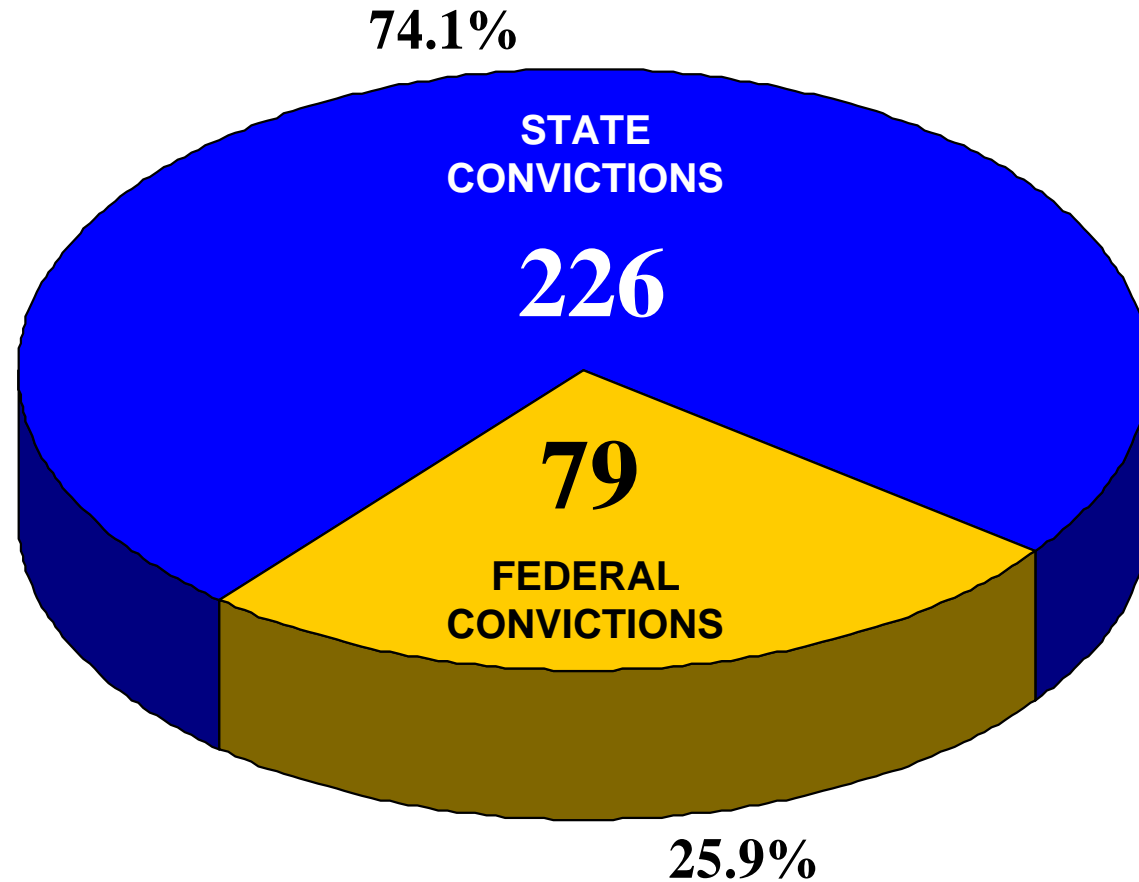

FEDERAL AND STATE CHURCH FIRE CONVICTIONS

October 6, 1999 - August 15, 2000

CALIFORNIA

1. Trinity Community Presbyterian (Spring Valley, CA)

On December 9, 1999, a black male, 30-year old defendant was sentenced in state court to 6 years in prison for burglary and arson.

FLORIDA

2. St. Mark Missionary Baptist Church (Middleburg, FL)

On May 31, 2000, a white male, 40-year old defendant was sentenced in state court to three years in prison for possession and manufacture of a firebomb.

GEORGIA

3. Hill Chapel Baptist Church (Athens, GA)

On March 26, 2000, a black male, 15-year old juvenile was sentenced in state court for reckless conduct. The sentence was sealed by the court.

4. Redeeming Life Fellowship (Cairo, GA)

On March 22, 2000, a white male, 24-year old defendant was sentenced in state court to 15 years in prison for burglary of the church.

ILLINOIS

5. Revival Center Church (Chicago, IL)

On March 8, 2000, a black male, 62-year old defendant was sentenced in federal court to 4 years imprisonment and three years supervised release for federal arson violations.

IOWA

6. St. Paul's Lutheran Church (Ft. Dodge, IA)

On April 25, 2000, a white male, 33-year old defendant was sentenced in federal court to 24 months imprisonment, 36 months supervised release, and ordered to pay \$2,236,139 in restitution.

7. Christ Temple Apostolic Church (Bradlee, IL)

On June 26, 2000, a white male, 16-year old juvenile defendant was sentenced in state court to 1 year in jail for arson.

KENTUCKY

8. Our Mother of Sorrows Catholic Church (Louisville, KY)

On August 8, 2000, a white male, 12-year old juvenile defendant was sentenced in state court to the State Youth Authority until his 18th birthday for arson. A second juvenile defendant, age fifteen, was sentenced to an undetermined amount of probation for arson.

MICHIGAN

9. St. Agnes Church (Fowlerville, MI)

On June 20, 2000, a white male defendant was sentenced in state court to 6 months probation, 20 hours of community service, counseling, and \$500 restitution for arson.

10. Liberty Center Temple (Benton Harbor, MI)

On August 1, 2000, a white male, 31-year old defendant was sentenced in federal court to 78 months in federal prison and 3 years supervised release for arson.

MONTANA

11. Jefferson Valley Baptist Church (Whitehall, MT)

On June 16, 2000, a white male, 40-year old defendant was sentenced in state court to a mental hospital for an indefinite period of time for psychological treatment.

NEW JERSEY

12. Mt. Laurel Church of the Nazarene (Laurel, NJ)

On October 14, 1999, a white male, 13-year old juvenile was sentenced in state court for arson and received deferred sentencing and a \$1000 fine.

NEW YORK

13. Blackwell Chapel AME Zion (Jamestown, NY)

On October 29, 1999, a white male, 42-year old defendant was sentenced in state court to 6 months imprisonment and 5 years probation for 3rd degree arson.

14. Grace Temple Church of God in Christ (Kingston, NY)

On January 24, 2000, a white male, 21-year old suspect was sentenced in state court to 1 to 3 years in jail for 3rd degree arson and 3rd degree burglary.

NORTH CAROLINA

15. World Harvest Oasis Temple (Greenville, NC)

On April 17, 2000, a black male, 27-year old defendant was sentenced in federal court to 125 months imprisonment for arson and bank fraud.

TEXAS

16. United Pentecostal Church (Bryan, TX)

On March 17, 2000, a white male, 30-year old suspect was sentenced in federal court to 24 months imprisonment and three years supervised release for conspiracy.

WASHINGTON

17. St. Joseph's Catholic Church (Yakima, WA)

On May 26, 2000, a white male, 29-year old defendant was sentenced in state court to 48 months in prison and ordered to pay \$4.36 million in restitution for 1st degree reckless burning.

18. Subud Pacific Northwest (Spokane, WA)

On June 19, 2000, a white male, 19-year old defendant was sentenced in federal court to 24 months in prison followed by 3 years supervised release for arson.

ARSONS AND BOMBINGS

ALABAMA

- Greater Saint Joseph Baptist Church (Baldwin) (Southern District)**
- Tate Chapel AME Church (Baldwin) (Southern District)** - On the night of June 30, 1997, there was an arson at the Greater Saint Joseph Baptist Church and an attempted arson at the nearby Tate Chapel AME Church. Both congregations were African American. The Greater Saint Joseph Baptist Church was totally destroyed by the fire. Regarding the arson at the Greater Saint Joseph Baptist Church, two 18-year-old Caucasian adults, one male and one female, were found guilty by a jury (in November 1997) of violating 18 U.S.C. §371 (conspiracy to commit an arson). These two defendants were sentenced to 41 months of imprisonment and ordered to perform 300 hours of community service. Another 18-year-old Caucasian male was found guilty (in November 1997) of violating one count of 18 U.S.C. §844(i) and one count of 18 U.S.C. §844(h)(i). He was sentenced to 15 years of imprisonment. The fourth defendant, an 18-year-old Caucasian male, pled guilty (in October 1997) to violations of 18 U.S.C. §844(i) and 18 U.S.C. §247 (civil rights violation). He was sentenced to 60 months of imprisonment, three years of supervised release, and 300 hours of community service. He was ordered to pay restitution. Regarding the attempted arson at Tate Chapel, a 19-year-old Caucasian male pled guilty (in October 1997) to one count of 18 U.S.C. §844(i). He was sentenced to 46 months of imprisonment, three years of supervised release, and 300 hours of community service. He was ordered to pay \$100 in restitution. One of the 18-year-old Caucasian males found guilty in the arson of the Greater Saint Joseph Baptist Church was also convicted (in November 1997) of violating one count of 18 U.S.C. §844(i) in connection with the Tate Chapel AME church. All of the co-defendants were ordered to jointly pay \$96,846 in restitution. Some of the defendants attended a Ku Klux Klan rally two days before the arsons. One yelled a racial epithet at the time of the arson.
- Born Again Church of Christ (Heflin) (Northern District)** - On November 14, 1996, a cross was burned at this African American church. Gasoline was poured onto two wooden beams arranged in the shape of a cross and then ignited at the front doorway of the church. Three Caucasian defendants, ages 26, 22, and 18, pled guilty in federal court (in April and May 1997) to violating 18 U.S.C. §241 (civil rights conspiracy). They were sentenced to 18 months,

15 months, and 24 months of imprisonment respectively. In addition, all were sentenced to three years supervised release, fined \$500, and ordered to pay restitution of \$2,145.

4. **Sunlight Baptist Church (Eastaboga) (Northern District)** - On October 27, 1996, this African American church was burned. One defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

ARKANSAS

5. **Universal Church of God (Shirley) (Eastern District)** - In May 1995, the Christian Day School operated by the Universal Church of God, which hosts a racially mixed congregation, was burned. One defendant, a 25-year-old Caucasian male, pled guilty in federal court (in August 1998) to violating one count of 18 U.S.C. §844(i) and one count of 18 U.S.C. §241. A second defendant, a 24-year-old Caucasian male, pled guilty (in October 1998) to one count of 18 U.S.C. §844(h)(1) and one count of 18 U.S.C. §241. A third defendant, a 22-year-old Caucasian female, pled guilty (in October 1998) to one count of 18 U.S.C. §241. The three were ordered to terms of incarceration ranging from 30 to 97 months in prison.

CALIFORNIA

6. **South Shore American Baptist Church (Dana Point) (Central District)** - On September 25, 1995, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §844(i). Sentencing is pending.

INDIANA

7. **Wabash Primitive Baptist Church (Huntington) (Northern District)** - On January 30, 1999, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

8. **Stidham United Methodist Church (Lafayette) (Northern District)** - On January 25, 1999, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

9. **Mt. Eden Christian Church (Scottsburg) (Southern District)** - On December 20, 1998, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

10. **Christian Liberty Church (Sheridan) (Southern District)** - On November 27, 1998, this Caucasian church was burned. A 24-year-old Caucasian female defendant pled guilty (in November 1999) to violating one count of 18 U.S.C. §247(a)(1) and (b). The second defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

11. **Bethel Missionary Church (Fillmore) (Southern District)** - On November 20, 1998, this Caucasian church was burned. A 24-year-old Caucasian female defendant pled guilty (in November 1999) to violating one count of 18 U.S.C. §247(a)(1) and (b). The second defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b), and one count of 18 U.S.C. §844(h)(1). Sentencing is pending.

12. **Ebenezer Presbyterian Church (Lewisville) (Southern District)** - On September 10, 1998, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

13. **New Liberty Congregational Christian Church (Lynn) (Southern District)** - On July 25, 1998 this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

14. **Grace Baptist Church (Coatesville) (Southern District)** - On June 10, 1998 this Caucasian church was burned. A 24-year-old Caucasian female defendant pled guilty (in November 1999) to violating one count of 18 U.S.C. §247(a)(1) and (b), and one count of 18 U.S.C. §844(h)(1) and (2). The second defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

15. **Hawcreek Missionary Baptist Church (Hope) (Southern District)** - On April 21, 1998, this Caucasian church was burned. A 24-year-old Caucasian female defendant pled guilty (in November 1999) to violating one count of 18 U.S.C. §247(a)(1) and (b). The second defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b), and one count of 18 U.S.C. §844(h)(1). Sentencing is pending.

16. **Milledgeville United Methodist Church (Milledgeville) (Southern District)** - On November 13, 1997, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

KENTUCKY

17. **Pleasant Hill Methodist Church (Elkton) (Western District)** - On January 18, 1999, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

18. **New Harmony Baptist Church (Morgantown) (Western District)** - On January 18, 1999, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

19. **Cedar Grove Baptist Church (Franklin) (Western District)** - On January 17, 1999, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

20. **Bolton Schoolhouse Missionary Baptist Church (Bonnieville) (Western District)** - On December 21, 1998, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

LOUISIANA

21. **Cypress Grove Baptist Church (Zachary) (Middle District)**

22. **Saint Paul's Free Baptist Church (Baker)(Middle District)**

23. **Sweet Home Baptist Church (Baker) (Middle District)**

24. **Saint Thomas Chapel Benevolent Society (Baker) (Middle District)** - On February 1, 1996, these African American churches were burned. The arsonists brought tires and gasoline to the churches. In one church, the fire was started by a molotov cocktail, in another church, by stacking tires and then setting them on fire, and in the last two instances gas was thrown into the churches and ignited. One defendant, a 25-year-old Caucasian male, pled guilty in federal court (in July 1997) to 18 U.S.C. §241 (civil rights conspiracy) and was sentenced to 48 months of imprisonment.

MISSOURI

25. **Sumach United Methodist Church (Wardell) (Eastern District)** - On July 21, 1998, this Caucasian church was burned. A Caucasian male defendant, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

NEVADA

26. **Temple Emanu-El Synagogue (Reno)** - On November 30, 1999, this synagogue was firebombed. The fire was started by a molotov cocktail. Five Caucasian male defendants, self-avowed skinheads ranging in ages from 18 to 25, pled guilty (in July 2000) to various federal charges. Four defendants, ages 20, 23 and 25, pled guilty to violating one count of 18 U.S.C. §241, one count of 18 U.S.C. §247(a)(1), and one count of 18 U.S.C. 844(h). The fifth defendant, age 18, pled guilty to violating one count of 18 U.S.C. §241, one count of 18 U.S.C. §247(a)(1), and one count of 18 U.S.C. 844(i). The defendants intended to burn down the building because it was a synagogue, and doing so would enable them to earn merits as skinheads. Sentencing is pending.

27. **Church of Christ (Henderson)** - On September 19, 1996, the siding on this African American church was burned. The defendant, a 23-year-old Caucasian male, pled guilty in federal court (in December 1996) to violating one count of 18 U.S.C. §247(c) (civil rights). He

confessed to using a lighter to ignite a fire. Witnesses stated that he attempted to burglarize the church, but failed. After the failed burglary, he stated he should burn the church because its members were African American. He was sentenced to 63 months of imprisonment and three years of supervised probation. He was also ordered to pay \$1,619 in restitution.

NEW MEXICO

28. Church of Jesus Christ of Latter Day Saints (Roswell) - On June 28, 1998, this Caucasian church was burned, causing 2.5 million dollars in damage. In the two months leading to this fire, a series of vandalisms occurred at three other Latter Day Saints churches in Alamogordo, Artesia and Alto, New Mexico, along with the arson of a truck used in interstate commerce. The vandalism included destruction of musical instruments, pews, doors and walls resulting in damage in excess of \$150,000. A 48-year-old Caucasian male pled guilty in federal court (in March 1999) to violating seven counts of 18 U.S.C. §247(a)(1), two counts of 18 U.S.C. §844(i), and one count of 18 U.S.C. §844(h)(1). The defendant was sentenced to 15 years in prison to be followed by three years supervised release.

NORTH CAROLINA

29. Saint James African Methodist Episcopal Zion Church (Maysville) (Eastern District) - On June 30, 1996, this African American church was burned. Seven molotov cocktails were thrown at and into the church and a petroleum product was poured around the church foundation. The damage estimate was \$50,000. Three Caucasian males pled guilty (in May 1997) to various federal charges. One of the defendants said they burned the church after hearing news reports about church burnings. One defendant, a 19-year-old male pled guilty to one count of 18 U.S.C. §844(i) and §844(h). He was sentenced to 30 months of imprisonment to be followed by three years supervised release, and ordered to pay restitution. Two of the juveniles pled guilty to 18 U.S.C. §§371, 844(i), 844(h), and 924(c)(1). They each received 18 months of imprisonment. A third juvenile was granted pre-trial diversion.

OHIO

30. Community United Methodist Church (Brookville) (Northern District) - On February 6, 1999, this Caucasian church was burned. One defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

31. Otterbein United Brethren Church (Rockford) (Northern District) - On January 23, 1999, this Caucasian church was burned. One defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

SOUTH CAROLINA

32. **Arm Oak Baptist Church (Hardeeville)** - On December 22, 1996, this African American church was burned. One defendant, a Caucasian male, age 38, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

33. **Mount Zion A.M.E. Church (Greeleyville)**

34. **Macedonia Baptist Church (Manning)** - On June 20 and 21, 1995, respectively, these two African American churches were burned. Four Caucasian ex-members of the Ku Klux Klan pled guilty (two defendants in August 1996 and two in December 1996) to federal charges relating to these arsons. Three of the defendants, ages 23, 24, and 52, received 168 months, 144 months, and 258 months of imprisonment, respectively, for violations of 18 U.S.C. §241 (civil rights conspiracy) and 18 U.S.C. §844(h). The fourth defendant, age 51, also pled guilty to violations of 18 U.S.C. §241 (civil rights conspiracy) and 18 U.S.C. §844(h). He received 180 months of imprisonment and five years of supervised release probation for the arson of Macedonia Baptist Church.

TENNESSEE

35. **Little Hurricane Primitive Baptist Church (Manchester) (Eastern District)** - On December 22, 1998, this African American church was burned. The defendant, a 38-year-old Caucasian male, pled guilty (in July 2000) to violating one count of 18 U.S.C. §247(a)(1) and (b). Sentencing is pending.

36. **Church of God of Prophecy (Dyersburg) (Western District)** - On July 22, 1996, this Caucasian church was burned. The defendant, a 20-year-old African American male, pled guilty in federal court (in November 1996) to violating one count of 18 U.S.C. §247(c) (civil rights). He said that he wanted to start a race war and that he was acting at the direction of Satan. The defendant was sentenced to 60 months in prison.

37. **Church of the Nativity (Bartlett) (Western District)** - On June 29, 1996, this Caucasian church was burned. The church suffered \$10,000 in damage to the altar area. The defendant, a 46-year-old Caucasian pastor, admitted setting the fire. He used a match to ignite curtains behind the altar. The defendant pled guilty in federal court (in March 1998) to one count of 18 U.S.C. §247. He was admitted into a rehabilitation clinic. He was sentenced to 33 months imprisonment to be followed by three years supervised release, and ordered to pay \$27,952 in restitution.

38. **Canaan A.M.E. Church (Maury County) (Middle District)**

39. **Friendship Missionary Baptist Church (Maury County) (Middle District)** - On January 29, 1995, these African American churches were firebombed. Three Caucasian defendants, 33, 35, and 43, pled guilty in federal court (in October 1995) to violating 18 U.S.C. §241 (civil rights

conspiracy). One defendant was sentenced to 57 months in prison while the other two defendants were sentenced to 46 months in prison.

TEXAS

40. **Gainesville Church of Christ (Harrison County) (Eastern District)** - On May 8, 1998, this African American church was burned. A 20-year-old Caucasian male pled guilty in federal court (in July 1998) to violating 18 U.S.C. §247(c) (civil rights) and 18 U.S.C. §844(i). A 29-year-old Caucasian male pled guilty (in August 1998) to violating 18 U.S.C. §247(c) (civil rights) and 18 U.S.C. §844(i). A 15-year-old juvenile male also pled guilty (in August 1998) to 18 U.S.C. §5032 to violate 18 U.S.C. §241 and 18 U.S.C. §844(i) in connection with this matter. The two adult defendants were sentenced to 60 months in prison to be followed by three years supervised release, and were ordered to pay \$54,000 in restitution. The juvenile defendant was sentenced to 24 months probation with a condition that he must complete 14 months detention in a boot camp program.

41. **Freedom Fellowship Church (New Boston) (Northern District)** - On March 28, 1998, this African American church was burned. The defendant, a 31-year-old Caucasian male, pled guilty in federal court (in September 1998) to violating one count of 18 U.S.C. §844(i). The defendant was sentenced to 60 months in prison to be followed by three years supervised release.

42. **Bethany Lutheran Church (Dallas) (Northern District)** - On March 5, 1998, this Caucasian church burned. Pentagrams, satanic symbols, racist and homophobic epithets were spray painted on the church and around the neighborhood. A 20-year-old Caucasian male pled guilty in federal court (in April 1998) to violating 18 U.S.C. §844(i) and 18 U.S.C. §247 (civil rights). He was sentenced to 33 months imprisonment and ordered to pay \$337,918 in restitution. A 19-year-old Caucasian male pled guilty (in April 1998) to violating one count of 18 U.S.C. §844(i). He was sentenced to 27 months imprisonment to be followed by three years supervised release, and ordered to pay \$337,918 in restitution. Two juveniles are being prosecuted by the state.

43. **Abiding Savior Lutheran Church (Corpus Christi) (Southern District)**

44. **McArdle Road Baptist Church (Corpus Christi) (Southern District)** - On October 31, 1997, these Caucasian churches were burned. Four defendants were involved. A 24-year-old Caucasian male pled guilty in federal court (in April 1998) to one count of 18 U.S.C. §371, two counts of 18 U.S.C. §247 (civil rights), and one count of 18 U.S.C. §844(i). He was sentenced to 71 months imprisonment and three years supervised release. A second 23-year-old Caucasian male pled guilty in federal court (in April 1998) to violating one count each of 18 U.S.C. §371, 18 U.S.C. §247, and 18 U.S.C. §844(i). He was sentenced to 63 months imprisonment and three years supervised release. A 23-year-old Caucasian female pled guilty in federal court (in April 1998) to violating one count each of 18 U.S.C. §371 and 18 U.S.C. §247 (civil rights). She was sentenced to 63 months imprisonment and three years supervised release. They were held jointly liable for \$138,628 in restitution. A female juvenile defendant was convicted at trial (in

November 1998) for violating one count of 18 U.S.C. §371 and two counts of 18 U.S.C. §247. She was sentenced to 51 months probation with the condition that she serve 12 months in a community corrections center. They were alleged to have Satanic motives for the arsons.

45. **Harvest Baptist Church (Keller) (Northern District)** - On August 27, 1997, the chapel of this Caucasian church was totally destroyed by fire. The damage estimate was \$150,000. The defendant, a 26-year-old Caucasian male, confessed to breaking a window, pouring diesel fuel, and striking a match. He said he decided to burn the church because he felt that the members of the congregation who attended services there were bothering his dog and creating parking and traffic problems along his street. He pled guilty in federal court (in November 1997) to one count of 18 U.S.C. §247(a)(2). He was sentenced to 30 months imprisonment to be followed by three years supervised release. He was also issued a \$100 special assessment and ordered to pay \$150,000 in restitution.

46. **Macedonia Baptist Church (Ferris) (Northern District)** - On March 22, 1997, this African American church was burned. Two Caucasian male defendants confessed to setting the fire using gasoline and a cigarette lighter. One defendant, 25, pled guilty in federal court (in May 1997) to violating 18 U.S.C. §844(i) and 18 U.S.C. §247(c) (civil rights). The other defendant, age 22, pled guilty (in May 1997) to violating 18 U.S.C. §844(i) and 18 U.S.C. §241 (civil rights conspiracy). The 25-year-old defendant received 60 months of imprisonment to be followed by three years supervised release, and was ordered to pay \$64,785 in restitution. The 22-year-old defendant received 70 months of imprisonment to be followed by three years supervised release, and was ordered to pay \$64,785 in restitution.

OTHER ACTS OF VIOLENCE

GEORGIA

47. **New Jerusalem African Methodist Episcopal Church (Ellenwood) (Northern District)** - On November 6, 1998, a Caucasian male made a threatening telephone call to this African American church. During the call he stated his intention to blow up the church. The defendant pled guilty in federal court (in April 1999) to violating one count of 18 U.S.C §844(e). The defendant was sentenced to one year imprisonment to be followed by three years supervised release, and was fined \$2,000.

IOWA

48. **Second Baptist Church (Fort Dodge) (Northern District)** - On August 15, 1993, a vandalism occurred and a cross was burned at this African American church. Two Caucasian

male defendants in their 20s pled guilty in federal court (in November 1998) to violating one count of 18 U.S.C. §241 and one count of 18 U.S.C. §844(i). One defendant was sentenced to 102 months in prison while the other was sentenced to 41 months in prison.

KANSAS

49. **Beth-El B'Y'Shue Messianic Synagogue (Wichita)** - On June 6, 1998, threatening graffiti was spray painted on all sides of this synagogue. The four defendants who were involved were members of a self-described skinhead group. Two Caucasian males, ages 21 and 23, pled guilty in federal court (in March 1999) to violating one count of 18 U.S.C. §241 (civil rights conspiracy) and violating one count of 18 U.S.C. §247. A 22-year-old Caucasian male pled guilty (in March 1999) to violating one count of 18 U.S.C. §241. The fourth defendant, a 19-year-old Caucasian male, was convicted in federal court (in March 1999) of violating one count of 18 U.S.C. §241 and one count of 18 U.S.C. §247. The three defendants who pled guilty were sentenced to terms of house arrest, while the fourth defendant who was convicted was sentenced to 18 months in prison.

NORTH CAROLINA

50. **Greensboro Jewish Federation (Greensboro) (Western District)** - On January 15, 1999, this Jewish cultural center received a threatening telephone call. The caller stated that all Jewish people will die and that, in the year 2000, synagogues will be bombed. One Caucasian male defendant, age 23, pled guilty (in April 2000) to violating one count of 18 U.S.C. §844(e). Sentencing is pending.

51. **China Grove A.M.E. Zion Church (Charlotte) (Western District)**

52. **Flora Williams Ministries (Charlotte) (Western District)** - On April 3, 1996 and May 19, 1996, these African American churches received racially threatening messages on their telephone answering machines. Two Caucasian defendants, ages 22 and 21, pled guilty in federal court (in January 1997) to violating one count of 18 U.S.C. §241 (civil rights conspiracy). The 22-year-old defendant was sentenced to 15 months of imprisonment to be followed by three years supervised release, and was ordered to perform 100 hours of community service. The 21-year-old defendant was sentenced to 12 months of imprisonment to be followed by three years supervised release, and was ordered to perform 100 hours of community service.

TEXAS

53. **Baruch Ha Shem (Dallas) (Northern District)** - On April 26, 1997, this Messianic Congregation building was damaged by gunfire and members were threatened with gunfire. The defendant, a 48-year-old Caucasian male, was yelling anti-semitic epithets as he fired the automatic weapon. He pled guilty (in January 1998) to violating one count of 18 U.S.C. §247(a)(2) and one count of violating 18 U.S.C. §24(c). He was sentenced to 147 months imprisonment and three years supervised release.

TENNESSEE

54. **Parker's Chapel (Memphis) (Western District)** - On August 5, 1996, this African American church was damaged by two gun shots. Three defendants, including two juveniles, were involved. One defendant, a 19-year-old Caucasian male, pled guilty in federal court (in October 1996) to one count of a federal firearms violation, 18 U.S.C. §922(j), and one count of 18 U.S.C. §922(x)(1). He was sentenced to six months in prison to be followed by six months home detention and two years supervised release. He was ordered to pay \$866 in restitution. A juvenile Caucasian male pled guilty (in October 1996) to one count of 18 U.S.C. §922(x)(2). He was sentenced to serve the remainder of his state sentence in addition to one year federal probation. The other juvenile Caucasian male pled guilty (in October 1996) to one count of 18 U.S.C. §922(j) and one count of 18 U.S.C. §922(x)(2). He has been sentenced to six months home detention and two years probation. He was ordered to pay \$866 in restitution.

THREAT ASSESSMENT GUIDE FOR HOUSES OF WORSHIP

Since 1995, over 1,500 houses of worship have been damaged by fire or bombing. Since that time, the National Church Arson Task Force (NCATF) has monitored every incident and identified common causes of fires. Many fires are preventable. The purpose of this booklet is to share what we have learned with the hope that it will help members of the faith community protect their facilities.

This booklet includes checklists designed to assist in determining your vulnerability to fire and bombing incidents. These guidelines have been developed from years of investigating and studying causes of fires, as well as from insurance companies and fire prevention experts. Leaders in the faith community are encouraged to utilize these checklists to see where improvements can be made. The lists are not all inclusive. You are encouraged to contact your local fire department, law enforcement agency or insurance representative for additional assistance. Church Mutual Insurance Company offers a 13-minute video with steps to protect your house of worship. The video is available at no cost by calling 1-800-554-2642.

You may communicate with the Bureau of Alcohol, Tobacco and Firearms (ATF) with any concerns or information regarding fires or bombings at houses of worship. The ATF Church Arson Section may be contacted through ATF's website at www.atf.treas.gov. Once in the website, click on the NCATF banner. There you will find the annual reports to the president, this threat assessment guide, as well as a link which you may send an e-mail. We encourage you to use the site for education and to provide any pertinent information you have regarding crimes at houses of worship. You may also visit the Federal Bureau of Investigation's (FBI) website at www.fbi.gov.

ARSON

Since 1995, the NCATF has recorded the arson of almost 900 houses of worship in the United States. Arson remains the leading cause of fire at worship facilities. The first step in prevention is to be aware of the potential for arson at your facility. Motives vary widely: vandalism, pyromania, to cover up evidence of other crimes (*such as burglary*), financial profit, retaliation, and racial/religious discrimination (*hate crimes*).

Assess your particular organization's potential to be a victim of an arson attack. Are there disgruntled persons or disputes that could motivate someone to commit arson? Also, be aware that if your congregation is involved in controversial social or political issues, you may be at risk of an attack.



Houses of worship are particularly vulnerable to arson due to their frequent periods of vacancy. Many houses of worship are only occupied a few hours a week. This allows an arsonist a wide window of opportunity to commit a crime. Help close this window of opportunity by requesting members of your congregation to be attentive to the facility on their way to work or shopping. Many of your members are likely to drive by your worship center many times during the week. Encourage them to take a few moments and drive through the parking lot and check the building. Increased activity around a house of worship may discourage an arsonist.

Advise them that if they encounter a suspicious person or activity not to challenge them, but to call the police.

Also, contact your local law enforcement agency and establish a rapport with the officers who routinely patrol your area. Familiarize them with times of worship and activities so that they will be alerted when people are present at off-times.



Nearby residents or business people may be an excellent resource in protecting your house of worship. Get to know them and ask them to be on alert for suspicious activity and to report it to the police. Provide them with a contact person's name and telephone number to call if they are not sure a vehicle or person should be at the building.

Studies have identified that more fires occur on Halloween and Independence Day. Ask your neighbors, members and police department to be especially watchful during these times.

If possible, install fire and burglar alarms at your house of worship. Alarms often cost less than people think and can save your facility in the event of a fire.

To protect persons who are present in the event of a fire, prepare an emergency evacuation plan. Post the plan on bulletin boards and make sure all are familiar with it. Consider conducting periodic fire drills. These are especially important if you have numerous children in your congregation.

Use the arson prevention checklist in this booklet to help assess your vulnerability to arson. Your local fire, police and insurance representative may provide additional assistance in taking a survey.

Finally, consider the following steps to help prevent arson at your worship facility:

- Cut shrubbery and trees to provide better visibility.
- Do not allow signs to block the view of the building.
- Secure ladders and stairways that give access to the roof.
- Consider decorative or wrought iron protection for windows.
- Install floodlights to the exterior of the building.

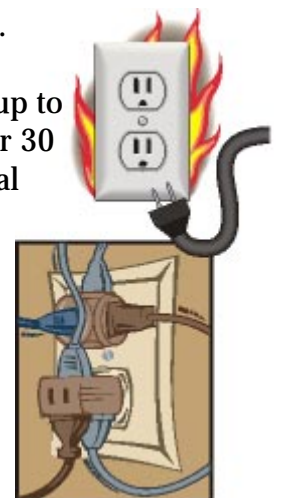


ACCIDENTAL FIRES

During the past five years, the National Church Arson Task Force has studied all houses of worship fires nationwide. We have learned that many of the accidental fires could have been prevented.

Some common causes of accidental fires at houses of worship and ways to prevent them include:

- **Construction/Maintenance Tools** – *Never* leave construction/maintenance tools such as propane torch or soldering tools unattended.
- **Improper Storage of Combustible Material** – *Always* store flammable liquids/materials such as paint, paint thinners, cleaning solutions and propane in a safe environment. *Never* store these items or any other flammable materials near heat or flame. *Never* store combustibles near a furnace or water heater. Also, *never* store combustibles inside or in storage areas near the building.
- **Kitchen Stoves/Coffee Makers (Appliances)** – If you have kitchen facilities, *never* leave kitchen stoves, coffee makers or any other electrical appliance unattended. *Always* turn off and unplug your appliances before leaving. Have a Type K fire extinguisher in your kitchen and be sure all personnel know how to use it properly.
- **Weather Related Fires (Lightning Strike)** – Houses of worship are particularly vulnerable to lightening strikes. Your best protection is a lightning protection system that has been certified by the Lightning Protection Institute (LPI) or Underwriters Laboratories (UL.) Your insurance representative or fire department can provide more information.
- **Malfunctioning of Furnace/Air Conditioner** – Annual inspections by qualified personnel are recommended on all heating and air conditioning units to ensure they are in safe working order.
- **Malfunctioning or Overheating of Water Heater in Baptismal Pool** – Most manufacturers and insurance representatives recommend the water be drained from baptisteries after use. If draining the baptistery is not desirable, consider turning off heaters and motors when the building is vacant. *Always* have repairs conducted by qualified technicians.
- **Poor Electrical Wiring** – *Always* make sure that your electrical wiring is up to code and have a qualified electrician do the repairs. If your building is over 30 years old, it is advisable to have the wiring inspected by a qualified electrical contractor.
- **Unattended Space Heaters** – *Never* leave space heaters on while unattended. *Always* make sure that the heater is turned off before leaving the premises. If an extension cord must be used, make sure it is the appropriate type and never overload an electrical outlet.



- **Unattended Candles/Incense** – *Never* leave candles or incense burning while unattended or overnight. *Always* make sure these items are placed on a heat resistant surface and that they are not left burning near combustible materials such as cloth. (See *Storage of Combustible Materials* above.) Make sure lit materials are cool before disposal. Remember, the use of lit materials should be supervised by an adult.



Here are some additional tips for preventing accidental fires at your house of worship:

- Discourage smoking within or near the exterior of the structure.
- Inspect all electrical cords and extension cords in use. Discard any frayed, cracked or dried out cords.
- Make sure that all wall sockets and light switches are equipped with faceplates.
- Store gasoline and gasoline operated equipment in vented storage areas or fire resistant enclosures.
- Insure that proper size fuses are used in fuse box.
- Never store combustibles/flammable liquids near heat or flame. Store away from church property in a safe place.
- Never leave Christmas tree lights or candles on overnight or while unattended.
- Make sure all draperies and furnishings are made of fire retardant fabrics.
- Make sure electronic musical instruments are turned off while not in use. If left on, the motor can overheat and cause a fire.
- Keep kitchen stoves and appliances in good working order.
- Make sure all kitchen appliances are turned off before leaving the building.
- If you allow persons to sleep in your facility, be aware there is an increased risk of fire and other property damage. If you intend to let people sleep in your building, be sure to first check with local authorities to make sure you are not in violation of local habitation codes. It is also wise to provide supervision, prohibit smoking and cooking and to install an early warning fire alarm.



Fire Extinguishers: Your worship facility should have at least one fire extinguisher for every 2,500 square feet and a minimum of one extinguisher on each level of your building. There should be no more than 75 feet of travel from anyplace in your building to a fire extinguisher. Local ordinances may require more, so check with your fire department for information specific to your particular area.

Fire extinguishers are classified by types of fires on which they are effective:

Type A – effective on ordinary combustibles such as paper, cloth, wood or trash.

Type B – effective on flammable liquids such as gasoline, paint, oil, grease or tar.

Type C - effective on electrical fires.

Type K – for use in kitchens on combustible cooking materials.

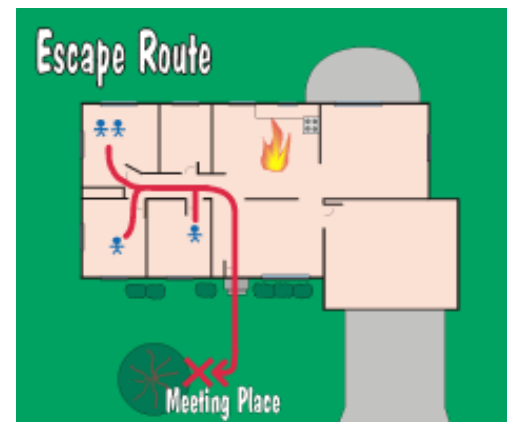


A fire extinguisher rated as **Type ABC** is recommended in all areas of your worship facility except kitchen areas. If you have a kitchen, place a Type K extinguisher near the kitchen exit and within 30 feet of cooking appliances, but not immediately above or beside them.

Fire extinguishers should be inspected monthly by a trained person. Staff and members who are regularly at your facility should be familiar with each extinguisher's operation.

In deciding whether or not to fight a fire with a fire extinguisher, keep the following in mind:

- Has everyone left the building and has the fire department been called?
- Is the fire confined to a small area and not spreading?
- Do you have an unobstructed escape route?
- Is your extinguisher rated for your fire?
- Do you know how to use the extinguisher properly?



If in doubt about any of these questions, leave immediately, close off the area and wait for the fire department.

BOMBINGS

Bombs can be constructed to look like anything and can be placed or delivered in any number of ways. The probability of finding a bomb that looks like the stereotypical bomb is almost nonexistent. The only common denominator that exists among bombs is that they are designed and intended to explode.

What can you do to help prevent a bombing disaster? First, consider whether you or your organization could be a possible target. Motives for bombings include revenge, extortion, terrorism and business disputes.



If your organization is active in controversial political and/or social issues, be aware that you could be targeted for violence.

If a suspicious object or package is found in your facility, under no circumstances should anyone move, jar or touch the object. Removing and disarming a bomb must be left to the professionals. Call your local police department immediately!

While waiting for their arrival, take the following steps:

- Identify the danger area. Generally, a 300-foot area should be considered in the danger zone, including floors below and above the object.
- Follow your evacuation plan and evacuate the building.
- Open all door and windows in order to minimize damage in the event the device explodes.
- Do not re-enter the building until bomb squad personnel tell you it is safe.

BOMB THREATS

Unfortunately, bomb threats do occur at houses of worship. Instruct all staff and members who answer the telephone how to respond to bomb threats. Proper planning for these incidents can reduce panic, instill confidence in leadership and help ensure a calm and safe response.

A calm response to the caller provides the best chance of obtaining additional information. Often, the bomber wants to avoid injuries or deaths. If the caller is told that the building is occupied and cannot be evacuated in time, the bomber may be willing to give more specific information on the bomb's location.



Remember, the caller is the best source of information about the bomb. Place a copy of the Bomb Threat Checklist found in the back of this booklet by each telephone in your worship facility.

When a bomb threat is received:

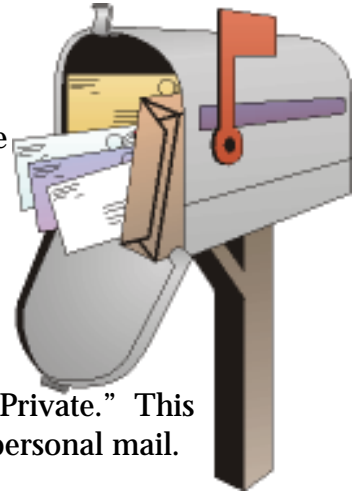
- Keep the caller on the line as long as possible. Ask him/her to repeat the message. Write down every word spoken by the person.
- If the caller does not volunteer the location of the bomb, ask him/her where it is.
- Calmly inform the caller that the building is occupied and that people may be injured or killed.
- Listen for background noise, such as motors running, music playing, and any other sounds which may give a clue as to the location of the caller.



- Pay particular attention to the voice of the caller (*male, female*), voice quality (*calm, excited*), accents and speech impediments.
- Report the threat immediately to your local law enforcement agency. After you have reported to your local law enforcement agency, you may also report the threat to the NCATF through our web site at **www.atf.treas.gov**.
- Remain available for law enforcement to interview you.

MAIL BOMBS

- Mail bombs may have excessive postage. Normally a bomber does not want to mail a parcel over the counter and have to deal face-to-face with a window clerk.
- The return address may be fictitious or non-existent.
- The postmark may show a different location than the return address.
- Mail bombs may bear restricted endorsements, such as “Personal” or “Private.” This is particularly important when the addressee does not usually receive personal mail.
- Mail bombs may display distorted handwriting or the name and address may be prepared with homemade labels or cut-and-paste lettering.
- Parcel bombs may be unprofessionally wrapped with several combinations of tape used to secure the package and may be endorsed “*Fragile—Handle With Care*” or “*Rush—Do Not Delay.*”
- Letter bombs may feel rigid or appear uneven or lopsided.
- Package bombs may have irregular shapes, soft spots or bulges.
- Mail bombs may have protruding wires, aluminum foil or oil stains and may emit a peculiar odor.
- Be suspicious of any letters or packages arriving before or after a phone call from an unknown person asking if the item was received.
- Packages wrapped in string are automatically suspicious, since modern packaging materials have virtually eliminated the need for twine or string.
- If your organization does not normally receive mail from foreign sources, be cautious of packages containing foreign writing, addresses or postage.



NOTE: To utilize these guidelines it is important to know the types of mail your organization receives.


If you become suspicious of a mailing and are unable to verify the contents, observe the following safety precautions:

- **Do not** open the article.
- Isolate the suspect parcel and evacuate the immediate area.
- Do not put the article in water or a confined space, such as a desk drawer or cabinet.
- If possible, open windows in the immediate area to assist in venting potentially explosive gases.
- If you have any reason to believe a letter or package is suspicious, do not take a chance or worry about possible embarrassment if the item turns out to be innocent. Contact your local police department immediately. They would rather respond to a false alarm than respond to a blast scene.

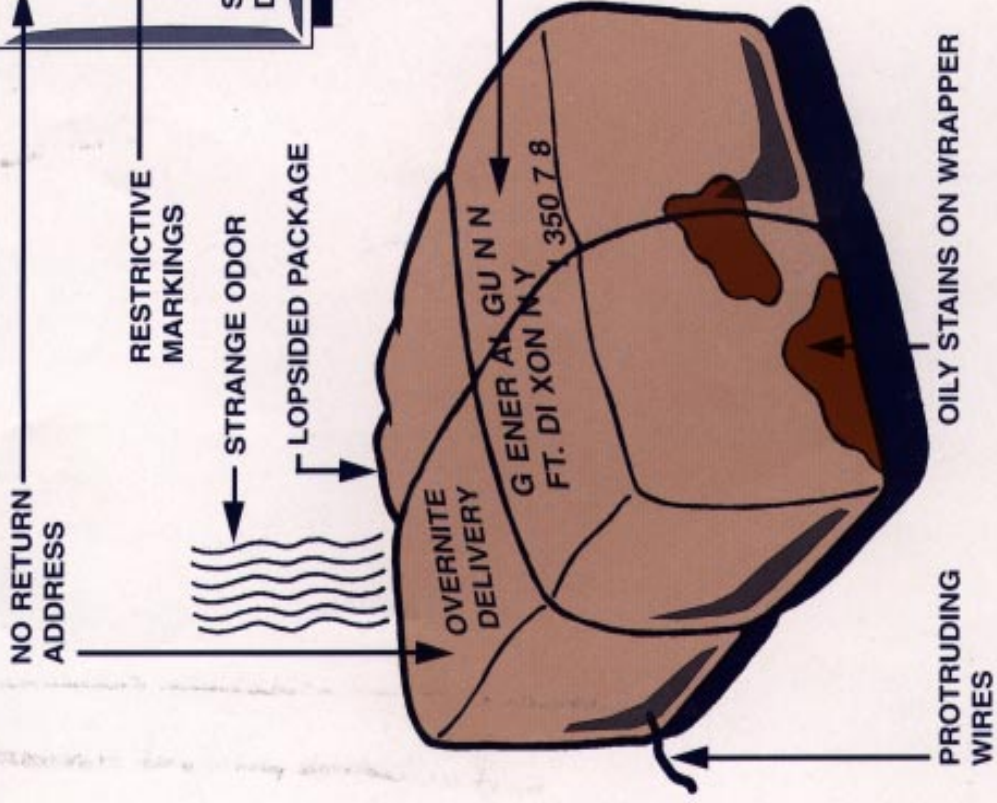
