Dear Secretary Spellings,

We are writing to request that the Department of Education direct any of the unobligated balances within the Office of Elementary and Secondary Education to the Upward Bound Math-Science Program at the University of Wisconsin-Green Bay (UWGB).

As you may be aware, UWGB sought a renewed Upward Bound Math-Science (UBMS) grant in 2006. Unfortunately, it was not approved because the school was not awarded any "prior experience points for post-secondary graduate rate," despite the University's participation in UBMS program since 1992. The University also submitted data that documented its successful post-secondary rate of graduation.

The Department of Education has acknowledged that the instructions in its application booklet and the formatting directions in its Annual Performance Report are inconsistent and has already begun revising the form for the next round of grants.

While we appreciate the Department's efforts to improve the upcoming application process, the past irregularities unfortunately resulted in UWGB missing the cut-off score and losing its grant. The University is actively pursuing alternate sources of funding to continue the program until the next grant cycle, but without funding to sustain the program in the interim, it is regrettably facing termination at the end of 2008.

Any funding that could be directed to the UWGB program from the Office's unobligated balances would make an immeasurable difference in the lives of students throughout the state of Wisconsin.
