## **Hurricane and Tropical Storm Procedures**

On May 26, 2005, MMS issued a Notice to companies in the Gulf of Mexico who lease oil and gas properties, "Hurricane and Tropical Storm Evacuation and Production Curtailment Statistics." It provides for the submittal of a report of more detailed information regarding oil and gas production shut-ins. Operators must submit statistics to the MMS Gulf of Mexico Region (GOMR) regarding evacuation of personnel and curtailment of production because of hurricanes, tropical storms, or other natural disasters. The MMS GOMR uses this data to notify the news media and interested public entities that monitor shut-in production.

MMS Form MMS-132 specifies the information that the MMS GOMR collects when platforms and drilling rigs are fully or partially evacuated and/or production is reduced because of a storm. Operators must include both those platforms and drilling rigs that are evacuated and those that they anticipate will be evacuated. Evacuation is defined as the removal of any personnel (both essential and non-essential) from a platform or drilling rig.

Completed forms must be sent to the MMS GOMR. In addition to Form MMS-132, a report containing the following information regarding each facility that remains shut in because of storm damage: the platform name; daily oil production (BPD); cumulative oil shut in (barrels); daily natural gas production (MMSCFPD); cumulative natural gas shut in (MMSCF); anticipated time to return to production (days); and the reason for shut- in (facility damage or transportation system damage).

Operators must notify the MMS GOMR when production is resumed.
