## Accomplishments and challenges in public health

In the past year, King County has made an effort to look more closely at public health issues and how they affect our residents. As a member of the King County Board of Health, I am especially committed to highlighting the achievements and areas needing improvement in our public health system. In 2006, the Public Health Department issued a report entitled "The Health of King County 2006," citing many improvements as well as continuing and emerging concerns.

We can be proud that King County remains one of the healthiest locales in Washington State and the entire nation. For example:

- ▶ Residents of King County can expect to live five years longer than they did 20 years ago, exceeding life expectancy totals throughout state and the country. Males average 78 years, and females, 82.5 years.
- ▶ Infant mortality is at its lowest ever in the County.
- ▶ Smoking rates have declined steadily.

Despite this positive news, we still have a ways to go, particularly with regard to health disparities among the poor and communities of color. The following statistics illustrate this problem:

- The life span of African American and Native American males is about eight years less than their White counterparts in King County.

- Nearly 25% of people with annual incomes of less than \$25,000 reported serious unmet medical needs.
- ▶ Frequent mental distress affects 20% of those in the lowest income bracket. There is also a higher rate of suicide deaths and hospitalizations in areas of high poverty.



### Restoring public trust in the Sheriff's Office

A special Blue Ribbon Panel formed by the Sheriff's Office lead a distinguished 10-person panel of professionals and community leaders through a nearly year-long review of officer discipline and personnel issues within the

King County Sheriff's Department. The panel was led by former King County Executive Randy Revelle and former Washington State Supreme Court Justice Faith Ireland.

This panel provided the Sheriff with a series of six interrelated recommendations for improving accountability, operational effectiveness, and policies for handling officer discipline and civilian oversight. The centerpiece of the recommendations was creating an Independent Police Oversight Board.

#### Riders to benefit from passage of Transit Now

In November, voters decisively passed King County Proposition No. 2, otherwise known as "Transit Now," a measure that increases the sales tax in King County by one-tenth of a percent (0.1) to provide expanded Metro bus service to county residents. The focus over the next few years will be on assigning more buses to high ridership routes within core communities in Seattle. There will be an effort to support and coordinate service integration with the Sound Transit Light Rail Line that will open in 2009. You will be pleased to know we plan to add new buses to

busy routes as early as February 2007. This increase will be implemented before Metro begins to collect the sales tax revenue in June. Planned route improvements for District 2 are as follows:



- 3/4, 11, 48, 60 (serving First Hill, Madison Park, Rainier Beach, Capitol Hill, Beacon Hill, University District, Downtown Seattle): Add more trips when ridership is greatest and adjust schedules to improve on-time operations.
- 36 (serving Rainier Beach, Beacon Hill, Downtown Seattle): Extend trolley bus service to Othello/New Holly Link Station and improve evening and Saturday service.
- 44 (serving University District, Wallingford, Ballard): Extend duration of 10-minute peak service on weekdays.
- 70 (serving University District, Eastlake, Downtown Seattle): Add evening and Sunday service to replace 71-72-73 local service between University District and downtown Seattle.

#### Sheriff's Office reforms continued from front

The King County Council voted unanimously on October 9th to establish a new Office of Law Enforcement to examine complaints of misconduct filed against the sheriff's deputies. This office will also have the authority to review and analyze staffing and supervisory issues that may arise in the future.

The Blue Ribbon Panel's report included six major recommendations and 36 implementing actions. In the 2007 budget, over \$1.3 million was included to begin funding a number of these recommendations, with an additional \$1.5 million put into reserves for future implementation of additional recommendations

It is my belief that this office will help expand public trust in the ability of the County Sheriff to discipline those few officers involved in conduct or behavior serious enough to require disciplinary action.
