H. Res. 724, providing for consideration of the bill (H.R. 2095) to amend title 49, United States Code, to prevent railroad fatalities, injuries, and hazardous materials releases and to authorize the Federal Railroad Safety Administration (H. Rept. 110–371).

Moment of Silence: The House observed a moment of silence in honor of Joseph David Waggonner, Jr., former Member of Congress.

Committee Elections: The House agreed to H. Res. 722, electing the following Members to serve on certain standing committees of the House of Representatives: Committee on Armed Services: Representative Lamborn. Committee on Foreign Affairs: Representative Blunt, to rank after Representative Chabot.

National Affordable Housing Trust Fund Act of 2007: The House passed H.R. 2895, to establish the National Affordable Housing Trust Fund in the Treasury of the United States to provide for the construction, rehabilitation, and preservation of decent, safe, and affordable housing for low-income families, by a yea-and-nay vote of 264 yeas to 148 nays, Roll No. 958.

Pages H11410-14, H11415-46

Rejected the Musgrave motion to recommit the bill to the Committee on Financial Services with instructions to report the same back to the House promptly with amendments, by a recorded vote of 199 ayes to 218 noes, Roll No. 957. Pages H11443-45

Pursuant to the rule, the amendment in the nature of a substitute recommended by the Committee on Financial Services now printed in the bill shall be considered as an original bill for the purpose of amendment.

Frank (MA) amendment (No. 2 printed in H. Rept. 110–369) that adds additional flexibility to permitted fund uses by allowing a grantee to use up to 10% of their funds for project operating accounts to cover shortfalls for projects assisted with trust fund dollars in order to facilitate affordability for families below the SSI income limit; Pages H11431–32

Hastings (FL) amendment (No. 3 printed in H. Rept. 110–369) that amends the Affordable Housing Trust Fund homeownership counseling criteria to include flood or other disaster specific insurance in applicable regions;

Page H11432

Frank (MA) amendment (No. 4 printed in H. Rept. 110–369) that includes among the factors for consideration in selecting applicants to receive Trust Fund grant amounts a consideration of the extent to

which the design, construction, and operation of the housing reduces utility costs for residents;

Frank (MA) amendment (No. 5 printed in H. Rept. 110–369) that allows grantees to give preference to public employees, including first responders and teachers, who cannot afford to live in high-cost areas; these workers have to meet the income eligibility requirements stated in the text of H.R. 2895;

Frank (MA) amendment (No. 6 printed in H. Rept. 110–369) that directs the Secretary of Housing and Urban Development to establish an internet-based "Green Housing Clearinghouse" including best practices, technical recommendations and other informational material regarding green building techniques. Additionally, grantees would be required to self-certify how many of the total units they built with money from the national affordable housing trust fund were green;

Frank (MA) amendment (No. 7 printed in H. Rept. 110–369) that provides that, for the purpose of increasing accountability, previous grant recipients applying for new grants must include in their applications progress reports for projects for which they used funds in the previous fiscal year; and

Page H11434

Frank (MA) manager's amendment (No. 1 printed in H. Rept. 110-369) that establishes a state minimum allocation percentage, under which every state will receive at least one half of one percent (.5%) of the total funds available each year that are allocated to states, Indian Tribes, and insular areas. Allocations to all other states would be reduced pro rata to bring these states up to this .5% minimum. The amendment also provides that the local jurisdiction in each state that is slated to receive the largest amount by formula in such state would be entitled to receive such funds directly (notwithstanding the bill's provision that jurisdictions entitled to their state in any year that nationwide funding is less than \$2 billion). The amendment includes a technical clarification to ensure that the mixed income limitation capping the number of units initially rented to extremely low income families at 50% applies to all of the units in a project (not just those units assisted by trust fund dollars). The amendment provides that the exception to the mixed income rule applies to all "elderly only" projects, not just those projects of 25 or fewer units (by a recorded vote of 418 ayes to 2 noes, Roll No. 955). Neugebauer amendment in the nature of a substitute (No. 8 printed in H. Rept. 110–369) that sought to establish a National Affordable Housing Grant Fund program within the HOME program,

which is currently administered through the U.S. Department of Housing and Urban Development (by a recorded vote of 163 ayes to 257 noes, Roll No. 956).

Agreed that the Clerk be authorized to make technical and conforming changes to reflect the actions of the House.

H. Res. 720, the rule providing for consideration of the bill, was agreed to by a recorded vote of 224 ayes to 194 noes, Roll No. 952, after agreeing to order the previous question by a yea-and-nay vote of 223 yeas to 195 nays, Roll No. 951. Pages H11410-13

Tax Collection Responsibility Act of 2007: The House passed H.R. 3056, to amend the Internal Revenue Code of 1986 to repeal the authority of the Internal Revenue Service to use private debt collection companies, to delay implementation of withholding taxes on government contractors, and to revise the tax rules on expatriation, by a recorded vote of 232 ayes to 173 noes, Roll No. 960.

Rejected the Hulshof motion to recommit the bill to the Committee on Ways and Means with instructions to report the same back to the House promptly with an amendment, by a yea-and-nay vote of 196 yeas to 212 nays, Roll No. 959.

Pages H11462-64

Pursuant to the rule, the amendment in the nature of a substitute recommended by the Committee on Ways and Means now printed in the bill, modified by the amendment printed in H. Rept. 110–368, shall be considered as adopted. Page H11400

H. Res. 719, the rule providing for consideration of the bill, was agreed to by a yea-and-nay vote of 217 yeas to 198 nays, Roll No. 954, after agreeing to order the previous question by a yea-and-nay vote of 220 yeas to 198 nays, Roll No. 953.

FEDERAL RAILROAD SAFETY IMPROVEMENT ACT OF 2007

Committee on Rules: Granted, by a non-record vote, a structured rule providing 1 hour of general debate on H.R. 2095, Federal Railroad Safety Improvement Act of 2007, equally divided and controlled by the chairman and ranking minority member of the Committee on Transportation and Infrastructure.

The rule waives all points of order against consideration of the bill except those arising under clause 9 or 10 of rule XXI. The rule provides that the amendment in the nature of a substitute recommended by the Committee on Transportation and Infrastructure now printed in the bill shall be considered as an original bill for the purpose of amendment and shall be considered as read. The rule waives all points of order against the committee amendment except those arising under clause 10 of rule XXI.

The rule makes in order only those amendments printed in the Rules Committee report. Amendments so printed may be offered only in the order printed in the report, may be offered only by a Member designated in this report, shall be considered as read, shall be debatable for the time specified in this report equally divided and controlled by a proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question in the House or in the Committee of the Whole. The rule waives all points of order against such amendments except those arising under clause 9 or 10 of rule XXI.

The rule provides one motion to recommit H.R. 2095 with or without instructions. Finally, notwithstanding the operation of the previous question, the Chair may postpone further consideration of the bill to a time designated by the Speaker Chairman Oberstar and Representatives Ginny Brown-Waite, Napolitano, Gonzalez, Shuster and Rohrabacher.
