FLOOR SCHEDULE AND PROCEDURE

The House will convene at 12:30 p.m. for Morning Hour and 2:00 p.m. for legislative business. Votes will be postponed until 6:30 p.m.

Suspensions (7 bills):

- 1) H.R. 517** - To direct the Commandant of the Coast Guard to convey the Coast Guard Cutter BRAMBLE, upon its scheduled decommissioning, to the Port Huron Museum of Arts and History located in Port Huron, Michigan, for use for education and historical display (C.Miller - T&I).
- 2) H.R. 281** - To designate the Federal building and United States courthouse located at 200 West 2nd Street in Dayton, Ohio, as the 'Tony Hall Federal Building and United States Courthouse' (Hobson - T&I).
- 3) H.Con.Res. 128** - Authorizing the use of the Capitol Grounds for the D.C. Special Olympics Law Enforcement Torch Run (LaTourette - T&I).
- 4) H.R. 985** - To designate the facility of the United States Postal Service located at 111 West Washington Street in Bowling Green, Ohio, as the "Delbert L. Latta Post Office Building" (Gillmor - Gov't Reform).
- 5) H.Res. 178** - Honoring the life and work of former Speaker of the Pennsylvania House of Representatives Matthew J. Ryan and offering the deepest condolences of the United States House of Representatives to his wife and family on his death (C. Weldon - Gov't Reform).
- 6) H.Con.Res. 160** - Expressing the sense of Congress that the United Nations should remove the economic sanctions against Iraq completely and without condition (N.Smith - International Relations).
- 7) H.Res. 222** - Commending those individuals who contributed to the debris collection effort following the Space Shuttle Columbia accident (Hall - Science).

"This year's federal deficit should exceed \$300 billion - the largest ever - as the government's fiscal outlook grew grimmer thanks to surging defense spending and declining revenue, the Congressional Budget Office said. The budget office's figures do not reflect the tax bills Congress is debating. The House version, which would cost \$550 billion through 2013, is expected to add \$60 billion to this year's shortfall."
