Dear Ambassador Withers:

I have received your letter of July 11, 2008, and read with interest your comments in the Los Angeles Times.¹ Your letter requested an opportunity to meet, and I would welcome this opportunity.

In my letter to Secretary Rice on June 23, 2008, I requested that you appear voluntarily for a transcribed interview with the Committee staff to assist the Committee's inquiry. I ask that you inform the Committee staff by 5:00 p.m. on July 16, 2008, whether you will appear voluntarily for this interview. I also ask that you indicate by then whether you will provide the responsive documents in your possession to the Committee.

The Los Angeles Times article confirmed some key elements of the account that Major Larry D. Harrison provided the Committee. According to the Times, you have acknowledged that you had a late-night meeting with the Albanian defense minister on November 19, 2007; that there were discussions at this meeting about how to respond to a request by the New York Times to visit a site in Albania where a U.S. arms contractor, AEY, Inc., repackaged ammunition to remove its Chinese origins; and that at the meeting, the Albanian defense minister suggested in your presence removing the Chinese markings from the site before the visit by the New York Times reporter.

According to the *Los Angeles Times*, you dispute Major Harrison's assertion that you agreed with the defense minister's suggestion. You also said that you did not inform the Committee about this incident because the name of the arms dealer did not come up.
