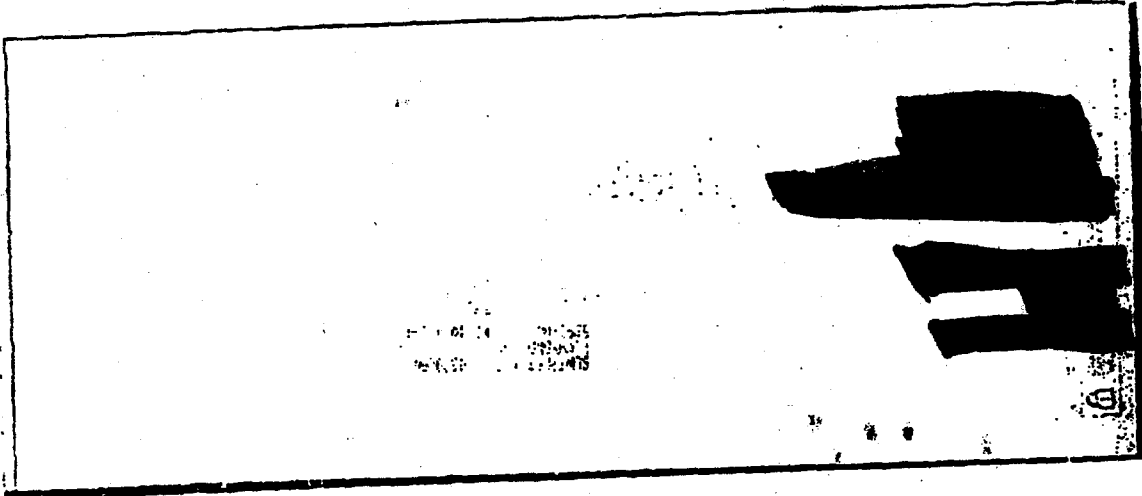

Fred Radewagon has been hanging around the territory issues for decades.

He

is part of the old Trust Territory group, which created the structure that eventually led the territories into their current socialist economic situation. Fred was the editor of a cynical and vicious monthly report about the territories, often making negative comments about our efforts in the CNMI (though sometimes giving us backhanded complements as well). His orientation is not in synch with what needs to be done in the territories (move them off dependency) and he is not well regarded in the islands because of his negative newsletter and the view that his cynicism toward economic development might be based in the all too familiar paternalism exhibited by many old 'trust territories' colonialist types.

We have been informed that Allen Stayman, Director of Compact Negotiations at the U.S. Department of State, may be retained in that position by the Bush Administration. The decision, we are told, will be made in the next 24

hours. For the reasons set forth below, we think Mr. Stayman's retention would be a serious mistake.

As you know, Mr. Stayman formerly headed the Office of Insular Affairs (OIA)

at the Department of the Interior. During an investigation of the OIA during Stayman's tenure, [REDACTED] found evidence that Stayman was aware of and participated in a campaign to conduct opposition research against House Republicans and to help their political opponents by using the Interior Department's official resources.

The Interior Department's Inspector General, Earl E. Devaney, testified on July 12, 2000 before the House Resources Committee that his investigation of OIA had uncovered the "most egregious example I've seen" in 30 years of law enforcement experience of official misconduct. Mr. Devaney testified that documents obtained during the investigation showed Mr. Stayman was aware of improper political activities, but no evidence that he ordered them stopped.

The improper activities Mr. Devaney enumerated included "partisan political activity", engaging "in a lobbying campaign", and "improperly" obtaining

and

disclosing information about Members of Congress and political opponents - all on official time and through the use of U.S. government equipment. Mr. Stayman also participated in these activities by signing some of the political communications drafted at OIA, approving a press release to be issued by a private corporation, and directing improper OIA activities like photographing a Republican Member of Congress in "social" settings unrelated to OIA.

This pattern of behavior calls into serious question his suitability to serve the Bush Administration in any capacity, but especially as the United States representative in negotiations that will affect a U.S. insular territory that was the target of these same improper practices.

I have copies of the Committee's report, the testimony of the Inspector General, and dozens of news clippings about the Stayman matter. I can send them to you should desire to review them.

In addition, it is worth noting that we were just recently made aware of a personal email that Mr. Stayman wrote to his former colleagues at the Interior Department. In it, he seems to take pleasure in the flap over Puerto Rico. Stayman wrote:

I had lunch with Farrow and he told me how badly Bush and messed this up. The White House was preparing to tell the Puerto Ricans to stuff it if they didn't want the U.S.

Navy, then they could have a vote on Statehood or Independence. But then Carl [sic] Rove advised that Jeb and Pataki needed Puerto Rican votes. The

rest is history.

Finally, a quick review of Mr. Stayman's contribution history shows that he has given thousands of dollars over the past several years to the DNC, DCCC, and Vice President Gore. The one Republican Mr. Stayman contributed to was Senator [REDACTED] during the GOP Presidential primaries.

We urge you to intercede and block the appointment of Mr. Stayman. Do not hesitate to contact me if you have any questions or require additional information.

Per our discussion I want to recommend Arnold H. Leibowitz, Esquire, for the position of Lead Negotiator for the Micronesian Compacts which will establish our future relations with the Republic of the Marshall Islands and

the Federated States of Micronesia (FSM).

Arnold has been active with respect to territorial matters since 1964 when he was General Counsel of the Status Commission on Puerto Rico. His book, *Defining Status: A Comprehensive Analysis of United States Territorial Relations* (Martinus Nijhoff 1989), is the leading reference book

in the field and has been cited by the United States Supreme Court.

Arnold has been an active negotiator for the territories and Commonwealths of the U.S. over the last 30 years and, therefore, has credibility in the islands and has knowledge of the issues. He has been

brought in by the Department of the Interior as a Consultant with respect to

the Compact negotiations and, therefore, is familiar with the issues from the U.S. point of view. In short, the learning curve will be very brief.

Some other elements of his background that is important to note. In addition to his former position as General Counsel to the Status Commission on Puerto Rico, he was one of the consultants hired by the Association of Pacific Island Legislatures to establish the Pacific Islands Development Bank. In this latter connection, he traveled throughout Micronesia with Tosiwo Nakayama, the former President of the FSM, visiting the heads of states of all the islands and Micronesia (Palau, FSM, Guam, Commonwealth of the Northern Mariana Islands and the Republic of the Marshall Islands.).

He

was Counsel to the Guam and Virgin Islands Constitutional Conventions. He is a Yale Law School graduate, selected for the Yale Law Journal, and a Phi Beta Kappa from Columbia.

Currently, he is an attorney in private practice specializing in refugee and

immigration law, including legislative and high-level Executive Branch representation and appellate litigation.

In addition to Arnold's territorial background, he has served as Special Counsel on the U.S. Senate Subcommittee on Immigration and Refugee Law where he was the primary draftsman of what became the Immigration Reform

and Control Act of 1986. He was appointed to the Special Counsel position by Alan Simpson. He worked for Senator Simpson for three years, from 1981-84, even though he was a Democrat and continued to be registered as such.

Similarly, Arnold was a non-career Democratic holdover who helped Secretary Maurice Stans establish the Office of Minority Business

Enterprise. Former HUD Secretary James Lynn and FTC Commissioner Calvin Colhane know his record in that connection.

As you know, the Lead Negotiator position is presently occupied by Al Stayman, who was appointed in the Clinton Administration. After Stayman's appointment, it came out that during his tenure as Director of the Office of International Affairs, he and a member of the staff were utilizing the office to assist Democratic Congressmen to unseat Republicans. I have worked with Arnold a number of years now in connection with the applicability of various federal laws to the Northern Marianas and have come to respect his legal knowledge in the field, his wit, and good judgment. I think you will too.

Sleazy politics

Sen. Frank Murkowski, Alaska Republican and ranking member of the Senate Energy and Natural Resources Committee, is furthering the Clinton legacy. To the dismay of his colleagues, he is backing Allen Stayman, a partisan Clinton bureaucrat, for a top post in the State Department. An investigation by the House Resources Committee underscores Mr. Stayman's unfitness for the job, and the outrageousness of Mr. Murkowski's support.

Rep. Don Young, former chairman of the House Resources Committee, recently completed his investigation of Mr. Stayman, who headed the Interior Department's Office of Insular Affairs (OIA) under Bill Clinton. Mr. Young's committee uncovered Mr. Stayman's campaign funded by taxpayers on government time against Republicans opposed to forcing federal labor laws on the Commonwealth of the Northern Marianas Islands (CNMI).

Earl Devaney, the Interior Department's inspector general, told the House Resources Committee last year that Mr. Stayman's behavior was the "most egregious . . . I've seen" in 30 years. Mr. Stayman's campaign was certainly unethical and probably illegal. Mr. Young accused him of violating the Hatch Act, which prohibits public employees from engaging in partisan politics, as well as the Anti-Federal Lobbying Act.

On March 14, Mr. Young urged Secretary of State Colin Powell in a letter to remove Mr. Stayman as director of the Office of Compact Negotiations, where he was transferred from OIA. "The clear import of the findings . . . is that Mr. Stayman . . . failed to end a wide range of prohibited political activities at OIA and the evidence suggests that he may have engaged in them himself."

Mr. Stayman also has been a loyal contributor to the Democratic Party.

In 1998, he gave four donations totaling \$1,400 to the Democratic National Committee. The following year, he gave \$500 to then-Vice President Al Gore.

Those disturbing realities never deterred Mr. Murkowski, who recommended Mr. Stayman to Mr. Powell in a March 21 letter. Mr. Stayman, he wrote, operates "in a frank and open manner" and "will be a valuable resource both to your administration as well as to those of us who will need to consider the product of your negotiations."

Mr. Murkowski's defense of Mr. Stayman is easily explained. Both are allied with powerful forces trying to straightjacket CNMI's free-market economy. A 1975 compact empowered CNMI, a U.S. territory, to control its labor and immigration laws. In 1997, Mr. Murkowski sought to change that.

He asked Mr. Stayman to craft legislation implementing the administration's anti-CNMI legislation, which imposed the minimum wage, worker safety regulations, limits on duty-free imports and restrictions on so-called "guest workers" from China and the Phillipines.

The Big Labor-Democratic coalition has vilified CNMI as a bastion of "slave labor" and sweatshop working conditions. But serious observers of CNMI including the New York Times have documented island workers enjoying reasonable wages and adequate workplaces. Indeed, Frank Strasheim, Occupational Safety and Hazard Administration Administrator, said the CNMI economy is "becoming a model for rest of the world" and was "impressed by commitment in placing the safety and health of their workers first."

Mr. Stayman, as director of OIA, was responsible for coordinating federal policy in U.S. territories, including the CNMI. He leveraged the power of that office to further a brazen political campaign to promote the administration's CNMI legislation. As the House Resources Committee found, several Republicans defending the status quo were targeted just before the 1998 elections.

Mr. Stayman facilitated efforts by OIA Political Director David North to defeat several pro-CNMI Republicans, including Rep. Dana Rohrabacher, Rep. Phil English, and Rep. Brian Bilbray. In a 1997 memo, Mr. North asked the Democratic Congressional Campaign Committee (DCCC) for negative information on House Majority Leader Dick Armey, Majority Whip Tom DeLay and other Republicans. "We have been asked for the names and phone numbers of the Democratic candidate for Congress in these districts if they have been identified for 1998."

Mr. North continued: "Some friends have asked for this information because the incumbents have been giving the Clinton Administration a hard time over its efforts to reform sweatshops and trade law evasions."

Mr. North, working on government time, also drafted press releases for their Democratic challengers. In a memo to Mr. Bilbray's opponent, Christine Kehoe, he wrote: "My motivations are: to elect Democrats to the House and to punish the handful of obvious GOP sweatshop allies."

Mr. Stayman never intervened to stop Mr. North. In fact, he was an eager participant. At taxpayer expense, he hired private investigators and "human rights activists" to propagate bogus claims that CNMI practiced forced abortions, religious persecution and prostitution. During a Senate Governmental Affairs hearing, former Sen. Rod Grams, Minnesota Republican, questioned Mr. Stayman about his dealings, but got no answers. Instead, Mr. Stayman publicly threatened Mr. Grams outside the hearing room.

He even attacked CNMI's Democratic governor, Froilan Tenorio. The DCCC, he wrote, should "repudiate" Mr. Tenorio for blocking Administration efforts to federalize the islands. He chastised Mr. Tenorio for "scorning our

'president" and "playing footsie with the Republican house leadership, and who should be repudiated in writing by the nation's Democrats." "Those of us who are political here at Interior want the Democratic National Committee to repudiate those scoundrels," he wrote.

Mr. Murkowski has vowed to push the Clinton-backed CNMI legislation through the Energy and Natural Resources Committee. The bill, among other things, provides for a federal takeover of the local immigration authority, which, as Mr. Murkowski himself admitted, would mean "the end of the garment industry in the Marianas."

Also, if Mr. Murkowski has his way, Mr. Stayman will be rewarded with employment at the State Department, where he can continue his partisan crusades. That's too bad: Mr. Stayman epitomizes the sleazy politics of the Clinton era. His presence is an affront to Republicans and the high ideals of the Bush administration.

We have been informed that Allen Stayman, Director of Compact Negotiations at the U.S. Department of State, may be retained in that position by the Bush Administration. The decision, we are told, will be made in the next 24

hours. For the reasons set forth below, we think Mr. Stayman's retention would be a serious mistake.

As you know, Mr. Stayman formerly headed the Office of Insular Affairs (OIA)

at the Department of the Interior. During an investigation of the OIA during Stayman's tenure, [REDACTED] found evidence that Stayman was aware of and participated in a campaign to conduct

opposition research against House Republicans and to help their political opponents by using the Interior Department's official resources.

The Interior Department's Inspector General, Earl E. Devaney, testified on July 12, 2000 before the House Resources Committee that his investigation of OIA had uncovered the "most egregious example I've seen" in 30 years of law enforcement experience of official misconduct. Mr. Devaney testified that documents obtained during the investigation showed Mr. Stayman was aware of improper political activities, but no evidence that he ordered them stopped.

The improper activities Mr. Devaney enumerated included "partisan political activity", engaging "in a lobbying campaign", and "improperly" obtaining and disclosing information about Members of Congress and political opponents - all on official time and through the use of U.S. government equipment. Mr. Stayman also participated in these activities by signing some of the political communications drafted at OIA, approving a press release to be issued by a private corporation, and directing improper OIA activities like photographing a Republican Member of Congress in "social" settings unrelated to OIA.

This pattern of behavior calls into serious question his suitability to serve the Bush Administration in any capacity, but especially as the United States representative in negotiations that will affect a U.S. insular territory that was the target of these same improper practices.

I have copies of the Committee's report, the testimony of the Inspector General, and dozens of news clippings about the Stayman matter. I can send

them to you should desire to review them.

In addition, it is worth noting that we were just recently made aware of a personal email that Mr. Stayman wrote to his former colleagues at the Interior Department. In it, he seems to take pleasure in the flap over Puerto Rico. Stayman wrote:

I had lunch with Farrow and he told me how badly Bush and messed this up. The White

House was preparing to tell the Puerto Ricans to stuff it if they didn't want the U.S.

Navy, then they could have a vote on Statehood or Independence. But then Carl [sic]

Rove advised that Jeb and Pataki needed Puerto Rican votes. The rest is history.

Finally, a quick review of Mr. Stayman's contribution history shows that he has given thousands of dollars over the past several years to the DNC, DCCC, and Vice President Gore. The one Republican Mr. Stayman contributed to was Senator [REDACTED] during the GOP Presidential primaries.

We urge you to intercede and block the appointment of Mr. Stayman. Do not hesitate to contact me if you have any questions or require additional information.
