Dear Mr. Chairman:

When we met on May 10, 2007, the Council on Environmental Quality (CEQ) was withholding approximately 500 documents that were responsive to the Committee's July 2006 request. At that meeting, we explained that CEQ had two basic options for each of the documents: provide the document to the Committee or assert executive privilege with respect to the document.

During the meeting and in a June 28 letter, we offered, as an accommodation to your concerns, to have Committee staff review the documents to assess whether the documents would be necessary for the Committee's investigation. This process, which you elected to pursue, has been constructive. Committee staff has since reviewed a significant number of the withheld documents and has determined that many of them are unnecessary for the investigation. Of the documents that the staff reviewed, we are requesting that you provide 56 documents to the Committee. These 56 documents, which are identified in the enclosed list, are necessary for the investigation. We ask you to provide complete, unredacted copies of these documents to the Committee by Tuesday, July 31, 2007.

On July 20, 2007, CEQ briefed Committee staff on the reasons why CEQ is continuing to withhold and not provide for staff review approximately 175 documents from the Committee. As Committee staff explained at the time, the briefing did not resolve the issues surrounding these documents. Marty Hall, your Chief of Staff, has requested that we meet with you again to discuss how access can be provided to these remaining documents. We believe we made CEQ's options clear at our meeting on May 10, 2007, but we are willing to meet again with you. We should ensure that this meeting occurs prior to Congress' August recess.
