Dear Alexandra:

Thank you for your November 12, 2002 request for the names of the four chemicals used as the basis for the \$8.8 billion figure number cited in the nonpaper. That number, which reflects the value of certain U.S. exports made from certain chemicals that could apparently be on the EU authorization list under the proposed REACH scheme, was derived from a draft American Chemical Council study (attached below), and considered the following chemicals: Acrylonitrile, Propylene oxide, 1,3-Butadiene, Phenol.

I hope this is helpful.
