The Contractor will provide planning services to complete the development of the SE Louisiana Catastrophic Hurricane Plan. This work will be integrated and coordinated closely with the plan products produced under Task Order 001, specifically the Hurricane Pam Exercise and follow-on exercises/workshops.

There are two main tasks to be performed:

1. Completion of a Basic Plan framework and content to overlay the functional plans developed as a result of Task Order 1; and
2. Development of Emergency Support Function (ESF) Annexes for ESFs 1-12 and Support Function Annexes.

The Basic Plan framework and content development will be based on the format and content of the Federal Response Plan (FRP), as well as information gained during execution of Task Order 001 regarding the overarching Federal, State, and Local Concept of Operations, Concept of Logistical Support, and Roles and Responsibilities of various agencies during a catastrophic hurricane event in Louisiana. The ESF Annexes and Support Annexes will be developed by extracting role, responsibility and task information from the products of the catastrophic hurricane exercises and planning workshops conducted in Louisiana already and those that are in the planning stage. The FRP format will be utilized for these annexes as well.
