# Jay Hein Meets with Leaders from the Charitable Sector

On February 8<sup>th</sup>, Director Jay Hein spoke to CEOs of national nonprofits at a meeting hosted by Independent Sector. Led by Diana Aviv, Independent Sector is a coalition of charities, foundations, and corporate giving programs working to advance the common good by leading, strengthening, and mobilizing the charitable community. Director Hein shared information about the Administration's compassion agenda and outlined his vision for the White House Office of

Faith-Based and Community Initiative for the coming two years.

Organizations in attendance included the National Council of Nonprofit Associations, YMCA of the USA, Youth Service America, American Red Cross, Habitat for Humanity, the Corporation for National and Community Service, Alliance for Children, Catholic Charities and the Islamic Society of North America.

# Reentry and Recidivism Symposium in Ohio

The Institute for Excellence in Justice, a partnership between the Criminal Justice Research Center at Ohio State University and the Ohio Department of Rehabilitation and



Correction, hosted the *Faith-Based Programming, Reentry, and Recidivism Symposium* in London, Ohio, on February 9<sup>th</sup>. Steven McFarland, Director of the U.S. Department of Justice's Task Force for Faith-Based and Community Initiatives, delivered the keynote address to 175 attendees from faithbased and community organizations on the essential role that private voluntary groups play in rehabilitating offenders. The symposium aimed to facilitate an ongoing dialogue between research, faith, and corrections communities. Workshop presenters discussed the impact of faith-based programming on crime prevention and pro-social behavior, Federal funding for reentry, as well as the legal issues surrounding faith-based programming and collaborations.

## Earned Income Tax Credit Resource Toolkit

Organizations partnering with the Internal Revenue Service (IRS) to provide free tax assistance to the public now have a new resource to assist them in their work. On February 1<sup>st</sup>, the IRS sponsored an Earned Income Tax Credit (EITC) Awareness Day and announced the availability of an EITC resource

toolkit. EITC is a tax benefit for people who work, but do not earn a high income. People who qualify for EITC may pay less or no Federal tax. The IRS toolkit provides useful information on EITC rules and qualifications. It also includes tips on completing returns, holding successful events, and more. Community organizations can utilize the toolkit to help inform eligible workers about the tax credits, motivate them to file their tax returns and connect them to free tax filing assistance.

and unemployed residents within Tacoma-Pierce County. The St. Patrick Center, located in St. Louis, Missouri, received a Department of Commerce EDA award for Excellence in Economic Development in the category of Community Faith-Based and Social Entrepreneurship.

### Food Stamp Outreach Grants

On December 11<sup>th</sup>, Secretary Mike Johanns of the U.S. Department of Agriculture (USDA) awarded nearly \$1 million to 14 faith-based and community organizations for their efforts to improve access to, and awareness of, USDA's Food Stamp Program for eligible low-income households. The Food Stamp Program, administered by USDA's Food and Nutrition Service, is the cornerstone of Federal nutrition assistance programs and provides crucial support to working poor and needy households.

"The Administration is committed to ensuring that people who are eligible for food stamps can access benefits with dignity and respect," said Secretary Johanns. "Faith-based and community organizations are uniquely positioned to help us reach those in need with information about this critical nutrition safety net." The majority of the Food Stamp grantees will work



with senior service programs, food banks or food pantries, healthcare providers, housing programs, and other faithbased and community organizations in order to

customize outreach to the needs of the targeted community.
