
# King County Councilmember Kathy Lambert District 3 Spring 2006

Thank you to all of you who participated in my recent Town Hall meetings in North Bend, Issaquah and Sammamish. I appreciate your input on the topics important to our communities.

In my new role as Policy Chair for Human Services, I will be focusing on affordable housing and hosting a Housing Availability Summit this spring. As Vice Chair of the Operating Budget Committee, I will be looking at more ways to be proactive in controlling criminal justice expenses, which use nearly three-quarters of the operating budget. Our work this year also includes efficiently prioritizing the Veterans and Human Services Levy funding that voters so generously approved last November.

Although my new district is the largest in the county, I aim to visit every community as frequently as possible. I serve on many committees and boards with meetings throughout the county and in Olympia. With so much happening in our district, I try to use time on the road productively with two cell phones (hands-free), to remain accessible between events and meetings!

More changes are coming to elections following the numerous problems revealed during the 2004 governor's race. Here are a couple of changes to watch for:


Earlier Primary: The state Legislature moved the primary election four weeks earlier, to the third Tuesday in August, starting in 2007.

All-Mail Elections? The County Council soon will consider a proposal to make all elections vote-by-mail only, as 70% of our voters already vote this way. However, as a poll voter myself, I have some concerns. Public hearings will be conducted.

#### **Annexations on the Eastside**

King County's Annexation Initiative moves toward having the county provide regional services while counting on cities to provide local services.

It was a pleasure for me to join Issaquah officials on March 1 for an Open House, welcoming the residents of South Cove and Greenwood Point to Issaquah. Last November, the residents of these communities voted overwhelmingly to annex into Issaquah.

Meanwhile, the Klahanie potential annexation area remains in unincorporated King County. Although public support for annexation remains strong, the main concern is responsibility for the Phase III improvements to Issaquah-Fall City Road. I am working with the Executive, the cities of Issaquah and Sammamish, the Issaquah School District, and the Roads Division to solve traffic congestion problems along this road. We also are working on pedestrian safety concerns for the students attending the new Pacific Cascade freshman campus.

#### **New consumer protection law**

As a member of the Legislative Steering Committee and a former state legislator, I continue to follow the work being done in Olympia. I am proud to report that a new consumer protection law was passed this session. Senator Bill Finkbeiner's bill makes it a felony to sell private cell phone and telephone numbers and records to a third party without the owner's permission. I brought this issue to his attention, and I appreciate his successful work on this bill.

On March 27, I had the honor to congratulate the members of the Eastside 70s, a senior softball team that won this year's Men's 70-plus AA Division of the Senior Softball World Championships in Phoenix, Arizona. Team captain Don Newman and seven other team members, aged 70 to 76, joined me for an official recognition from the King County Council. # New park & rides

Two new park-and-ride facilities offer additional commuting options in the I-90 corridor. In February, a 1,000-stall parking garage opened at Issaquah Highlands, providing new express bus service to Seattle as well as local service. In March, a 265-stall parking lot opened in Sammamish at 228th SE and Issaquah-Pine Lake Road. The new facility and bus shelter celebrates the art of native Salish basketry and incorporates a sophisticated bioswale filtration system to improve the quality of surface water runoff before it reaches nearby Pine Lake. Metro routes 216, 269, and 927 serve this new South Sammamish Park & Ride.

#### **East Lake Sammamish Trail**

The center link of the East Lake Sammamish Trail has opened just in time for spring outdoor recreation opportunities. The center section connects regional trails running from Issaquah all the way to Ballard in Seattle. I hope you enjoy this remarkable new recreational amenity, but we all need to be respectful of adjacent, private property owners. For more information about the trail, please call 206-296-8687.

I recently was appointed to serve on the Lake Sammamish State Park Advisory Committee.
