DEPARTMENTS OF HEALTH AND PUBLIC SAFETY BUILDING SUFFERS POWER LOSS

HONOLULU - The state building at 919 Ala Moana Boulevard suffered a power loss Monday afternoon, October 9, 2006. Last night, state engineers determined that the building transformer needs replacement. The public is advised that business with the Department of Health and Department of Public Safety offices in that building may be temporarily disrupted.

Employees who work in the building will not have access to mail, e-mail or voicemail messages.

Meetings scheduled for today or tomorrow will not be held in the building. Anyone who has an appointment scheduled for today or tomorrow should try to call the appropriate programs to reschedule the meeting or to make alternative arrangements. Telephone service is still operable.

Departmental staff members are making other arrangements to carry on work as best they can until power is restored.

The state is working to restore power as soon as possible and will notify the public when it is restored.
