SDWB PRESENTS AWARDS TO STATE SCIENCE FAIR WINNERS FOR GROUNDWATER or DRINKING WATER PROJECTS

As part of our continuing effort to promote ground water and drinking water in the Hawaii Education System, the Department of Health, Safe Drinking Water Branch participated in the 49th Annual Hawaii State Science Fair held April 3-5, 2006 at the Neal Blaisdell Center Exhibition Hall. One of the key elements to a successful ground water and drinking water program is the education and awareness of the public. One of the best ways to educate the public is by educating students about our water resources. NOTICE OF PUBLIC PARTICIPATION AND INPUT ON THE PROPOSED DRINKING WATER TREATMENT REVOLVING LOAN INTENTED USE PLAN FOR THIS FISCAL YEAR

Notice of Public Participation and Input on the Proposed Drinking Water Treatment Revolving Loan Fund Intended Use Plan for the State of Hawaii Fiscal Year 2007 and the Federal Fiscal Year 2006 Appropriation

The State of Hawaii Drinking Water Treatment Revolving Loan Fund, also known as the Drinking Water State Revolving Fund (DWSRF), is required to develop an Intended Use Plan each year as part of the U.S. Environmental Protection Agency's (EPA)- DWSRF grant requirements. EPA grants monies to the State of Hawaii annually to construct drinking water infrastructure and support other drinking water programs.

For State Fiscal Year 2007, the Hawaii DWSRF program expects to receive approximately \$8,352,500 in Federal Funds. The Intended Use Plan explains how the new and existing funds will be used towards construction projects on the Priority List of Projects and towards other activities that support drinking water branch activities.

On April 3, 2006, the Drinking Water State Revolving Fund (DWSRF) program will publish a public notice statewide in the Honolulu Star Bulletin, the Hawaii Tribune-Herald, the West Hawaii Today, The Maui News, and The Garden Isle newspapers. The public notice period will be open from **April 3, 2006** - **May 5, 2006** in which the program will accept comments. Upon written request, a public hearing may be scheduled. All comments and/or requests for a public hearing must be received by the Safe Drinking Water Branch by **May 5, 2006**.
