#### SDWB STAFF RECEIVES DEPARTMENT OF HEALTH PERFORMANCE AWARD

On June 7, 2007 at the Hawaii Department of Health's 2007 Incentive and Service Awards Ceremony held at the State Capitol Auditorium, Daniel Chang of the Safe Drinking Water Branch's Monitoring Section was one of 25 individuals presented with a Sustained Superior Performance Award.

#### SDWB ADDS NEW STAFF TO MONITORING SECTION

On May 1, 2007, Steven Matsuda joined the Safe Drinking Water Branch, Monitoring Section as an Environmental Health Specialist. Mr. Matsuda comes to the SDWB after 18+ years as a Pesticides Specialist with the Hawaii Department of Agriculture, Pesticides Program (including working on the Pesticides in Groundwater Project). At the SDWB, Steven is currently learning the sampling sites and sampling procedures for drinking water monitoring and will also be assisting with the Groundwater Monitoring Program. The SDWB staff welcomes Steven, who we feel will be a great asset to the Branch.

#### **AUTHORITY**

- ✓ Definition of pesticide is broad, includes everything from bear repellants to disinfectants.
- ✓ Chlorine is used to disinfect wastewater and drinking water.
- ✓ Chlorine meets the criteria for restricted-use classification because of its corrosivity

#### WHAT WILL "RESTRICTED-USE" MEAN?

- ✓ The use and distribution of chlorine gas will be monitored by the Department of Agriculture.
- ✓ Dealers must furnish Department of Agriculture with records of distribution and may only be distributed to a certified applicator in the specified category. Records of use must be kept for 2 years.

#### **HOW DO I BECOME CERTIFIED?**

The Pesticides Program offers certification tests regularly throughout the State. Staff is present on Oahu, Hawaii and Maui Kauai is serviced from Oahu. Oahu (973-9424 or 973-9409), Hawaii (974-4142), and Maui (873-3555). The examination fee will be \$25.00.

- ✓ You must pass the written test with a score of 70% or more.
- ✓ You will be notified of the test results, and if you are notified that you passed, you will be issued a certification card that is valid for 5 years. You must bring in a current photo or have your picture taken by DOA for your certification card and a certification fee of \$50 will be charged.

#### **HOW DO I MAINTAIN CERTIFICATION?**

- ✓ You may renew your certification by taking 20 hours of classes related to the safe use of chlorine gas and general information about pesticide safety and use.
- ✓ The University of Hawaii also publishes quarterly newsletters that offer opportunities to earn recertification credits by passing comprehension quizzes on some of the newsletter's articles.

#### WHAT RECORDS MUST BE KEPT?

- **✓** Brand of pesticide
- ✔ EPA Registration Number
- ✓ Type of formulation
- ✓ % active ingredient
- ✓ Name of pest
- ✔ Dilution rate

- ✓ Total amount used
- ✓ Time and date of application
- ✓ Site address
- ✓ Name of certified applicator and his/her certification number.
- ✓ Type of use

#### RESPONSIBILITIES

- ✓ Dealers are responsible for selling and distributing restricted pesticides only to certified applicators.
- ✓ Certified applicators are responsible for using the pesticide in accordance with label directions and keeping records.
- ✓ Applicators must report changes in applicator information to the Department of Agriculture within 30 days after change.

#### WHO MUST BE CERTIFIED

- ✓ Applicators of restricted-use pesticides must be certified.
- Certified applicators may have competent workers apply pesticides under their instructions and control as long as the certified applicator is available when needed (provided the label does not prohibit use by others).
- ✓ Certified applicator is responsible for the acts of workers under his/her supervision.

#### POTENTIAL CHLORINE GAS APPLICATORS

- ✓ Wastewater treatment plant operators
- ✓ Drinking Water treatment operators
- ✓ Non-residential swimming pool caretakers
- ✔ Workers disinfecting wash water for food handling premises and equipment and raw agricultural commodities
- ✓ Cooling tower water treatment operators

#### To All Chlorine Gas Users:

The Hawaii Department of Agriculture (HDOA) is authorized by the United States Environmental Protection Agency to certify applicators of restricted use pesticides. Chapter 149A of the Hawaii Revised Statutes defines a pesticide as "any substance or mixture of substances intended for preventing, destroying, repelling, attracting, or mitigating any pest..." The Hawaii Pesticides Law further requires that restricted use pesticides be applied by a certified applicator or under the certified applicator's direct supervision.

Chlorine gas is an extremely hazardous pesticide that may cause significant injury. Restricted-use classification provides a means to restrict sales and use to only those applicators who have shown competency by passing the written certification examinations. The Hawaii Administrative Rules, Title 4, Chapter 66 was amended to classify chlorine, in its gaseous form, as a restricted use pesticide, effective January 1, 2008. Therefore, all users of chlorine gas or those providing direct supervision of its use must be certified by HDOA under Commercial Category 7F - Chlorine Gas Application by January 1, 2008.

This measure is needed to provide essential regulatory controls to track the distribution, storage, and use of chlorine gas. ## MAY WAS HURRICANE PREPAREDNESS MONTH - JUNE STARTS HURRICANE SEASON "Are You Prepared?"

Are you ready? Hawaii's Hurricane Season spans from June through November. During this period, Hawaii is at an increased risk of being hit by tropic storms or hurricanes. Hurricanes not only bring high winds and heavy rains, they can also cause flooding and damaging surf. The Department of Health reminds everyone to be prepared:

- Have a personal/family emergency plan. Make sure that each family member knows what to do and where to go in case of emergency.
- Have an emergency supplies kit. For helpful guidelines on assembling an emergency supply kit, refer to the DOH publication, "Plan to Be Ready: *The Hawaii Family Guide to Health Emergencies*," available for download from the DOH website or call the Communications Office at 586-4442 for printed copies.

**WATCH:** According to Hawaii State Civil Defense, a Hurricane WATCH means a hurricane may strike within 36 hours. During a Watch, listen to radio or television broadcasts for instructions.

**WARNING:** A Hurricane WARNING is issued when a hurricane is expected within 24 hours or less. When a Warning is issued, sirens will sound. Continue listening for instructions via television or radio. Be prepared to evacuate to a designated public shelter, unless your home has a "Safe Room" in which you're able to securely shelter in place until the storm has passsed. See the "Disaster Preparedness Guide" at the front of your telephone book's white pages for more hurricane preparedness tips.
