## SDWB Staff Recognized with DOH Sustained Superior Performance Award

On July 18, 2008 at the Hawaii Department of Health's 2008 Incentive and Service Awards Ceremony held at the State Capitol Auditorium, David Kawahara, Steven Matsuda, and Theresa Takiue of the Safe Drinking Water Branch's Monitoring Section were among the Department of Health employees presented with a Sustained Superior Performance Award.



**David** was presented this award based on his work performance of his duties which include preparing monitoring schedules and forms, conducting drinking water monitoring, and drinking water sample tracking.

Over the years, David has gained extensive knowledge of drinking water requirements and has utilize that to initiate and develop a database system that determines and manages a water system's compliance sampling requirements and schedule for the three (3) year monitoring compliance period. In addition, he has also initiated the creation/development of programs which

will allow (1) monitoring staff to electronically enter and track

samples that have been collected and submitted to the laboratory for analyses, and (2) samplers to access and download drinking water sampling forms electronically via the Internet. These systems have been instrumental in improving the drinking water monitoring program by being capable of better informing water systems of their monitoring requirements, making sampling forms/documents more readily accessible to the water systems, and allows for better tracking of samples. David's work has been key to the success of our monitoring program and he is most deserving of the Sustained Superior Performance Award.

**Steven** was presented this award based on his work performance of his duties which include conducting drinking water monitoring, drinking water sample tracking, and data management activities. In addition to monitoring section activities that he is assigned, Steven has made improvements to our monitoring program by improving the working relationship of staff and with the water systems and the development of new data handling processes/systems.

Through Steven's efforts, drinking water - chemical monitoring results are no longer sent to the water systems through paper copies but electronically. Water systems now receive their monitoring data via email, resulting in a significant reduction in paper copies, elimination of redundant filing of copies and the potential for missing file copies, and has made data dissemination more efficient and consistent.

These activities have been instrumental in improving the drinking water monitoring program and Steven's work has been key to the success of our monitoring program and he is most deserving of the Sustained Superior Performance Award.



**Theresa** was presented this award based on the work performance of her duties which include conducting drinking water monitoring, reviewing of plans, responding to investigations and complaints, and dealing with the public.

Not being afraid to use new methods and technology to accomplish her work has resulted in her being one of the first Neighbor Island staff in the Safe Drinking Water Branch to utilize Geographic Information System (GIS) technology in her work. Using GIS to assist in plan

reviews have cut down on the time required to complete each review. Additional, her willingness to work hard and learn new things have lead to many of the SDWB's monitoring program improvement activities being tested in her work area and the conducting of several special monitoring studies in East Hawaii.

Through her own initiative, she has made major efforts to conduct public education and outreach activities to further the awareness of safe drinking water. Over the past years, Ms. Takiue has participated in the Annual Hawaii County Fair (to disseminate drinking water information), Kamehameha Schools' Career Shadowing Program (in working with high school students interested in water quality careers), and through school presentations and contact with students and teachers. Ms. Takiue is currently working with the University of Hawaii at Hilo's Summer Enrichment Program in educating elementary school students about water quality issues.

Finally, her responsiveness to investigations and complaints and being cordial and thorough when dealing with these matters, as well as her willingness to volunteer and participate in other DOH activities such as the "statewide school immunization program" are further examples that exemplifies her commitment to the true meaning of "public service." She is most deserving of the Sustained Superior Performance Award.

#### COMMISSION ON WATER RESOURCE MANAGEMENT - WATER RESOURCE PROTECTION PLAN

On August 28, 2008, the staff of the Commission on Water Resource Management submitted a recommendation to adopt the updated Water Resource Protection Plan (WRPP), at the Commission's meeting on Oahu. The updated Water Resource Protection Plan (WRPP) is available in the Commission on Water Resource Management's website at http://hawaii.gov/dlnr/cwrm/planning wrpp.htm

The WRPP is one of the five components of the Hawaii Water Plan. The other component plans are the Water Quality Plan, State Water Projects Plan, Agricultural Water Use and Development Plan, and County Water Use and Development Plans. The other four component plan are to be prepared by other agencies, as specified in the State Water Code. The Hawaii Department of Health is responsible for preparing the Water Quality Plan.
