2006 New Freedom Initiative Awards

WASHINGTON — Labor Secretary Elaine L. Chao today called upon non-profits, small businesses, corporations and individuals that have demonstrated exemplary and innovative efforts to improve the employment and workplace environment of people with disabilities to submit their entries for the 2006 "Secretary of Labor's New Freedom Initiative (NFI) Award." This will be the fifth anniversary of the NFI awards, which so far have been presented to 13 companies, 13 non-profits and 4 individuals.

"President Bush and I are committed to advancing employment opportunities for workers with disabilities," said Secretary of Labor Elaine L. Chao. "The *New Freedom Initiative* Awards recognize individuals, nonprofit organizations and private sector companies that have improved the employment prospects for people with disabilities."

The award recognizes public-private partnerships and programs that have had a positive impact on the employment of people with disabilities through access to assistive technologies, the use of innovative training, and hiring and retention strategies. It also recognizes organizations, businesses and individuals who develop comprehensive strategies to enhance the ability of Americans with disabilities to enter and advance in the 21st century workforce.

REGION 3

Gulfstream to Add 1,100 Jobs in Savannah, Georgia Gulfstream plans a \$300 million expansion of its corporate jet plant in Savannah, a project that will add 1,100 jobs over the next seven years.

INC Research Will Add 100 Jobs in Raleigh, North Carolina_INC Research is about to outgrow its corporate headquarters as it adds 100 jobs by the end of the year. The new positions in Raleigh will cover a range of skills, including biostatistics and data management.

Georgia Lands KIA Auto Plant South Korean automaker Kia Motors Corp. will open a \$1.2 billion plant in Georgia, creating almost 5,500 new jobs in the state. Cars will begin rolling off the plant's two assembly lines in August 2008.

Call Center Firm PRC Adds Jobs in Tampa, Florida Fort Lauderdale call center operator PRC is expanding into Tampa, creating 175 jobs at a division which assists large corporations with sales and marketing.

REGION 4

Spirit Aerosystems - An increase in orders for Boeing airplanes means additional jobs in Oklahoma. Spirit

Aerosystems, a supplier of wing components to Boeing, expects to add 200 to 300 jobs in the next year to the meet the

demand for new Boeing airplanes. Spirit employs about 1,300 people at manufacturing plants in Tulsa and McAlester. The Chicago-based company expects to deliver 395 airliners this year, a 36 percent increase over last year. Wing

components on each of those planes will be assembled in a Spirit facility in Oklahoma. Other aerospace companies in the Tulsa area also stand to benefit from Spirit's windfall of work.

REGION 5

Michigan Governor Jennifer M. Granholm announced the appointment of Paula D. Cunningham to succeed David Hollister as director of the Department of Labor and Economic Growth (DLEG). As director of DLEG, Cunningham will be responsible for furthering Granholm's economic plan, which will include enhancing the states job training efforts. The department she will lead is already involved in workforce development programs, including Regional

Skills Alliances and the MiOpportunity Partnership.

Portable Practical Education Preparation Inc. (PPEP) and the Arizona Interagency Farmworker Coalition (AIFC) are spearheading an effort with Larsen Assistance Services to provide an ?official? count of Migrant and Seasonal Farmworkers (MSFWs). The Arizona study will help

develop profiles of MSFWs for every county in the State. The effort is modeled on research completed in 2000 for the U.S. Public Health Service, Office of Migrant Health and similar studies conducted in Oregon and Idaho. The survey will be instrumental in helping service providers plan, set policy, fund decisions, and advocate on behalf of agricultural workers and MSFWs

HUD Publishes Application Requirements and Submission Deadlines for 39 Programs

In the <u>January 20 Federal Register</u>, the Department of Housing and Urban Development (HUD) published its Notice of Fiscal Year 2006 Notice of Funding Availability Policy Requirements and General Section to the SuperNOFA (General Section). HUD announced it was publishing the General Section of the FY2006

SuperNOFA in advance of the individual NOFAs in order to give prospective applicants sufficient time to begin preparing their applications, and to register early with **Grants.gov** to facilitate their application submission process. In the March 8 Federal Register, HUD has published information on the 39 funding opportunities that constitute HUD's FY2006 SuperNOFA.

HUD notes that the key dates that apply to all federal financial assistance made available through HUD's FY2006 SuperNOFA are found in each individual program NOFA and in Appendix A.

HUD indicates that approximately \$46,035,000 in funding is made available for the FY 2006 **Youthbuild** NOFA, which includes any carry over from previous appropriated funds plus any FY 2006 funds appropriated by Congress, plus any funds available through recapture, minus any amount needed to correct errors.

Participants in a Youthbuild program must be very low-income high school dropouts between the ages of 16 and 24, inclusive, at the time of enrollment. Up to 25 percent of participants may be above very low-income, or may be high school graduates (or equivalent), but must have educational needs (such as lack of reading, writing, and communication skills) that justify their participation in the program. HUD reminds prospective applicants that "Youthbuild grantees are mandatory partners in

one-stop centers authorized by the Workforce Investment Act of 1998."

The SuperNOFA also contains application information on other economic development programs (Brownfields Economic **Development Initiative and Rural** Housing & Economic Development) as well as the McKinney-Vento Homeless Assistance Programs. HUD provides funding information for its University and College Programs (HBCU, HSIAC, AN/NHIAC and TCUP), noting the potential use of funding for economic development and hurricane recovery. HUD has also identified \$59,4000,000 in funding under the Indian **Community Development Block Grant Program**. HUD also outlines its community development technical assistance plans and grant opportunities. FY 2006 SuperNOFA for HUD's Discretionary Programs (PDF format; note 359 pages in length).

RESEARCH AND RECENT PUBLICATION

Report Published on "Size and Characteristics of the Unauthorized Migrant Population in the United States"

An analysis based on the March 2005 Current Population Survey shows that there were 11.1 million unauthorized in the United States a year ago. The <u>report</u> written by Jeffrey S. Passel, Senior Research Associate of the Pew Hispanic Center indicates that about 7.2 million of the unauthorized migrants were employed in March 2005, accounting for about 4.9% of the civilian labor force. Unauthorized immigrants make up a large share of all workers in the following occupational categories, including 24% of all workers employed in agriculture, 17% in cleaning, 14% in construction and 12% in food preparation.

Issue Brief on Innovative State Policy Options to Promote Rural Economic Development published by Center for Best Practices, National Governors Association While not new, the Center for Best Practices at the National Governors Association published an issue brief in February 2003 to promote rural economic development. Three promising strategies identified include:

Adapt cluster-based principles
