## Dear Interested Reader:

I would like to notify you that I signed the Decision Notice and Finding of No Significant Impact (DN/FONSI) for the *Travel Management on the Sandia Ranger District* project on the Sandia Ranger District in Bernalillo and Sandoval Counties, New Mexico on July 10, 2008. I selected Alternative 4 with modifications for implementation.

This decision designates a system of roads and trails for public access and motorized recreation travel. This decision prohibits motorized cross county travel off of the designated system on the Sandia Ranger District. There are 42.66 miles designated for motorcycle use, 1.76 miles designated for vehicles under 50" (ATVs and motorcycles) and 10.12 miles open to all vehicles (including OHVs.) There are also 7.02 miles designated for highway legal vehicles only. The decision approves construction of approximately 3.5 miles of trails for motorized use, construction of one trailhead facility for motorized recreation, and use of the Oak Area Picnic ground as a trailhead. The decision includes a non-significant Forest Plan amendment.

This decision will result in the publication of a Motor Vehicle Use Map (MVUM). Designations made with past decisions will also be shown on the MVUM. After the MVUM has been released, travel off the designated system will be prohibited unless authorized by permit or other authorization. This decision is subject to appeal pursuant to regulations at 36 CFR 215. Individuals or organizations who provided comment or otherwise expressed interest in the proposed action by the close of the comment period may appeal. That comment period began with publication of the legal notice in the Albuquerque Journal on January 29<sup>th</sup>, 2008 and ended on February 28th, 2008. Interest expressed or comments provided on this project prior to or after the close of the comment period do not have standing for appeal purposes.

If no appeals are filed within the 45-day time period, implementation of the decision may occur on, but not before, 5 business days from the close of the appeal filing period. When appeals are filed, implementation may occur on, but not before, the 15<sup>th</sup> business day following the date of the last appeal disposition.
