Strike all after the resolving clause and insert the following:

1 SECTION 1. CONCURRENT RESOLUTION ON THE BUDGET
2 FOR FISCAL YEAR 2002.

3 The Congress declares that this is the concurrent res-
4 olution on the budget for fiscal year 2002 and that the
5 appropriate budgetary levels for fiscal years 2003 through
6 2011 are hereby set forth.
