At the end of subtitle C of title X (page 271, after line 17), insert the following new section:

4	(a) Assignment Authority of Secretary of De-
5	FENSE.—Chapter 18 of title 10, United States Code, is
6	amended by inserting after section 374 the following new
7	section:
8	"§ 374a. Assignment of members to assist border pa-
9	trol and control
10	"(a) Assignment Authorized.—Upon submission
11	of a request consistent with subsection (b), the Secretary
12	of Defense may assign members of the Army, Navy, Air
13	Force, and Marine Corps to assist—
14	"(1) the Immigration and Naturalization Serv-
15	ice in preventing the entry of terrorists and drug
16	traffickers into the United States; and
17	"(2) the United States Customs Service in the
18	inspection of cargo, vehicles, and aircraft at points
19	of entry into the United States to prevent the entry
20	of weapons of mass destruction, components of



1	weapons of mass destruction, prohibited narcotics or
2	drugs, or other terrorist or drug trafficking items.
3	"(b) Request for Assignment.—The assignment
4	of members under subsection (a) may occur only if—
5	"(1) the assignment is at the request of the At-
6	torney General, in the case of an assignment to the
7	Immigration and Naturalization Service, or the Sec-
8	retary of the Treasury, in the case of an assignment
9	to the United States Customs Service; and
10	"(2) the request of the Attorney General or the
11	Secretary of the Treasury (as the case may be) is
12	accompanied by a certification by the President that
13	the assignment of members pursuant to the request
14	is necessary to respond to a threat to national secu-
15	rity posed by the entry into the United States of ter-
16	rorists or drug traffickers.
17	"(c) Training Program Required.—The Attorney
18	General or the Secretary of the Treasury (as the case may
19	be), together with the Secretary of Defense, shall establish
20	a training program to ensure that members receive general
21	instruction regarding issues affecting law enforcement in
22	the border areas in which the members may perform du-
23	ties under an assignment under subsection (a). A member
24	may not be deployed at a border location pursuant to an

- 2 successfully completed the training program.
- 3 "(d) CONDITIONS OF USE.—(1) Whenever a member
- 4 who is assigned under subsection (a) to assist the Immi-
- 5 gration and Naturalization Service or the United States
- 6 Customs Service is performing duties at a border location
- 7 pursuant to the assignment, a civilian law enforcement of-
- 8 ficer from the agency concerned shall accompany the
- 9 member.
- 10 "(2) Nothing in this section shall be construed to—
- 11 "(A) authorize a member assigned under sub-
- section (a) to conduct a search, seizure, or other
- similar law enforcement activity or to make an ar-
- 14 rest; and
- 15 "(B) supersede section 1385 of title 18 (popu-
- larly known as the 'Posse Comitatus Act').
- 17 "(e) Establishment of Ongoing Joint Task
- 18 Forces.—(1) The Attorney General or the Secretary of
- 19 the Treasury may establish ongoing joint task forces when
- 20 accompanied by a certification by the President that the
- 21 assignment of members pursuant to the request to estab-
- 22 lish a joint task force is necessary to respond to a threat
- 23 to national security posed by the entry into the United
- 24 States of terrorists or drug traffickers.



- 1 "(2) When established, any joint task force shall fully
- 2 comply with the standards as set forth in this section.
- 3 "(f) Notification Requirements.—The Attorney
- 4 General or the Secretary of the Treasury (as the case may
- 5 be) shall notify the Governor of the State in which mem-
- 6 bers are to be deployed pursuant to an assignment under
- 7 subsection (a), and local governments in the deployment
- 8 area, of the deployment of the members to assist the Im-

- 12 "(g) Reimbursement Requirement.—Section 377
- 13 of this title shall apply in the case of members assigned

- 15 "(h) Termination of Authority.—No assignment
- 16 may be made or continued under subsection (a) after Sep-
- 17 tember 30, 2004.".
- 18 (b) Commencement of Training Program.—The
- 19 training program required by subsection (b) of section
- 20 374a of title 10, United States Code, shall be established
- 21 as soon as practicable after the date of the enactment of
- 22 this Act.
- 23 (c) Clerical Amendment.—The table of sections
- 24 at the beginning of such chapter is amended by inserting



- 1 after the item relating to section 374 the following new
- 2 item:

"374a. Assignment of members to assist border patrol and control.".
