MRS. MORELLA OF MARYLAND**

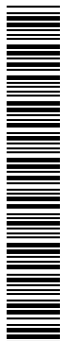
Page 95, after line 3, add the following:

1 **SEC. 706. AMENDMENTS TO THE VICTIMS OF TRAFFICKING**  
2 **AND VIOLENCE PROTECTION ACT OF 2000.**

3 (a) ASSISTANCE FOR VICTIMS IN OTHER COUN-  
4 TRIES.—Section 107(a)(1) of the Victims of Trafficking  
5 and Violence Protection Act of 2000 is amended by adding  
6 at the end the following: “In addition, such programs and  
7 initiatives shall, to the maximum extent practicable, in-  
8 clude the following:

9 “(A) Support for local in-country non-  
10 governmental organization-operated hotlines,  
11 culturally and linguistically appropriate protec-  
12 tive shelters, and regional and international  
13 nongovernmental organization networks and  
14 databases on trafficking, including support to  
15 assist nongovernmental organizations in estab-  
16 lishing service centers and systems that are mo-  
17 bile and extend beyond large cities.

18 “(B) Support for nongovernmental organi-  
19 zations and advocates to provide legal, social,  
20 and other services and assistance to trafficked



1 individuals, particularly those individuals in de-  
2 tention.

3 “(C) Education and training for trafficked  
4 women and girls upon their return home.

5 “(D) The safe reintegration of trafficked  
6 individuals into an appropriate community or  
7 family, with full respect for the wishes, dignity,  
8 and safety of the trafficked individual.

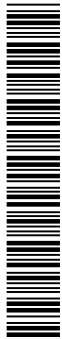
9 “(E) Support for increasing or developing  
10 programs to assist families of victims in locat-  
11 ing, repatriating, and treating their trafficked  
12 family members.”.

13 (b) AUTHORIZATION OF APPROPRIATIONS.—Section  
14 113 of the Victims of Trafficking and Violence Protection  
15 Act of 2000 is amended—

16 (1) in subsection (a), by striking “for fiscal  
17 year 2002” and inserting “for each of the fiscal  
18 years 2002 and 2003”;

19 (2) in subsection (c)—

20 (A) in paragraph (1), by striking “and  
21 \$10,000,000 for fiscal year 2002” and inserting  
22 “, \$10,000,000 for fiscal year 2002, and  
23 \$15,000,000 for fiscal year 2003”; and



1                   (B) in paragraph (2), by striking “for fis-  
2                   cal year 2001” and inserting “for each of the  
3                   fiscal years 2001, 2002, and 2003”; and

4                   (3) in paragraphs (1) and (2) of subsection (e),  
5                   by striking “and \$10,000,000 for fiscal year 2002”  
6                   each place it appears and inserting “, \$10,000,000  
7                   for fiscal year 2002, and \$15,000,000 for fiscal year  
8                   2003”.
