

LAA 3 includes the following boundaries: northern boundary, Hwy 121 N/Hwy 641 S to Hwy 94 E; Eastern boundary, Hwy 121, Locust Grove Rd, Goldenrod Rd, and Alton Trail; Western boundary, Calloway Graves County line; and southern boundary, Kentucky/Tennessee State Line.
