**County Committees:** The Farm Service Agency county/area committees are responsible for the administration of Federal farm programs at the local level.

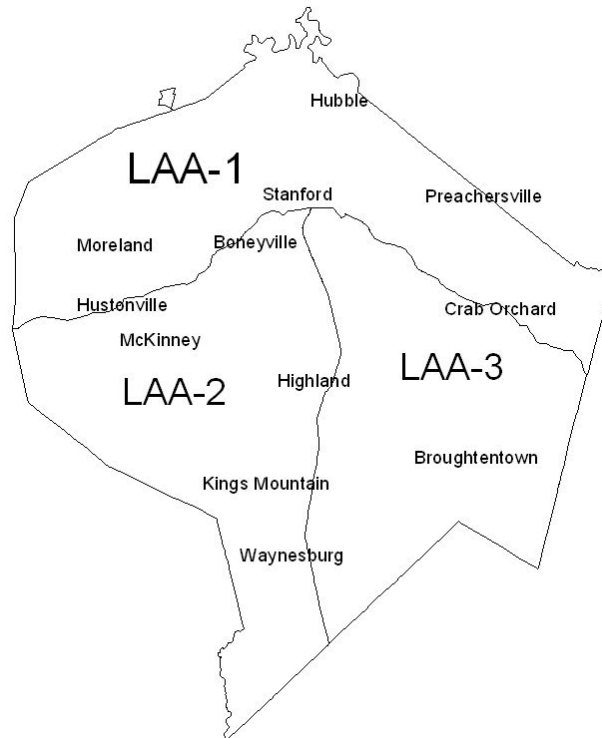
**Committee Nominations Open:** Nominations for candidates to run for the Farm Service Agency county committee election representing producers in Local Administrative Area (LAA) 1 will be accepted from June 15 through August 1, 2008. LAAs are election areas. Elections are held each year to elect or re-elect a member(s) whose term will expire.

Lincoln County will be holding an election for a person to represent LAA 1 beginning January 1, 2009. That position is currently held by Boyd Coleman, Jr. LAA 1 includes all land that is North of Highways 78 and 150 to the Lincoln County line. This includes the communities of Moreland, Milledgeville, Hubble, Logantown, Preachersville, Gilberts Creek, Chicken Bristle and parts of Hustonville, Crab Orchard, and Stanford.

**Nomination Forms:** Nomination form FSA-669A is used to nominate a candidate to run in the election. All nomination forms must be postmarked or returned to the Stanford FSA Service Center not later than August 1, 2008.
