LAA's are election areas. Elections are held each year to elect or re-elect a member(s) whose term will expire.

Bardstown will be holding an election for a person to represent LAA 3 beginning January 1, 2009. That position is currently held by Nancy Richardson. LAA 3 includes the North Eastern area.
