**County Committees:** The Farm Service Agency county/area committees are responsible for the administration of Federal farm programs at the local level.


**Committee Nominations Open:** Nominations for candidates to run for the Farm Service Agency committee election representing producers in Local Administrative Area (LAA) 3 will be accepted from June 16 through August 1, 2008. LAAs are election areas. Elections are held each year to elect or re-elect a member whose term will expire.

Russell County will be holding an election for a person to represent LAA 3 beginning January 1, 2009. That position is currently held by Jared Foley. LAA 3 includes the Northern section of Russell County, including the area North of Hwy 80 from the Adair County line to Hwy 76, North of Hwy 76 to Eli, then along Freedom Branch to Lake Cumberland, then following the lake to the Pulaski County line.
