

Insurance Commissioner's Annual Report on the Use of the Insurance Regulation Fund For the Fiscal Year 2000-2001

Pursuant to §431:2-215(f), Hawaii Revised Statutes, the Insurance Commissioner submitted the report on the use of the Insurance Regulation Fund ("IRF") for fiscal year 2000-2001 to the Governor, Director of Commerce & Consumer Affairs, and Legislature.

The IRF was established by Act 163, Session Laws of Hawaii 1999, and began its first year of operations in FY 1999-2000. The IRF is used to defray all of the cost associated with the Insurance Division and cost incurred by supporting offices and divisions

The report on page 2 shows assessments by line of insurance, other revenues and expenditures made from the IRF.
