6	(c) Assessment of Obstacles.—The study shall
7	provide an assessment of existing obstacles that prevent
8	members of the Armed Forces and military families in
9	need of mental health services from obtaining these serv-
10	ices, including—
11	(1) the extent to which existing confidentiality
12	regulations, or lack thereof, inhibit members of the
13	Armed Forces from seeking mental health treat-
14	ment;
15	(2) the implications that a decision to seek
16	mental health services can have on a military career;
17	(3) the extent to which a social stigma exists
18	within the Armed Forces that prevents members of
19	the Armed Forces and military families from seeking
20	mental health treatment within the Department of

22	(4) the extent to which logistical obstacles, par-
23	ticularly with respect to members of the Armed
24	Forces and families residing in rural areas, deter



1	members in need of mental health services from ob-
2	taining them; and
3	(5) the extent to which members of the Armed
4	Forces and their families are prevented or hampered
5	from obtaining mental health treatment due to the

7	(d) Identification of Problems Unique to Re-
8	SERVES.—The study shall identify potential problems in
9	obtaining mental health treatment that are unique to
10	members of Reserve components.
11	(e) Report.—The Secretary of Defense shall submit
12	to Congress a report on the study conducted under this
13	section not later than 90 days after the date of the enact-
14	ment of this Act. The report shall contain the results of
15	the study and make specific recommendations—
16	(1) for improving the effectiveness and accessi-
17	bility of mental health services provided by Depart-
18	ment of Defense to the persons listed in subsection
19	(b), including recommendations to ensure appro-
20	priate referrals and a seamless transition to the care
