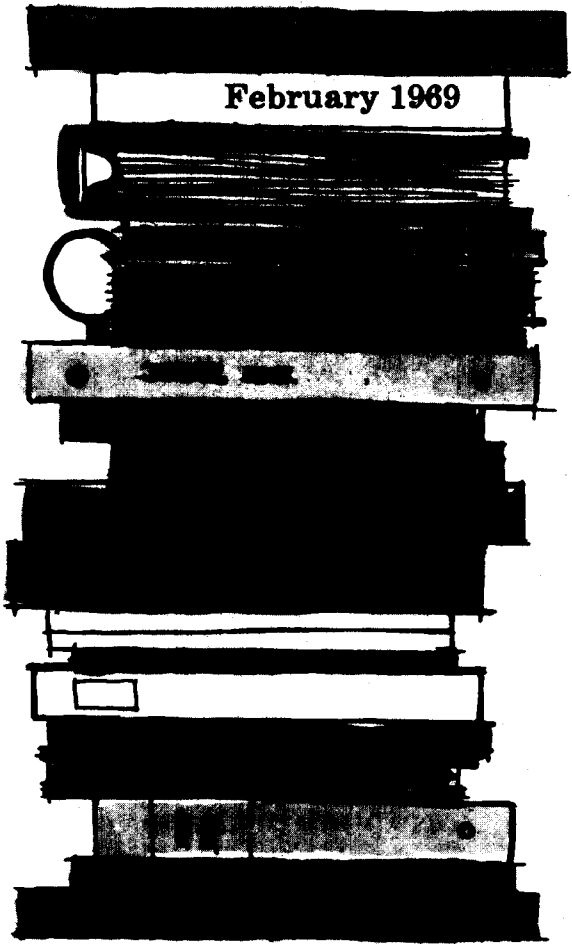

PREFACE AND TABLE OF CONTENTS

This first revision of the *Selected Bibliography of Regional Medical Programs* has been made by the Office of Communications and Public Information of the Division of Regional Medical Programs. The need for such a revision only six months after the first publication was made necessary by the overwhelming number of new articles and publications dealing with Regional Medical Program activities.

This *Bibliography* is based upon materials collected since the Division was established in February of 1966, as well as materials published as early as April 1965, which are important references to the history of the Programs. As indicated by the term *Selected* in the title, the choice of the references represents a continuing effort aimed at the development of a representative resource which will be of value to all Regional Medical Programs and those organizations, institutions, and individuals working with them.
