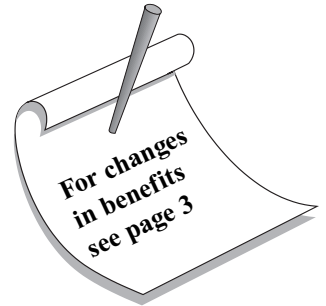

Introduction

Prudential Health Care Plan, Inc., Prudential HealthCare HMO® - Philadelphia

This brochure describes the benefits you can receive from Prudential Health Care Plan, Inc., dba Prudential HealthCare HMO® - Philadelphia under its contract (CS 2685) with the Office of Personnel Management (OPM), as authorized by the Federal Employees Health Benefits (FEHB) law. This brochure is the official statement of benefits on which you can rely. A person enrolled in this Plan is entitled to the benefits described in this brochure. If you are enrolled for Self and Family coverage, each eligible family member is also entitled to these benefits.

OPM negotiates benefits and premiums with each plan annually. Benefit changes are effective January 1, 2000, and are shown on page 3. Premiums are listed at the end of this brochure.

Plain language

The President and Vice President are making the Government's communication more responsive, accessible, and understandable to the public by requiring agencies to use plain language. Health plan representatives and Office of Personnel Management staff have worked cooperatively to make portions of this brochure clearer. In it you will find common, everyday words, except for necessary technical terms; "you" and other personal pronouns; active voice; and short sentences.

We refer to Prudential HealthCare HMO® - Philadelphia as "this Plan" throughout this brochure even though in other legal documents, you will see a plan referred to as a carrier.

These changes do not affect the benefits or services we provide. We have rewritten this brochure only to make it more understandable.

We have not re-written the Benefits section of this brochure. You will find new benefits language next year.

How to use this brochure

This brochure has eight sections. Each section has important information you should read. If you want to compare this Plan's benefits with benefits from other FEHB plans, you will find that the brochures have the same format and similar information to make comparisons easier.

1. Health Maintenance Organizations (HMO). This Plan is an HMO. Turn to this section for a brief description of HMOs and how they work.
2. How we change for 2000. If you are a current member and want to see how we have changed, read this section.
3. How to get benefits. Make sure you read this section; it tells you how to get services and how we operate.
4. What to do if we deny your claim or request for service. This section tells you what to do if you disagree with our decision not to pay for your claim or to deny your request for a service.
5. Benefits. Look here to see the benefits we will provide as well as specific exclusions and limitations. You will also find information about non-FEHB benefits.
6. General exclusions - Things we don't cover. Look here to see benefits that we will not provide.
7. Limitations - Rules that affect your benefits. This section describes limits that can affect your benefits.
8. FEHB FACTS. Read this for information about the Federal Employees Health Benefits (FEHB) Program.

Section 1. Health Maintenance Organizations

Health maintenance organizations (HMOs) are health plans that require you to see Plan providers: specific physicians, hospitals and other providers that contract with us. These providers coordinate your health care services. The care you receive includes preventative care such as routine office visits, physical exams, well-baby care and immunizations, as well as treatment for illness and injury.

When you receive services from our providers, you will not have to submit claim forms or pay bills. However, you must pay copayments and coinsurance listed in this brochure. When you receive emergency services you may have to submit claim forms. You will also need to submit claims for certain supplies, such as durable medical equipment.

You should join an HMO because you prefer the plan's benefits, not because a particular provider is available. You cannot change plans because a provider leaves our Plan. We cannot guarantee that any one physician, hospital, or other provider will be available and/or remain under contract with us. Our providers follow generally accepted medical practice when prescribing any course of treatment.

Section 2. How we change for 2000

Program-wide changes

To keep your premium as low as possible OPM has set a minimum copay of \$10 for all primary care office visits.

This year, you have a right to more information about this Plan, care management, our networks, facilities, and providers.

If you have a chronic or disabling condition, and your provider leaves the Plan at our request, you may continue to see your specialist for up to 90 days. If your provider leaves the Plan and you are in the second or third trimester of pregnancy, you may be able to continue seeing your OB/GYN until the end of your postpartum care. You have similar rights if this Plan leaves the FEHB program. (See Section 3, How to get benefits, for more information.)

You may review and obtain copies of your medical records on request. If you want copies of your medical records, ask your health care provider for them. You may ask that a physician amend a record that is not accurate, not relevant, or incomplete. If the physician does not amend your record, you may add a brief statement to it. If they do not provide you your records, call us and we will assist you.

If you are over age 50, all FEHB plans will cover a screening sigmoidoscopy every five years. This screening is for colorectal cancer.

Changes to this Plan

- Your share of the non-postal premium will increase by 27.9% for Self Only or 74.3% for Self and Family.
- Our office visit copay for doctor visits, short term rehabilitation therapy, infertility treatment, cardiac rehabilitation and urgent care center visits increased from \$5 to \$10 per visit. See pages 7, 9, 11, and 12.
- We waive copays for pre and postnatal care. See page 8.
- Our diabetic coverage increased. See page 9.
- Our emergency room copay increased from \$25 to \$50 per visit. See page 11.
- We cover treatment for serious mental illness. See page 13.
- Our prescription drug copay structure will now have a \$15 brand formulary copay instead of \$10 and a \$25 copay for non-formulary drugs. See page 13.

Section 3. How to get benefits

What is this Plan's service area?

To enroll with us, you must live in our service area. This is where our providers practice. Our service area is: The Philadelphia/Lehigh Valley, Pennsylvania area including the Pennsylvania counties of Bucks, Chester, Delaware, Lehigh, Montgomery, Northampton and Philadelphia.

You may also enroll with us if you work in the above service area and live in the following places: The **Pennsylvania** counties of Berks, and Lancaster; the **New Jersey** counties of Burlington, Camden, Gloucester, and Mercer; or the **Delaware** county of New Castle. You must use Plan providers in the above Pennsylvania service area.

Ordinarily, you must get your care from providers who contract with us. If you receive care outside our service area, we will pay only for emergency. We will not pay for any other health care services.

If you or a covered family member move outside of our service area, you can enroll in another plan. If your dependents live out of the area (for example, if your child goes to college in another state), you should consider enrolling in a fee-for-service plan or an HMO that has agreements with affiliates in other areas. If you or a family member move, you do not have to wait until Open Season to change plans. Contact your employing or retirement office.

How much do I pay for services?

You must share the cost of some services. This is called either a copayment (a set dollar amount) or coinsurance (a set percentage of charges). Please remember you must pay this amount when you receive services.

After you pay \$1,213.16 in copayments or coinsurance for one family member, or \$3,336.45 for two or more family members, you do not have to make any further payments for certain services for the rest of the year. This is called a catastrophic limit. However, copayments or coinsurance for your prescription drugs do not count toward these limits and you must continue to make these payments.

Be sure to keep accurate records of your copayments and coinsurance, since you are responsible for informing us when you reach the limits.

Do I have to submit claims?

You normally won't have to submit claims to us unless you receive emergency services from a provider who doesn't contract with us or for certain other charges, such as durable medical equipment. If you file a claim, please send us all of the documents for your claim as soon as possible. You must submit claims by December 31 of the year after the year you received the service. Either OPM or we can extend this deadline if you show that circumstances beyond your control prevented you from filing on time.

Who provides my health care?

Prudential HealthCare HMO® - Philadelphia is offered by Prudential Health Care Plan, Inc., a member company of Aetna US Healthcare®. Organized as an IPA HMO in the Philadelphia/Lehigh Valley area, Prudential HealthCare HMO® - Philadelphia network includes approximately 12,330 primary and specialty care physicians. These physicians provide and arrange all health services.

You will need to let us know which primary care physician you select for each member of the family. If you need help in choosing a physician, please call us at 800/856-0764. You may change your choice by calling us 30 days in advance.

We contract with Merit Behavioral Health Care for all mental health and substance abuse services. You must contact Merit at 800/251-2422 prior to getting services. Merit will authorize and determine the appropriate number of visits. You do not need a referral from your doctor.

What do I do if my primary care physician leaves the Plan?

Call us at 800/856-0764. We will help you select a new one.

What do I do if I need to go into the hospital?

Talk to your Plan physician. If you need to be hospitalized, your primary care physician or specialist will make the necessary hospital arrangements and supervise your care.

Outpatient surgical services may be performed at a participating hospital or at a participating ambulatory surgical center.

Section 3. How to get benefits *continued*

What do I do if I'm in the hospital when I join this Plan?

First, call our customer service department at 800/856-0764 if you are within the service area. If you are hospitalized outside of the service area, please call our national hotline number at 800/526-2963. If you are new to the FEHB Program, we will arrange for you to receive care. If you are currently in the FEHB Program and are switching to us, your former plan will pay for the hospital stay until:

- You are discharged, not merely moved to an alternative care center, or
- The day your benefits from your former plan run out, or
- The 92nd day after you became a member of this Plan; whichever happens first.

These provisions only apply to the person who is hospitalized.

How do I get specialty care?

Your primary care physician will arrange your referral to a specialist. You must receive a referral from your primary care physician before seeing any other doctor or obtaining special services.

When you receive a referral from your primary care physician, you must return to that physician after the consultation unless your primary care physician authorizes additional visits. Your primary care physician will develop a treatment plan with you that allows an adequate number of direct access visits with that specialist. Do not go to the specialist unless your primary care physician has arranged for, and we have issued an authorization for, the referral in advance. We do not require a referral for visits to a network OB/GYN, one visit every 24 months to a network vision provider, and mental health and substance abuse services can be reached at 800-251-2422 without a referral.

If you need to see a specialist frequently because of a chronic, complex, or serious medical condition, your primary care physician will develop a treatment plan that allows you to see your specialist for a certain number of visits without additional referrals. Your primary care physician will use our criteria when creating your treatment plan.

What do I do if I am seeing a specialist when I enroll?

Your primary care physician will decide what treatment you need. If they decide to refer you to a specialist, ask if you can see your current specialist. If your current specialist does not participate with us, you must receive treatment from a specialist who does. Generally, we will not pay for you to see a specialist who does not participate with our Plan.

What do I do if my specialist leaves the Plan?

Call your primary care physician, who will arrange for you to see another specialist. You may receive services from your current specialist until we can make arrangements for you to see someone else.

But, what if I have a serious illness and my provider leaves the Plan or this Plan leaves the Program?

Please contact us if you believe your condition is chronic or disabling. You may be able to continue seeing your provider for up to 90 days after we notify you that we are terminating our contract with the provider (unless the termination is for cause). If you are in the second or third trimester of pregnancy, you may continue to see your OB/GYN until the end of your postpartum care.

You may also be able to continue seeing your provider if your plan drops out of the FEHB Program and you enroll in a new FEHB plan. Contact the new plan and explain that you have a serious or chronic condition, or are in your second or third trimester. Your new plan will pay for or provide your care for up to 90 days after you receive notice that your prior plan is leaving the FEHB Program. If you are in your second or third trimester, your new plan will pay for the OB/GYN care you receive from your current provider until the end of your postpartum care.

How do you authorize medical services?

Your physician must get our approval before sending you to a hospital, referring you to a specialist, or recommending follow-up care. Before giving approval, we consider if the service is medically necessary to prevent, diagnose or treat your illness or condition and if it follows generally accepted medical practice.

Section 3. How to get benefits *continued*

How do you decide if a service is experimental or investigational?

We do not cover procedures, services, or supplies that are experimental or investigational. In order to determine whether or not a procedure, service, or supply is experimental or investigational, we gather appropriate information for a decision that will be made by medical professionals. The information we collect may include medical records, current reviews of medical literature and scientific evidence, results of current studies or clinical trials, research protocols, reports or opinions of authoritative medical bodies, opinions of independent outside experts and approvals granted by regulatory bodies. Your provider may sometimes ask that you sign a form acknowledging that the procedure, service, or supply is experimental or investigational. This form and any related protocol may also be part of the information we consider. After reviewing all pertinent information, we make our determination and notify you of our decision. Please contact customer service at 800/856-0764 for more specific information.

Section 4. What to do if we deny your claim or request for service

If we deny services or won't pay your claim, you may ask us to reconsider our decision. Your request must:

1. Be in writing,
2. Refer to specific brochure wording explaining why you believe our decision is wrong; and
3. Be made within six months from the date of our initial denial or refusal. We may extend this time limit if you show that you were unable to make a timely request due to reasons beyond your control.

We have 30 days from the date we receive your reconsideration request to:

1. Maintain our denial in writing;
2. Pay the claim;
3. Arrange for a health care provider to give you the service; or
4. Ask for more information

If we ask your medical provider for more information, we will send you a copy of our request. We must make a decision within 30 days after we receive the additional information. If we do not receive the requested information within 60 days, we will make our decision based on the information we already have.

When may I ask OPM to review a denial?

You may ask OPM to review the denial after you ask us to reconsider our initial denial or refusal. OPM will determine if we correctly applied the terms of our contract when we denied your claim or request for service.

What if I have a serious or life threatening condition and you haven't responded to my request for services?

Call us at 800/856-0764 and we will expedite our review.

What if you have denied my request for care and my condition is serious or life threatening?

If we expedite your review due to a serious medical condition and deny your claim, we will inform OPM so that they can give your claim expedited treatment too. Alternatively, you can call OPM's health benefits Contract Division III at (202) 606-0755 between 8 a.m. and 5 p.m. Serious or life-threatening conditions are ones that may cause permanent loss of bodily functions or death if they are not treated as soon as possible.

Are there other time limits?

You must write to OPM and ask them to review our decision within 90 days after we uphold our initial denial or refusal of service. You may also ask OPM to review your claim if:

1. We do not answer your request within 30 days. In this case, OPM must receive your request within 120 days of the date you asked us to reconsider your claim.
2. You provided us with additional information we asked for, and we did not answer within 30 days. In this case, OPM must receive your request within 120 days of the date we asked you for additional information.

Section 4. What to do if we deny your claim or request for service *continued*

What do I send to OPM?

Your request must be complete, or OPM will return it to you. You must send the following information:

1. A statement about why you believe our decision is wrong, based on specific benefit provisions in this brochure;
2. Copies of documents that support your claim, such as physicians' letters, operative reports, bills, medical records, and explanation of benefits (EOB) forms;
3. Copies of all letters you sent us about the claim;
4. Copies of all letters we sent you about the claim; and
5. Your daytime phone number and the best time to call.

If you want OPM to review different claims, you must clearly identify which documents apply to which claim.

Who can make the request?

Those who have a legal right to file a disputed claim with OPM are:

1. Anyone enrolled in the Plan;
2. The estate of a person once enrolled in the Plan; and
3. Medical providers, legal counsel, and other interested parties who are acting as the enrolled person's representative. They must send a copy of the person's specific written consent with the review request.

Where should I mail my disputed claim to OPM?

Send your request for review to: Office of Personnel Management, Office of Insurance Programs, Contract Division III, P.O. Box 436, Washington, D.C. 20044

What if OPM upholds the Plan's denial?

OPM's decision is final. There are no other administrative appeals. If OPM agrees with our decision, your only recourse is to sue.

If you decide to sue, you must file the suit against OPM in Federal court by December 31 of the third year after the year in which you received the disputed services or supplies.

What laws apply if I file a lawsuit?

Federal law governs your lawsuit, benefits, and payment of benefits. The Federal court will base its review on the record that was before OPM when OPM made its decision on your claim. You may recover only the amount of benefits in dispute.

You (or a person acting on your behalf) may not sue to recover benefits on a claim for treatment, services, supplies, or drugs covered by us until you have completed the OPM review procedure described above.

Your records and the Privacy Act

Chapter 89 of title 5, United States Code allows OPM to use the information it collects from you and us to determine if our denial of your claim is correct. The information OPM collects during the review process becomes a permanent part of your disputed claims file, and is subject to the provisions of the Freedom of Information Act and the Privacy Act. OPM may disclose this information to support the disputed claim decision. If you file a lawsuit, this information will become part of the court record.

Section 5. Medical and Surgical Benefits

What is covered

A comprehensive range of preventive, diagnostic and treatment services is provided by Plan doctors and other Plan providers. This includes all necessary office visits; you pay a \$10 office visit copay, but no additional copay for laboratory tests and X-rays. Within the service area, house calls will be provided if, in the judgment of the Plan doctor, such care is necessary and appropriate; you pay \$10 for a doctor's house call and nothing for home visits by nurses and health aides.

CARE MUST BE RECEIVED FROM OR ARRANGED BY PLAN DOCTORS

Section 5. Medical and Surgical Benefits *continued*

What is covered *continued*

The following services are included and are subject to the office visit copay unless stated otherwise:

- Preventive care, including vision and hearing screening for children through age 17, well-baby care and periodic check-ups, and routine gynecological exams.
- Sigmoidoscopy screening for colorectal cancer every five years for those age 50 and above.
- Mammograms are covered as follows: for women under age 40, mammograms as recommended by your primary care doctor; for women age 40 and older, one mammogram every year or as recommended by your primary care doctor. In addition to routine screening, mammograms are covered when prescribed by the doctor as medically necessary to diagnosis or treat your illness.
- Routine immunizations and boosters
- Consultations by specialists
- Diagnostic procedures, such as laboratory tests and X-rays (no copay applies)
- Complete obstetrical (maternity) care for all covered females, including prenatal, delivery and postnatal care by a Plan doctor. Copays are waived for pre and postnatal care. The mother, at her option, may remain in the hospital up to 48 hours after a regular delivery and 96 hours after a cesarean delivery. Inpatient stays will be extended if medically necessary. If enrollment in the Plan is terminated during pregnancy, benefits will not be provided after coverage under the Plan has ended. Ordinary nursery care of the newborn child during the covered portion of the mother's hospital confinement for maternity will be covered under either Self Only or Self and Family enrollment; other care of an infant who requires definitive treatment will be covered only if the infant is covered under a Self and Family enrollment.
- Voluntary sterilization and family planning services
- Diagnosis and treatment of diseases of the eye
- Allergy testing and treatment, including testing and treatment materials (such as allergy serum)
- The insertion of internal prosthetic devices, such as pacemakers and artificial joints.
- Cornea, heart, lung (single and double), heart/lung, intestinal, pancreas, kidney and liver transplants; allogeneic (donor) bone marrow transplants; autologous bone marrow transplants (autologous stem cell and peripheral stem cell support) for the following conditions: acute lymphocytic or non-lymphocytic leukemia, advanced Hodgkin's lymphoma, advanced non-Hodgkin's lymphoma, advanced neuroblastoma, breast cancer, multiple myeloma, epithelial ovarian cancer, and testicular, mediastinal, retroperitoneal and ovarian germ cell tumors. Transplants are covered when approved by the Medical Director. Related medical and hospital expenses of the donor are covered when the recipient is covered by this Plan.
- Patients who undergo mastectomies may, at their option, have this procedure performed on an inpatient basis and remain in the hospital up to 48 hours after the procedure.
- Dialysis
- Chemotherapy, radiation therapy, and inhalation therapy
- Surgical treatment of morbid obesity
- Home health services of nurses and health aides, including intravenous fluids and medications, when prescribed by your Plan doctor, who will periodically review the program for continuing appropriateness and need
- Chiropractic services and acupuncture services with a referral
- Orthopedic devices, such as braces; foot orthotics
- Implanted time-released medications, such as Norplant®; you pay the office visit copay.
- For Norplant® and other internally implanted time-release medication, there is no charge when the device is implanted during a covered hospitalization. There will be no refund of any portion the copay if the implanted time-released medication is removed before the end of its expected life.
- Injectable drugs, other than insulin (insulin is covered under the Prescription Drug Benefits)
- Disposable needles and syringes needed to inject covered prescribed medications;
- Durable medical equipment, such as crutches, wheelchairs, hospital beds, oxygen and rental of equipment for use of oxygen. Replacement, repairs and maintenance of durable medical equipment not provided for under a manufacturer's warranty or purchase agreement will be covered.
- Prosthetic devices, such as artificial limbs, breast prostheses and surgical bras (as well as their replacement) and lenses following cataract removal (Initial eyeglasses or lenses for the replacement for loss of the natural lens are also covered.)

CARE MUST BE RECEIVED FROM OR ARRANGED BY PLAN DOCTORS

Section 5. Medical and Surgical Benefits *continued*

What is covered *continued*

- All necessary medical or surgical care in a hospital or extended care facility from Plan doctors and other Plan providers.
- Diabetic equipment and supplies, including blood glucose monitors, monitor supplies, injection aids, syringes, insulin infusion devices, pharmacological agents for controlling blood sugar and orthotics
- Diabetic outpatient self-management educational training and education shall be provided under the supervision of a licensed health care professional with expertise in diabetes to ensure that persons with diabetes are educated as to the proper self-management and treatment of their diabetes, including information on proper diets. Self-management and diet education prescribed by a licensed physician shall include (1) visits medically necessary upon the diagnosis of diabetes; (2) visits where a physician identifies and diagnoses a significant change in the patient's symptoms or conditions necessitating changes in the patient's self-management; (3) where a licensed physician identifies that a new medication or therapeutic process relating to the person's treatment or diabetes management is medically necessary.

Limited benefits

Oral and maxillofacial surgery is provided for non-dental surgical and hospitalization procedures for congenital defects, such as cleft lip and cleft palate, and for medical or surgical procedures occurring within or adjacent to the oral cavity or sinuses including, but not limited to, treatment of fractures and excision of tumors and cysts. All other procedures involving the teeth or intra-oral areas surrounding the teeth are not covered, including any dental care involved in treatment of temporomandibular joint (TMJ) pain dysfunction syndrome.

Reconstructive surgery will be provided to correct a condition resulting from an abnormal congenital and /or functional defect or from an injury or surgery that has produced a major effect on the member's appearance and if the condition can reasonably be expected to be corrected by such surgery. A patient and her attending physician may decide whether to have breast reconstruction surgery following a mastectomy and whether surgery on the other breast is needed to produce a symmetrical appearance.

Short-term rehabilitative therapy (physical, speech and occupational) is provided on an inpatient or outpatient basis for up to 90 calendar days if significant improvement can be expected within that period; you pay a \$10 copay per outpatient session. Speech therapy is limited to treatment of certain speech impairments of a organic origin. Occupational therapy is limited to services that assist the member to achieve and maintain self-care and improved functioning in other activities of daily living. Therapy for learning disabilities is not covered.

Diagnosis and treatment of infertility is covered; you pay a \$10 copay per office visit. The following types of artificial insemination are covered: intravaginal insemination (IVI), intracervical insemination (ICI) and intrauterine insemination (IUI); cost of donor sperm is not covered. Fertility drugs are covered. Oral fertility drugs are covered under the Prescription Drug Benefits, subject to the applicable copays. Other assisted reproductive technology (ART), such as in vitro fertilization and embryo transfer, are not covered.

Cardiac rehabilitation following a heart transplant, bypass surgery or a myocardial infarction, is provided on an outpatient basis for up to 90 days if such care is necessary and appropriate in the judgment of the Plan doctor and has been authorized by the Plan. You pay a \$10 copay per outpatient session.

Institutes of Quality (IQ) Program: The IQ program provides coverage for sophisticated medical treatments and procedures offered by a network of hospitals and physicians known for their demonstrated accomplishments in patient outcomes. This Program includes a nationwide network for organ transplants, bone marrow transplants, and brain and spinal cord injury rehabilitation. Under the Program, the person's primary care doctor must initiate a referral to an institute of quality for covered procedures. Participation is subject to approval by Prudential HealthCare and candidates must meet pre-screening criteria. Contact the Plan for further information on the IQ Program.

Medical foods are covered if medically necessary and critical to the well being of individuals afflicted with rare hereditary genetic metabolic disorders. The disorders are as follows: Phenylketonuria (PKU), branched-chain ketonuria, galactosemia and homocystinuria. There is no copay. However, this treatment must be precertified by a participating Plan provider.

- What is not covered**
- Physical examinations that are not necessary for medical reasons, such as those required for obtaining or continuing employment or insurance, attending school or camp, or travel
 - Reversal of voluntary, surgically-induced sterility
 - Surgery primarily for cosmetic purposes
 - Transplants not listed as covered
 - Hearing aids, exams to determine the need for hearing aids, or the need to adjust them
 - Cochlear implants for prelingually deafened adults or children less than two years of age (unless authorized by the Plan)
 - Homemaker services
 - Long-term rehabilitative therapy
 - Blood and blood derivatives not replaced by or for the patient
 - Any eye surgery solely for the purpose of correcting refractive defects of the eye, such as nearsightedness (myopia), farsightedness (hyperopia) and astigmatism.

Section 5. Hospital/Extended Care Benefits

What is covered

Hospital Care

The Plan provides a comprehensive range of benefits with no dollar or day limit when you are hospitalized under the care of a Plan doctor. You pay nothing. All necessary services are covered, including:

- Semiprivate room accommodations; when a Plan doctor determines it is medically necessary, the doctor may prescribe private accommodations or private duty nursing care
- Specialized care units, such as intensive care or cardiac care units

Extended care

The Plan provides a comprehensive range of benefits for up to 100 days per condition for all such confinements which are due to the same or related causes and which are separated by less than three months. Coverage is provided when full-time skilled nursing care is necessary and confinement in a skilled nursing facility is medically appropriate as determined by a Plan doctor and approved by the Plan. You pay nothing. All necessary services are covered, including:

- Bed, board and general nursing care
- Drugs, biologicals, supplies, and equipment ordinarily provided or arranged by the skilled nursing facility when prescribed by a Plan doctor.

Hospice Care

Supportive and palliative care for a terminally ill member is covered in the home or hospice facility up to a reasonable cash value of \$7,400. Services include inpatient and outpatient care, and family counseling; these services are provided under the direction of a Plan doctor who certifies that the patient is in the terminal stages of illness, with a life expectancy of approximately six months or less. Counseling services within 3 months of the death of the patient will be furnished to the patient's family up to a reasonable cash value of \$200.

Ambulance service

Benefits are provided for ambulance transportation ordered or authorized by a Plan doctor.

Limited benefits

Inpatient dental procedures

Hospitalization for certain dental procedures is covered when a Plan doctor determines there is a need for hospitalization for reasons totally unrelated to the dental procedure; the Plan will cover the hospitalization, but not the cost of the professional dental services. Conditions for which hospitalization would be covered include hemophilia and heart disease; the need for anesthesia, by itself, is not such a condition.

Acute inpatient detoxification

Hospitalization for medical treatment of substance abuse is limited to emergency care, diagnosis, treatment of medical conditions, and medical management of withdrawal symptoms (acute detoxification) if the Plan doctor determines that outpatient management is not medically appropriate. See page 13 for non-medical Substance Abuse Benefits.

What is not covered

- Personal comfort items, such as telephone and television
- Blood and blood derivatives not replaced by or for the patient
- Custodial care, rest cures, domiciliary or convalescent care

Section 5. Emergency Benefits

What is a medical emergency?	<p>A medical emergency is the sudden and unexpected onset of a condition or an injury that you believe endangers your life or could result in serious injury or disability, and requires immediate medical or surgical care. Some problems are emergencies because, if not treated promptly, they might become more serious; examples include deep cuts and broken bones. Others are emergencies because they are potentially life threatening, such as heart attacks, strokes, poisonings, gunshot wounds, or sudden inability to breathe. There are many other acute conditions that the Plan may determine are medical emergencies - what they all have in common is the need for quick action.</p>
Emergencies within the service area	<p>If you are in an emergency situation, please call your primary care doctor. In extreme emergencies, if you are unable to contact your doctor, contact the local emergency system (e.g., the 911-telephone system) or go to the nearest hospital emergency room. Be sure to tell the emergency room personnel that you are a Plan member so they can notify the Plan. You or a family member must notify the Plan within 48 hours, unless it was not reasonably possible to do so. It is your responsibility to ensure that the Plan has been timely notified.</p> <p>If you need to be hospitalized, the Plan must be notified within 48 hours or on the first working day following your admission, unless it was not reasonably possible to notify the Plan within that time. If you are hospitalized in non-Plan facilities and Plan doctors believe care can be better provided in a Plan hospital, you will be transferred when medically feasible with any ambulance charges covered in full.</p> <p>Benefits are available for care from non-Plan providers in a medical emergency only if delay in reaching a Plan provider would result in death, disability or significant jeopardy to your condition.</p> <p>To be covered by this Plan, any follow-up care recommended by non-Plan providers must be approved by the Plan or provided by Plan providers.</p>
Plan pays...	<p>Reasonable charges for emergency services to the extent the services would have been covered if received from Plan providers.</p>
You pay...	<p>\$50 per hospital emergency room visit for emergency services that are covered benefits of this Plan. If the emergency results in an admission to a hospital, the emergency room copay is waived.</p>
Emergencies outside the service area	<p>Benefits are available for any medically necessary health service that is immediately required because of injury or unforeseen illness.</p> <p>If you need to be hospitalized, the Plan must be notified within 48 hours or on the first working day following your admission, unless it was not reasonably possible to notify the Plan within that time. If a Plan doctor believes care can be better provided in a Plan hospital, you will be transferred when medically feasible with any ambulance charges covered in full.</p> <p>To be covered by this Plan, any follow-up care recommended by non-Plan providers must be approved by the Plan or provided by plan providers.</p>
Plan pays...	<p>Reasonable charges for emergency care services to the extent the services would have been covered if received from Plan providers.</p>
You pay...	<p>\$50 per hospital emergency room visit; \$10 per urgent care center visit for emergency services that are covered benefits of this Plan. (Urgent care services rendered outside the service area must be coordinated through the Prudential National Service Hotline at 800-526-2963 in order for the \$10 copay to apply). If the emergency results in an admission to a hospital, the emergency room copay (\$50) is waived.</p>
What is covered	<ul style="list-style-type: none">• Emergency care at a doctor's office or an urgent care center• Emergency care as an outpatient or inpatient at a hospital, including doctors' services• Ambulance service approved by the Plan.
What is not covered	<ul style="list-style-type: none">• Elective care or non-emergency care• Emergency care provided outside the service area if the need for care could have been foreseen before leaving the service area• Medical and hospital costs resulting from a normal full-term delivery of a baby outside the service area

Section 5. Emergency Benefits *continued*

Filing claims for non-Plan providers

With your authorization, the Plan will pay benefits directly to the providers of your emergency care upon receipt of their claims. Physician claims should be submitted on the HCFA 1500 claim form. If you are required to pay for the services, submit itemized bills and your receipts to the Plan along with an explanation of the services and the identification information from your ID card.

Payment will be sent to you (or the provider if you did not pay the bill), unless the claim is denied. If it is denied, you will receive notice of the decision, including the reasons for the denial and the provisions of the contract on which denial was based. If you disagree with the Plan's decision, you may request reconsideration in accordance with the disputed claims procedure described on page 6.

Portability (Reciprocity)

If you are away from home and required medical care other than routine physicals, immunizations and non-emergency maternity care, you can access a network facility in the area you are visiting. You will receive this care at a maximum benefit as if you were at home, free of bills and claim forms.

To obtain these benefits you must do one of two things:

- Contact your primary care doctor at home to obtain permission for out-of-area care. In life-threatening emergencies, we recommend that you seek appropriate treatment immediately. However, you or a family member must notify the Plan or your primary care doctor within 48 hours concerning the emergency care you received.
- Contact the Prudential HealthCare office in the city you are visiting or the Prudential National Hotline (800-526-2963) to obtain a referral to a local participating doctor. This toll free number is also located on the back of your member ID card and is answered 24 hours a day. You pay a \$10 office visit copay for urgent care services received out of your service area at the local participating doctor's office.

Your home plan is responsible for reimbursing the providers in the out-of-area Prudential HealthCare HMO plan. You should not be asked to make payments, except applicable copays, or file a claim form unless you receive authorized treatment from a non-Prudential HealthCare provider.

Section 5. Mental Conditions/Substance Abuse Benefits

You must contact Merit Behavioral Health Care Corporation at 800-251-2422 before receiving services. Merit will determine and authorize the appropriate number of visits. A referral from your primary care doctor is not required.

Mental conditions

What is covered

To the extent shown below, the Plan provides the following services necessary for the diagnosis and treatment of acute psychiatric conditions, including the treatment of mental illness or disorders:

- Diagnostic evaluation
- Psychological testing
- Psychiatric treatment (including individual and group therapy)
- Hospitalization (including inpatient professional services)

Outpatient care

Up to 20 outpatient visits to Plan doctors, consultants or other psychiatric personnel each calendar year; you pay a \$15 copay per group or individual session for the first 20 visits - all charges thereafter.

Inpatient care

Up to 30 days of hospitalization each calendar; you pay nothing for the first 30 days - all charges thereafter. Mental health inpatient care day limit combines with the substance abuse inpatient benefit.

Intermediate care

Intermediate care for mental health accumulates towards the same 30-day inpatient maximum. Each two days of intermediate care will count as one inpatient day. Intermediate care consists of continuous treatment in a facility for not less than 3 hours nor more than 12 hours in any 24-hour period. It does not include a hospital inpatient stay.

Section 5. Mental Conditions/Substance Abuse Benefits *continued*

- What is not covered**
- Care for psychiatric conditions that in the professional judgment of Plan doctors are not subject to significant improvement through relatively short-term treatment.
 - Psychiatric evaluation or therapy on court order or as a condition of parole or probation, unless determined by a Plan doctor to be necessary and appropriate.
 - Psychological testing when not medically necessary to determine the appropriate treatment of a short-term psychiatric condition.

Serious Mental Illness

Serious mental illness means any of the following mental illnesses as defined by the American Psychiatric Association in the most recent edition of the Diagnostic and Statistical Manual: schizophrenia, schizo-affective disorder, bipolar disorder, major depressive disorder, panic disorder, obsessive-compulsive disorder, anorexia nervosa, bulimia nervosa and delusional disorder.

What is covered Outpatient care up to 60 outpatient visits to Plan doctors, consultants or other psychiatric personnel each calendar year, you pay a \$15 copay per group or individual session for the first 60 visits - all charges thereafter.

Inpatient care Up to 30 days of hospitalization each calendar; you pay nothing for the first 30 days - all charges thereafter. Every inpatient day may be converted to outpatient care. Each one inpatient day provides two outpatient visits.

What is not covered Treatment not authorized

Substance abuse

What is covered This Plan provides medical and hospital services such as acute detoxification services for the medical, non-psychiatric aspects of substance abuse, including alcoholism and the drug addiction, the same as for any other illness or condition, and to the extent shown below, the services necessary for diagnosis and treatment.

Outpatient care Up to 30 outpatient visits/partial hospitalization sessions to Plan providers for treatment each calendar year (120 visits/sessions per lifetime) ; you pay nothing for each covered visit/session - all charges thereafter.

An additional 30 outpatient visits/partial hospitalization sessions may be exchanged on a 2 for 1 basis to allow up to 15 additional inpatient residential care days per calendar year.

Inpatient care Up to 30 days per calendar year (90 days per lifetime) for treatment in an Alcoholism or Drug Abuse Addiction Treatment Center. You pay nothing for each covered day - all charges thereafter.

What is not covered Treatment that is not authorized by a Plan doctor.

Section 5. Prescription Drug Benefits

What is covered Prescription drugs prescribed by a Plan or referral doctor and obtained at a Plan pharmacy will be dispensed for up to a 30 day supply or one commercially prepared unit (i.e. one inhaler, one vial ophthalmic medication or insulin). You pay a \$5 copay per prescription unit or refill for generic formulary drugs, or a \$15 copay per prescription unit or refill for brand name formulary drugs, or a \$25 copay per prescription unit or refill for non-formulary drugs. However, in no event will the copay exceed the cost of the prescription.

Maintenance drugs are used for the treatment of the following chronic medical conditions: chronic obstructive pulmonary disease; clotting drugs; congestive heart failure; coronary artery disease (angina); diabetes; glaucoma; hypertension; thyroid disease; and seizure disorders. We may include other conditions.

Section 5. Prescription Drug Benefits *continued*

What is covered *continued*

Maintenance medications and oral contraceptives prescribed by a plan or referral doctor can also be obtained via a mail order drug program for up to a 90-day supply per refill for a single copay. You pay a \$5 copay per prescription unit or refill for generic formulary drugs, a \$15 copay for brand name formulary drugs, or a \$25 copay for non-formulary drugs per each 90-day supply.

Drugs are prescribed by Plan doctors and dispensed in accordance with the Plan's drug formulary. Non-formulary drugs will be covered when prescribed by a Plan doctor subject to a non-formulary copay. To obtain additional information about our formulary or our mail order program, call Prudential HealthCare customer service at 800-856-0764 or visit our website at www.aetnaushc.com/pruhealthcare.

Formulary development:

The Prudential Health Care Drug Formulary was developed and is maintained by the Prudential HealthCare National Pharmacy and Therapeutics committee (P&T) with the understanding that a well constructed formulary enhances quality of care. The P&T committee evaluates the clinical use of drugs and develops policies and procedures for developing new drug therapies and managing the formulary. The P&T is also responsible for conducting therapeutic class reviews and analyzing new drugs as they enter the market. The formulary reflects our medical and pharmaceutical experience in formulary management and rigorous reviews of individual clinical studies.

The following are examples of what a copay applies to:

- Up to a 30-day supply of tablets, capsules and liquids to be taken orally; or as indicated for use by the Food and Drug Administration (FDA). For example, Diflucan VC is FDA indicated as a single-dose treatment and copay will be charged for each tablet. The treatment usage for many antibiotics will be for a 10-day supply or less.
- a manufacturer's standard 10 milliliter vial of insulin
- insulin syringes, a copay applies to each package of 100;
- a package of no more than 15 milliliters of any optic or ophthalmic product
- a manufacturer's smallest standard package of nasal or oral inhaler
- a manufacturer's smallest standard package of nebulizer solution
- 1 manufacturer's smallest standard package of liquid or solid rectal or vaginal medication
- 1 manufacturer's smallest standard package containing no more than 60 milliliters of topical solutions or lotions
- 1 manufacturer's smallest standard package containing no more than 60 grams of topical ointments or creams
- Up to a 30 day supply of patches, a copay applies to each manufacturer's standard package;
- 1 package of oral contraceptives

Covered medications and accessories include:

- Drugs for which a prescription is required by law;
- Oral contraceptive drugs; up to a 90-day supply per refill of maintenance and oral contraceptive drugs may be obtained with a copay applied to each 30-day supply filled at the local participating pharmacy;
- Diaphragms (with a prescription);
- Insulin with a copay charge applied to each vial;
- Disposable needles and syringes for insulin; you pay a separate copay;
- Fertility drugs

Diabetic supplies (except insulin and insulin syringes), other disposable needles and syringes, contraceptive devices other than diaphragms, intravenous fluids and medications for home use, implantable drugs (such as Norplant®), and injectable drugs (such as Depo Provera® or some fertility drugs) are covered under the Medical and Surgical Benefits.

Limited benefits

Sexual dysfunction drugs have dispensing limitations. For complete details, please call Prudential HealthCare customer service at 800/856-0746.

Smoking cessation aids:

Smoking cessation therapy that requires a prescription is covered, subject to the following limitations. You pay a \$5 prescription drug copay for each generic formulary supply and a \$15 copay for each brand name formulary supply and a \$25 copay for each non-formulary supply.

- Lifetime coverage is limited to one 90 day course of treatment to be administered through a Plan doctor.

- What is not covered**
- Drugs available without prescription or for which there is a nonprescription equivalent available;
 - Drugs obtained at a non-Plan pharmacy except out-of-area emergencies;
 - Vitamins and nutritional substances which can be obtained without a prescription;
 - Medical supplies such as dressing and antiseptics;
 - Drugs for cosmetic purposes;
 - Drugs to enhance athletic performance;
 - Non-prescription smoking cessation drugs and medication;

Section 5. Other Benefits

Dental care

Accidental injury benefit Restorative services and supplies necessary to promptly repair or replace sound natural teeth are covered. The need for these services must result from an accidental injury. **You pay nothing.**

- Other dental services not shown as covered

Vision care

What is covered In addition to the medical and surgical benefits provided for diagnosis and treatment of diseases of the eye, one eye refraction every two years (to provide a written lens prescription for eyeglasses) may be obtained from Plan providers. You pay a \$15 copay per visit.

- Corrective lenses or frames (except the initial eyeglasses or lenses to replace the loss of natural lenses are covered)
 - Eye exercises

The benefits described on this page are neither offered nor guaranteed under the contract with the FEHB program but are made available to all enrollees and family members who are members of the Plan. The cost of the benefits described on this page is not included in the FEHB premium; any charges for these services do not count toward any FEHB deductibles or out-of-pocket maximums. These benefits are not subject to the FEHB disputed claims procedures.

Along with the medical benefits described elsewhere, Prudential HealthCare HMO gives you access to additional programs that can enhance your quality of life.

Dental Program

The Dental Program is a comprehensive dental plan with no claims forms or deductibles. It is not insurance; it's a discount dental program, with more than 10,000 participating dentists across the country. These dentists have agreed to provide services to program participants at reduced rates - including periodic exams, cleanings, root canals...even orthodontia care. **Contact Benefit Network Systems at 800-391-9721 with any questions.** You have access to dental services at a discount and will receive a separate ID card. There is no additional charge for this program. More details about the Dental Program are included in your Prudential HealthCare open enrollment packet.

The Plan has made arrangements with independent doctors of optometry which enables you and your family to obtain eye glasses, frames and contact lenses at a 20% discount. There is no limit on quantity.

Section 6. General exclusions — Things we don't cover

The exclusions in this section apply to all benefits. Although we may list a specific service as a benefit, we will not cover it unless your Plan doctor determines it is medically necessary to prevent, diagnose, or treat your illness or condition.

We do not cover the following:

- Services, drugs or supplies that are not medically necessary;
- Services not required according to accepted standards of medical, dental, or psychiatric practice;
- Care by non-Plan providers except for authorized referrals or emergencies (see Emergency Benefits);
- Experimental or investigational procedures, treatments, drugs or devices;
- Procedures, services, drugs and supplies related to abortions except when the life of the mother would be endangered if the fetus were carried to term or when the pregnancy is the result of an act of rape or incest;
- Procedures, services, drugs and supplies related to sex transformations;
- Services or supplies you receive from a provider or facility barred from the FEHB Program; and
- Expenses you incurred while you were not enrolled in this Plan.

Section 7. Limitations — Rules that affect your benefits

Medicare

Tell us if you or a family member is enrolled in Medicare Part A or B. Medicare will determine who is responsible for paying for medical services and we will coordinate the payments. On occasion, you may need to file a Medicare claim form.

If you are eligible for Medicare, you may enroll in a Medicare+Choice plan and also remain enrolled with us.

If you are an annuitant or former spouse, you can suspend your FEHB coverage and enroll in a Medicare+Choice plan when one is available in your area. For information on suspending your FEHB enrollment and changing to a Medicare+Choice plan, contact your retirement office. If you later want to re-enroll in the FEHB Program, generally you may do so only at the next Open Season.

If you involuntarily lose coverage, or move out of the Medicare+Choice service area, you may re-enroll in the FEHB Program at any time.

If you do not have Medicare Part A or B, you can still be covered under the FEHB Program and your benefits will not be reduced. We cannot require you to enroll in Medicare.

For information on Medicare+Choice plans, contact your local Social Security Administration (SSA) office or request it from SSA at 1-800/638-6833.

Other group insurance coverage

When anyone has coverage with us and with another group health plan, it is called double coverage. You must tell us if you or a family member has double coverage. You must also send us documents about other insurance if we ask for them.

When you have double coverage, one plan is the primary payer; it pays benefits first. The other plan is secondary; it pays benefits next. We decide which insurance is primary according to the National Association of Insurance Commissioners' Guidelines.

If we pay second, we will determine what the reasonable charge for the benefit should be. After the first plan pays, we will pay either what is left of the reasonable charge or our regular benefit, whichever is less. We will not pay more than the reasonable charge. If we are the secondary payer, we may be entitled to receive payment from your primary plan.

We will always provide you with the benefits described in this brochure. Remember: even if you do not file a claim with your other plan, you must still tell us that you have double coverage.

Circumstances beyond our control

Under certain extraordinary circumstances, we may have to delay your services or be unable to provide them. In that case, we will make all reasonable efforts to provide you with necessary care.

Section 7. Limitations — Rules that affect your benefits *continued*

When others are responsible for injuries	When you receive money to compensate you for medical or hospital care for injuries or illness that another person caused, you must reimburse us for whatever services we paid for. We will cover the cost of treatment that exceeds the amount you received in the settlement. If you do not seek damages, you must agree to let us try. This is called subrogation. If you need more information, contact us for our subrogation procedures.
TRICARE	TRICARE is the health care program for members, eligible dependents, and retirees of the military. TRICARE includes the CHAMPUS program. If both TRICARE and this Plan cover you, we are the primary payer. See your TRICARE Health Benefits Advisor if you have questions about TRICARE coverage.
Workers' compensation	We do not cover services that: <ul style="list-style-type: none">• You need because of a workplace-related disease or injury that the Office of Workers' Compensation Programs (OWCP) or a similar Federal or State agency determine they must provide;• OWCP or a similar agency pays for through a third party injury settlement or other similar proceeding that is based on a claim you filed under OWCP or similar laws. Once the OWCP or similar agency has paid its maximum benefits for your treatment, we will provide your benefits as long as you use our providers.
Medicaid	We pay first if both Medicaid and this Plan cover you.
Other Government Agencies	We do not cover services and supplies that a local, State, or Federal Government agency directly or indirectly pays for.

Section 8. FEHB FACTS

You have a right to information about your HMO.

OPM requires that all FEHB plans comply with the Patients' Bill of Rights, which gives you the right to information about your health plan, its networks, providers and facilities. You can also find out about care management, which includes medical practice guidelines, disease management programs and how we determine if procedures are experimental or investigational. OPM's website (www.opm.gov) lists the specific types of information that we must make available to you.

We don't determine who is eligible for coverage and, in most cases, cannot change your enrollment status without information from your employing or retirement office.
When are my benefits and premiums effective?	The benefits in this brochure are effective on January 1. If you are new to this plan, your coverage and premiums begin on the first day of your first pay period that starts on or after January 1. Annuitants' premiums begin January 1.

Section 8. FEHB FACTS *continued*

What happens when I retire?

When you retire, you can usually stay in the FEHB Program. Generally, you must have been enrolled in the FEHB Program for the last five years of your Federal service. If you do not meet this requirement, you may be eligible for other forms of coverage, such as Temporary Continuation of Coverage, which is described later in this section.

What types of coverage are available for my family and me?

Self-Only coverage is for you alone. *Self and Family* coverage is for you, your spouse, and your unmarried dependent children under age 22, including any foster or step children your employing or retirement office authorizes coverage for. Under certain circumstances, you may also get coverage for a disabled child 22 years of age or older who is incapable of self-support.

If you have a Self Only enrollment, you may change to a Self and Family enrollment if you marry, give birth or add a child to your family. You may change your enrollment 31 days before to 60 days after you give birth or add the child to your family. The benefits and premiums for your Self and Family enrollment begin on the first day of the pay period in which the child is born or becomes an eligible family member.

Your employing or retirement office will not notify you when a family member is no longer eligible to receive health benefits, nor will we. Please tell us immediately when you add or remove family members from your coverage for any reason, including divorce.

If you or one of your family members is enrolled in one FEHB plan, that person may not be enrolled in another FEHB plan.

Are my medical and claims records confidential?

We will keep your medical and claims information confidential. Only the following will have access to it:

- OPM, this Plan, and subcontractors when they administer this contract,
- This plan, and appropriate third parties, such as other insurance plans and the Office of Worker's Compensation Programs (OWCP), when coordinating benefits payments and subrogating claims,
- Law enforcement officials when investigating and/or prosecuting alleged civil or criminal actions,
- OPM and the General Accounting Office when conducting audits,
- Individuals involved in bona fide medical research or education that does not disclose your identity; or
- OPM, when reviewing a disputed claim or defending litigation about a claim.

Information for new members

Identification cards

We will send you an Identification (ID) card. Use your copy of the Health Benefits Election Form, SF-2809, or the OPM annuitant confirmation letter until you receive your ID card. You can also use an Employee Express confirmation letter.

What if I paid a deductible under my old plan?

Your old plan's deductible continues until our coverage begins.

Pre-existing conditions

We will not refuse to cover the treatment of a condition that you or a family member had before you enrolled in this Plan solely because you had the condition before you enrolled.

When you lose benefits

What happens if my enrollment in this Plan ends?

You will receive an additional 31 days of coverage, for no additional premium, when:

- Your enrollment ends, unless you cancel your enrollment, or
- You are a family member no longer eligible for coverage.

You may be eligible for former spouse coverage or Temporary Continuation of Coverage.

Section 8. FEHB FACTS *continued*

What is former spouse coverage?

If you are divorced from a Federal employee or annuitant, you may not continue to get benefits under your former spouse's enrollment. But, you may be eligible for your own FEHB coverage under the spouse equity law. If you are recently divorced or are anticipating a divorce, contact your ex-spouse's employing or retirement office to get more information about your coverage choices.

What is TCC?

Temporary Continuation of Coverage (TCC). If you leave Federal service or if you lose coverage because you no longer qualify as a family member, you may be eligible for TCC. For example, you can receive TCC if you are not able to continue your FEHB enrollment after you retire. You may not elect TCC if you are fired from your Federal job due to gross misconduct.

Get the RI 79-27, which describes TCC, and the RI 70-5, the Guide to Federal Employees Health Benefits Plans for Temporary Continuation of Coverage and Former Spouse Enrollees from your employing or retirement office.

Key points about TCC:

- You can pick a new plan;
- If you leave Federal service, you can receive TCC for up to 18 months after you separate;
- If you no longer qualify as a family member, you can receive TCC for up to 36 months;
- Your TCC enrollment starts after regular coverage ends.
- If you or your employing office delay processing your request, you still have to pay premiums from the 32nd day after your regular coverage ends, even if several months have passed.
- You pay the total premium, and generally a 2-percent administrative charge. The government does not share your costs.
- You receive another 31-day extension of coverage when your TCC enrollment ends, unless you cancel your TCC or stop paying the premium.
- You are not eligible for TCC if you can receive regular FEHB Program benefits.

How do I enroll in TCC?

If you leave Federal service your employing office will notify you of your right to enroll under TCC. You must enroll within 60 days of leaving, or receiving this notice, whichever is later.

Children: You must notify your employing or retirement office within 60 days after your child is no longer an eligible family member. That office will send you information about enrolling in TCC. You must enroll your child within 60 days after they become eligible for TCC, or receive this notice, whichever is later.

Former spouses: You or your former spouse must notify your employing or retirement office within 60 days of one of these qualifying events:

- Divorce
- Loss of spouse equity coverage within 36 months after the divorce.

Your employing or retirement office will then send your former spouse information about enrolling in TCC. Your former spouse must enroll within 60 days after the event, which qualifies them for coverage, or receiving the information, whichever is later.

Note: Your child or former spouse loses TCC eligibility unless you or your former spouse notify your employing or retirement office within the 60-day deadline.

How can I convert to individual coverage?

You may convert to an individual policy if:

- Your coverage under TCC or the spouse equity law ends. If you canceled your coverage or did not pay your premium, you cannot convert.
- You decided not to receive coverage under TCC or the spouse equity law; or
- You are not eligible for coverage under TCC or the spouse equity law.

If you leave Federal service, your employing office will notify you if individual coverage is available. You must apply in writing to us within 31 days after you receive this notice. However, if you are a family member who is losing coverage, the employing or retirement office will not notify you. You must apply in writing to us within 31 days after you are no longer eligible for coverage.

Section 8. FEHB FACTS *continued*

Your benefits and rates will differ from those under the FEHB Program; however, you will not have to answer questions about your health, and we will not impose a waiting period or limit your coverage due to pre-existing conditions.

How can I get a Certificate of Group Health Plan Coverage?

If you leave the FEHB Program, we will give you a Certificate of Group Health Plan Coverage that indicates how long you have been enrolled with us. You can use this certificate when getting health insurance or other health care coverage. You must arrange for the other coverage within 63 days of leaving this Plan. Your new plan must reduce or eliminate waiting periods, limitations or exclusions for health related conditions based on the information in the certificate.

If you have been enrolled with us for less than 12 months, but were previously enrolled in other FEHB plans, you may request a certificate from them, as well.

Inspector General Advisory: Stop Health Care Fraud!

Penalties for Fraud

Anyone who falsifies a claim to obtain FEHB Program benefits can be prosecuted for fraud. Also, the Inspector General may investigate anyone who uses an ID card if they:

- Try to obtain services for a person who is not an eligible family member; or
- Are no longer enrolled in the Plan and try to obtain benefits.

Your agency may also take administrative action against you.
