SUBJECT: Publication of USAID Foreign Assistance for Programs Overseas in the Catalog of Federal Domestic Assistance (CFDA)

As described in the attached policy notice of May 2, 2003, all agencies of the U.S. Government, including USAID, are required to collect, coordinate, and submit information on current programs, and on new programs as they arise, in the Catalog of Federal Domestic Assistance (CFDA). CFDA was established by the Federal Program Information Act (31 U.S.C. 6104) and OMB Circular A-89. It is a web-based database of all Federal programs available to U.S. non-governmental organizations, individuals, educational institutions, and state and local governments. It catalogs all federal domestic assistance programs, including programs that finance grants or cooperative agreements to U.S. recipients for activities abroad.

The May 2003 policy notice stipulated that each grant program that makes multiple awards to U.S. recipients in more than one fiscal year in a particular field and does not have a particular geographic focus will have its own CFDA entry. USAID will also have one entry that encompasses USAID's general activities, under which either single awards will be made, or multiple awards will be issued pursuant to a single announcement (Request for Application) in FedGrants.

PPC and M/OP are pleased to announce the publication of the CFDA entry covering USAID's general assistance activities, "USAID Foreign Assistance for Programs Overseas." The CFDA number for the general activities is 98.001 and may be

accessed at www.cfd.gov. Bureaus and offices are encouraged to establish a separate entry for each discrete grant program they offer that makes multiple awards in a particular field to U.S. recipients in more than one fiscal year.
