Type of Proposal: New Fee

**Site Description:** Black River Harbor is located along the south shore of Lake Superior. The pavilion building, located within the day use area, features an enclosed building with picnic tables, fireplace, electrical outlets, and restrooms.

**Proposed Action:** A new fee of \$40 for the Black River Harbor pavilion. Pavilion my be reserved through the National Recreation Reservation Service for an additional fee.

Current Fee: This is a new fee.

**Proposed Fee:** \$40 for any part of the day.

Amount Increase: \$40

Date Last Increase: This is a new fee.

Reason for New Fee or Fee Change: There has been a notable increase in the demand for reservations of the pavilion by large groups. Examples include church picnics, weddings, family reunions, schools and various clubs. Appropriated funds have not been sufficient to address the impacts of this intense use. Funds are needed to supplement existing operations and maintenance.

If recommended, the fee increase will be used for: Operation and maintenance of the pavilion associated with group use

If recommended, the proposal will be implemented: May 15, 2008.

## Benchmark Price Comparisons for Similar Facilities & Services:

- Forest Service: Across the Eastern Region, the price for reservations of similar type picnic shelters ranges from \$25 \$35.
- Local Private and Public Providers: The fee use for similar type shelters in the immediate area along Lake Superior include Saxon Harbor (\$30 to \$35) and Little Girls Point (\$25/family; \$50 for groups over 100 persons). Both facilities are managed by county governments. A city-owned picnic pavilion in Bessemer charges \$25.
